Re: DCD 2026 Proposed Budget - Responses to Follow-Up Questions

Dear Chair Dimitrijevic and Committee Members:

This letter responds to requests and questions that were raised at the Finance and Personnel Committee's October 13. 2025 hearing regarding the Department of City Development's (DCD) proposed 2026 budget.

1. Share the anticipated timing of the next Housing Trust Fund RFP.

The Housing Trust Fund is administered by the Department of Administration. DOA will follow up with information to respond to this inquiry.

2. For the existing in rem inventory, please provide the breakdown of the numbers of properties acquired prior to, and subsequent to, the March 24, 2024 effective date of the updated State Statures governing sale of tax deed in rem properties.

There are currently 3,736 in rem foreclosed properties in City inventory. Of that total, 3,348 (89.6%) were acquired before 3/24/24. The remaining 388 (10.4%) were acquired on or after 3/24/24. The table below shows the breakdown of these properties by category (vacant lot, residential, commercial/other).

3. Provide a list of all 2025 recipients of Commercial Revitalization Grants awarded by DCD. Share information about employment impacts as a result of the grants.

Please see the attached spreadsheet containing this requested list of 2025 grantees. Additionally, DCD has included a summary of Commercial Revitalization Grant activity during the past five years in the Legistar file associated with the 2026 Proposed Budget. A table with job creation data reported by Retail Investment Fund grantees is included on page 3 of the report. RIF grants have supported creation of more than 170 jobs in the past five years, with 70+ additional planned through projects currently under construction.

4. Provide current status and final outcomes of the MERI, MERI 2.0, and RICH programs.

The Milwaukee Employment/Renovation Initiative (MERI and MERI 2.0) programs provided funds to participating developers for the rehabilitation and resale of City-owned tax foreclosed homes, including a workforce development subsidy. These programs were created and funded in 2017 (MERI) and 2019 (MERI 2.0) with funds from the Wisconsin Department of Financial Institutions (MERI) and local funds (MERI 2.0). MERI and MERI 2.0 investments totaled \$2,055,000 to support the rehabilitation of 115 homes.

The ARPA-funded Homes MKE Initiative was modeled in large part on the MERI program, and will continue to operate with ARPA funding during 2026, with 32 home rehabilitations currently under construction and 20+ homes currently in the predevelopment pipeline.

The Re-Invest City Homes (RICH) program utilized \$280,000 CDBG funds in 2017-2018 to provide loan funds to Habitat for Humanity to support construction of seven new affordable homes. That program has been completed and the initial loan remains current in repayment.

5. Has DCD sold any improved residential properties to investor owners during 2025? If so, how many?

Of the 54 residential property sales YTD, 43 were sold to owner occupants, and 11 to investor owners. These sales were carried out under the previous version of the City Real Estate sales ordinance. This means that in each case, the local alder had received the Neighborhood Property Report that provided them the opportunity to specify whether or not DCD should consider investor offers after the initial 60-day owner occupant only listing period. Generally, the properties sold to investor owner represent some of the most difficult to market and sell properties, often because of property condition.
