This office is in receipt of your claim in the amount of \$1,977.71, relating to damage sustained to your vehicle on June 8, 2001 when it was allegedly hit by a City dump truck at North 76th Street and West Hampton Avenue.

Our investigation reveals that the Fleet Services Division Report completed as a result of this accident note that the City dump truck was completing a left turn onto Hampton Avenue and was going to make a right turn into an alley. A witness indicated that, after the traffic signal changed to green, your vehicle proceeded across the intersection and attempted to squeeze past in the curb lane and get in front of the City vehicle and made contact. The liability for this accident rests with the driver of your vehicle. As such, the City cannot accept liability for the loss. Accordingly, we are denying your claim.
