There is a possibility that your application may be denied for one or more of committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/23/22, Milwaukee Police were advised to monitor 7525 W. Good Hope Rd., due to a Health Department Order for Closure. At approximately 9:15pm., officers driving by observed at least 3 cars in the drive thru picking up food orders and an individual sitting in the lobby. At 9:57pm., officers conducted a License Premise Check and it was determined the order had been rescinded by the Health Department and no violations occurred.
- 2. On 04/17/25 at 9:30p.m., Milwaukee Police were dispatched to a Subject with Weapon. The business called due to a subject making threats while waving a gun. The subject was gone on officer's arrival.
- 3. On 06/30/25, Milwaukee Police took a walk-in Battery complaint that occurred on 06/29/25 at approximately 4 or 5pm. Officers were advised the subject was battered by a known subject, who was employed at the business, armed with a handgun. Follow up was conducted at the business, however, there was no video surveillance as the fight occurred at a nearby business. The manager stated the employee has been fired, but did provide officers with the suspects information.

On Thursday, April 17, 2025, at approximately 9:30 PM we were dispatched to a subject with weapon call located at 7525 W Good Hope Rd (Which is located in the City and County of Milwaukee).

Upon arrival, officers spoke to Popeyes manager, verbally identified as Lyle A. SHUMPERT (B/M, 04/12/1968). SHUMPERT stated at approximately 9:06 P.M. a B/M, 5'10. short afro wearing a colorful jacket walked into the lobby and started yelling threats and waiving a gun wrapped in a rainbow colored tape. SHUMPERT stated the suspect did not point the weapon but was walking around yelling threats. SHUMPERT stated the suspect was intoxicated.

Officers did not observe anyone fitting the description in the immediate area.

I spoke to witness, verbally identified as Rachel L. THOMAS (B/F, 06/19/1988). THOMAS stated that she was outside during this time when she had observed a gray 4 door sedan drove up and stopped at the door on the north west side of the business. THOMAS stated that she did observe a man get out of the front passenger side and walked into the store, only to get out a few moments later with no food in hand. THOMAS stated that she had only taken a glance of the vehicle and unknown actor because she was throwing out the trash. THOMAS stated that where she was standing, she did not observe any firearm that the unknown actor was seen to be carrying. THOMAS stated that she did not know what had happened until she went back into the business.

The business was cooperative with the investigation. The business had no security officers on scene.

I was unable to review video surveillance footage because I was unable to interact with the system. An evidence.com link was sent to "Sonya" who was one of the store managers who knew how to operate the system, but was unable to come to the location at the time.

On Monday, June 30, 2025, at approximately 6:20pm, while assigned to District 3 Front Desk, Jeremiah L LONG (B/M 03-26-08) walked into District 3 to report a battery that occurred at 7525 W Good Hope Rd, in the City and County of Milwaukee, WI. LONG was accompanied by his mother Regina T LONG (b/f 09-02-82). LONG stated that on 6-29-25, at the above location, at or around 4pm or 5pm, he was at the Popeyes with a cousin eating in the lobby of the restaurant.

LONG stated that while he was eating he was approached by two black male subjects, one he knew as Elijah, who was an employee of the Popeye's restaurant. LONG stated that Elijah approached him along with another subject and invited him outside to fight. LONG stated that they went to school together at Early View Academy and had problems during the school year. LONG stated that Elijah and other individuals have been threatening him over social media for the past couple of days. LONG stated that he went out to fight Elijah, but he was then jumped by Elijah and two other unknown black males and one of the subjects were armed with a black semi-automatic handgun.

LONG stated that the subjects punched him in his nose and head causing pain and lumps on the head. LONG stated that during the fight suspect 2 and 3 were both clutching their waist bands as if the had firearms. LONG stated that suspect 3 dropped the gun on the ground during the fight and then picked it up, but never pointing it. LONG stated that the fight occurred in the drive thru of the restaurant.

LONG described suspect 1 as a black male, "Elijah", 17yoa, 508-509, 140-150, light complexion, freeform dreadlocks, mustache, and wearing all black clothing.

Suspect 2 was described as a black male, possibly older in his 20s, 511, 160, dark skin, dread locks, muscular build, gray sweats and gray hooded sweatshirt, and black slides sandals. He was possibly armed with a unknown hand gun.

Suspect 3 was described as a black male 20s, 511, 165, blonde/red dreadlocks, gray sweats, blue hooded sweat shirt, slide sandals, and armed with a black semi-automatic handgun with an extended magazine.

I took 13 photos at 7:08pm which depict the victims injuries.

LONG provided me wit Elijah's instagram "outtavisionn." Follow up will be conducted to identify the owner of this instagram page.

On 6-30-25, I requested a squad to be sent out to the Popeye's location to check for video, interview any witnesses and speak to a manager to identify "Elijah." (CAD# P2506301341). On 7-1-25, I requested a squad go to the Popeye's (CAD# P2507010774), the manager was not on scene and the employees had no access to the video. I requested a squad be sent regarding follow up and the call was cancelled by squad 4280 citing the call needed to be handled on dayshift (CAD# P2507021193).

Officer FIDLIN conducted follow up and spoke to the store manager, Sonya R. HUGHES (B/F, 06/16/80). I asked HUGHES if she knew anything about a fight involving an employee by the name of "Alijah". HUGHES stated she did not witness the incident but was familiar with it. HUGHES stated the fight was not on their surveillance and occurred in the Culver's parking lot. HUGHES pulled up the store file, and his information was Alijah RIVERS, 2453 S. 43rd St., ph # 414-364-1536. HUGHES stated they do not collect birthdays of employees. HUGHES stated he has been terminated.

P.O. THOMSEN went to the Culver's at 7515 W. Good Hope Rd. THOMSEN spoke to Juan OROZCO, (H/M, 05/30/83). OROZCO stated he observed a group of individuals outside the store on Saturday, June 28, 2025, at approximately 4:30 p.m. OROZCO stated he saw 1 B/M, with his shirt off, and 5 other B/M subjects standing around the southwest corner of the Culver's lot. OROZCO stated he is unable to pull up store surveillance, but "Matt" is able to. He can be reached at 414-371-0500.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
