Notice is hereby given that an  
ordinance that was introduced at  
the July 12, 2022 meeting of the  
Milwaukee Common Council, the  
essence of which is as follows:

A substitute ordinance relating to  
the change in zoning from Detailed  
Planned Development known as  
John C. Cudahy YMCA Youth &  
Family Center to a new Detailed  
Planned Development known  
as Cudahy Farms for phased  
multi-family development on land  
located at 9050 North Swan Road,  
on the east side of North Swan  
Road, south of West Fairy Chasm  
Drive, in the 9th Aldermanic Dis-  
trict.

The Mayor and Common Council  
of the City of Milwaukee ("Common  
Council"), do ordain as follows:

Part 1. There is added to the  
Milwaukee Code of Ordinances  
("Code") a new section to read as  
follows:

(1) In accordance with the pro-  
visions of Section 295-507 of the  
Code relating to the establishment  
of planned development districts,  
the Common Council approves the  
subject Detailed Planned Devel-  
opment, which is restricted to the  
time limit of 5 years from the effec-  
tive date of this ordinance unless  
the criteria per s.295-907-2-c-11  
are met as referenced in Exhibit A,  
a copy of which is attached to this  
Common Council File which is on  
file in the office of the City Clerk  
and made a part as though fully set  
forth herein.

(2) The zoning map is amended  
to change the zoning for the prop-  
erty located at: 9050 North Swan  
Road, Tax Key No. 033-0432-000  
from Detailed Planned Develop-  
ment (DPD) to a new DPD known  
as Cudahy Farms.

(3) The requirements set forth in  
said detailed plan attached to this  
Common Council File as Exhibit  
A, constitute the zoning regula-  
tions for the area contained in  
such planned development district  
described, provided further, that  
the effect of the approval of such  
detailed plan is that such plan shall  
limit and control construction, loca-  
tion, use and operation of all land  
and structures included within the  
detailed plan to all conditions and  
limitations set forth in such detailed  
plan.

Part 2. Any persons, firm, com-  
pany or corporation owning, con-  
trolling or managing any building or  
premises wherein or whereon there  
shall be placed or there exists any-  
thing in violation of the terms of  
this ordinance; or who shall build  
contrary to the plans or specifica-  
tions submitted to and approved by  
the Commissioner of the Depart-  
ment of City Development, or any  
person, firm, company or corpo-  
ration who shall omit, neglect or  
refuse to do any act required in this  
ordinance shall be subject to the  
penalties provided in Section 200-  
19 of the Code.

Part 3. If any section, subsec-  
tion, sentence, clause, phrase or  
portion of this ordinance is for any  
reason held invalid or unconstitu-  
tional by any court of competent  
jurisdiction, such portion shall be  
deemed a separate, distinct and  
independent provision, and such  
holding shall not affect the valid-  
ity of the remaining portions. The  
Common Council declares that it  
would have passed this ordinance  
and each section, subsection, sen-  
tence, clause, phrase or portion  
irrespective of the fact that any  
one or more sections, subsections,  
sentences, clauses or phrases or  
other portions be declared void or  
invalid.

Notice is hereby further given  
that the foregoing matter will be  
given a public hearing by the Com-  
mittee on Zoning, Neighborhoods  
and Development in Room 301-B,  
City Hall, 200 East Wells Street,  
Milwaukee, Wisconsin, on Tuesday,  
July 8, 2025, at 9:00 A.M., pursu-  
ant to the provision of Sub-Sec-  
tion (7)(b) of Section 62.23 of the  
Revised Statutes of the State of  
Wisconsin. This is also a virtual  
meeting. Those wishing to view the
