There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, lilegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The l

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Upon arrival, we observed approximately 500 subjects all over the sidewalk, in the street and in the parking lots. We immediately called for medical and more squads due to the number of people on scene. Most of the individuals around were juveniles that ranged in age from approximately 10-18 that I observed.

Overall there were 10-2 man squads, 2-1 man squads, 3 Sgts, 3 MFD units and 1 Bell unit on scene for all the resources. All MPD squads were on scene for approximately 2 hours for the whole scene and

I spoke to the owner of Flame 13 identified as James H PERRY Jr (B/M 11/27/1975).

Interview of James H PERRY (Owner):

PERRY stated he had an event at the location with a Youtube influencer who he identified as Eli Unique. PERRY stated the influencer put on a free event for the youth and to give back to the community. PERRY stated the youth were with their parents. PERRY stated the event was from 6:00 PM until 10:00 PM. PERRY stated his bar/restaurant has a capacity of 320 people. PERRY stated his capacity was full and he had a line of people, waiting for other people to leave. PERRY stated the influencer came the last 2 years to the location. PERRY stated he was on the stage and everyone began to look out the windows and then everyone began to run out of the business. PERRY stated eventually his bouncer informed him there was a fight on N MLK Jr Dr. towards W North Ave. PERRY did shut down the event after this incident. PERRY stated prior to a fight outside, he was informed that someone drove past the event and threw a firecracker and people believed it to be a gunshot. We did not have any calls for service regarding Shots Fired and we did not locate any evidence of shots being fired.

PERRY stated his normal hours of operation are 6:00 AM to 2:30 AM. PERRY stated he has security cameras and showed me them (See Below).

I reviewed video surveillance footage. The footage showed everyone in the establishment and looking at the stage. The interior video then shows at approximately 8:02 PM the subjects start looking out the window and then running out of the business. The exterior cameras show everyone outside standing in a line and at approximately 7:53 PM everyone starts running towards W North Ave and out of the view of the camera. The whole incident that I observed did occur outside of the business. PERRY showed me numerous different cameras and angles and I was not able to observe who was actually fighting or using pepper spray.

While on scene, I observed the licenses posted and they were up to date. (Expire 7/31/2025)-



- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
