There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the license and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The license should be prepared to address these matters at the hearing.

If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 08/24/23 at 2:00p.m., Milwaukee Police were contacted by City of Milwaukee Health Department regarding inappropriate comments made to inspectors. The officer was advised the employee made racist comments to an inspector, as well as a comment they would "kill" they inspector, then laughed about it. The officer contacted the employee who stated they were joking and did not mean to offend anyone and would officially apologize the next inspection
- 2. On 09/19/23 at 12:04p.m., Milwaukee Police accompanied Milwaukee Health Department, conduct an inspection at 2500 N. Booth. This was due to inappropriate comments made to the Inspector at the last visit. The same employee was on scene and apologized for the prior made comments. The employee was advised of rat droppings in the basement and agreed to clean them up.

3. On 05/05/24 at 248pm., Milwaukee Police conducted a License Premise Check at 2500 N. Booth. Investigation revealed this is a Class A Establishment and the licenses had all expired on 04/22/24. The officer did note the business applied for a Provisional License, however, it had not been granted. The officer found the business open and operating, as well as sales for alcohol conducted by the sole employee, who did not possess a valid Class D Operator License. The officer made contact with the Agent and advised them of the violations.

- 4. On 09/25/24 at 100pm., Milwaukee Police assisted the Health Department in an Investigation at 2500 N. Booth, due to a perceived threat they had experienced on a previous visit. The only violation found was cleaning supplies stored over food items. The business was cooperative.
- 5. On 11/01/24 at 153pm., Milwaukee Police were dispatched to an Armed Robbery, later determined to be a Property Damage at 2500 N. Booth. Investigation revealed two juveniles were asked to leave the store and the clerk locked the door after them. The juveniles then began banging on the door and threatened to rob the store, eventually breaking the glass. Squads located the juveniles and took them into custody.
- On 01/30/25 at 802pm., Milwaukee Police were dispatched to a Theft at 2500 N. Booth. Investigation revealed the business was the victim of a retail theft and they requested more patrol.
- 7. On 05/08/25 at 105pm., Milwaukee Police assisted the Health Department in conducting a License Premise Check at 2500 N. Booth. Officers found the Class A establishment open and alcohol for sale. The clerk did not have a Class D Operator License, and stated they were only helping out until the owner returned. The clerk was advised they could not sell any alcohol until the owner returned. Further, the Health Department found a leaky freezer with food that was thawing. The clerk was cooperative and agreed to throw it out.

St., which was a licensed premise in the city of Milwaukee.

Earlier in the day, while checking several businesses and their licenses in LIRA, I found that Star Grocery did have a Class A Intoxicating Liquor License, Food Dealers License and a Cigarette License which all expired on 04-22-24. I also did observe that the business had applied for a provisional license, which was pending Aldermanic approval since 04-26-24.

I went to the business to find out if any licenses had been issued and just were not viewable in LIRA as of yet.

I arrived at the business and found the business to be open. I entered the store and the person who was behind the counter, Mahmoud AMIREH (w/m 05-23-61) exited the cashiers area and asked what I wanted. I informed him that I was there to inspect the licenses for the business. AMIREH did not know where the licenses were and asked why I wanted to see them. I informed him that the police do inspect the licenses and that the licenses have to be readily available for police review. AMIREH could not find them, so he contacted the the agent of the store, who informed me that the licenses were in a locked drawer that he had the key for.

I explained to the agent why I was there and he stated that he would be back at the store in 30 minutes. I informed him that I would not be able to wait that long and that I would have to write a report about this. He asked why and it was explained that a report is required coming to his store.

I then began to speak to AMIREH, who stated he was there helping his friend out while he was doing something. He informed me that he has worked at Sunrise Foods in the past and that he helps his friend out when he can. I informed him on why I was there and that if the business did not have any licenses to sell alcohol, cigarettes or refrigerated food, they would not be able to sell any of those items, until obtaining their licenses. While waiting for the agent to arrive, AMIREH did take money for alcohol purchases, as well as cigarette purchases.

I asked AMIREH if he had a Class D license to sell the alcohol and he stated if he did not, he would tomorrow (Monday) to apply for one. I again advised him if the store did not have any licenses, they could not sell certain items.

Marouf M. DAHIA (w/m 08-10-57) arrived and I explained why I was at the business today. He explained that he was in contact with the alderperson and that he had a letter which indicated that he had to appear at the Tuesday May 7th license committee hearing, in order to get a license. He did show me a letter with the police report and other items attached to it.

DAHIA stated he was at the store and left before my arrival to do something and that AMIREH was there to help him out while he was away from the store. I advised him that since he had the letter regarding the meeting, that he would have to attend that and if approved the license would be issued. Since that has not happened yet, I informed DAHIR that he needed the actual license from the city in order to sell the items that require a license.

I then informed DAHIR that if AMIREH did not have a Class D license, he could not sell alcohol, even if the store did have the proper license.

I explained what items in the store do not need a license to sell and he stated he just may close

the store until Tuesday's meeting. He stated that he would remain at the store and I again advised him not to sell alcohol, cigarettes or food, items that require a license. He stated he would not sell those items and he would make sure to get his licenses on Tuesday.

I informed him that I would be writing this report, documenting my visit today.

I returned to District 5 and checked to see if AMIREH had a Class D license and I could not locate any. DAHIR does not appear as an agent of the business, but Mohamad DAHIR (w/m 06-10-97) does.

On Wednesday, September 25, 2024, at 1:00P.M., I met two City of Milwaukee Health Department Inspectors at 2500 N. Booth Street (Star Grocery).

The health inspectors were at the property to conduct a follow-up inspection, and requested an escort from an officer after there was a perceived threat made during a previous inspection.

Upon entering the business, I observed a male standing at the register behind a glass wall. That male identified himself with a Wisconsin Driver's License as Marouf Mohamad Dahir (08/10/57). He was also in possession of a second Wisconsin ID issued to Mohamad M Dahir (06/18/97), who he identified as his son. Marouf stated he's in possession of his son's ID, because his son keeps misplacing it. No further action was taken.

Inspectors conducted their check of the property and found a minor infraction of household cleaning supplies stored over food items. They explained to Marouf the infraction, and he confirmed items would be moved.

The inspection was concluded without incident or any other concerns at that time.

On Friday, November 1, 2024, at approximately 1:53 PM, Squad 5142 were dispatched to a possible armed robbery complaint, which later was determined to be a property damage incident, located at 2500 N Booth St, in the City and County of Milwaukee.

I interviewed the caller/employee who disclosed two juveniles entered the store, and he demanded they leave and locked the door. DAHIR stated while outside the juveniles stated they had a firearm and would use it. DAHIR stated the juveniles continued to stand outside beating on the window and harassing him. DAHIR stated one of the juveniles brandished, what he thought was a hammer, and smashed the glass front door (valued at \$500), causing the owner the use of their property. DAHIR stated after breaking the window he chased them away from the store and they ran westbound. DAHIR stated, he did not want to press charges for what he experienced during this incident, however the owner of the establishment may want to. Responding squads located the juveniles and a foot pursuit ensued in which the juveniles were eventually taken into custody.

This license premise report is written by PO David LETTEER, assigned to District 5, Day Shift, Sq. 5166.

On 05-08-25 at 1:05 p.m., I went to Star Grocery, located at 2500 N. Booth St,. in the city and county of Milwaukee, which is a licensed business in the city of Milwaukee.

Upon arrival I met with City of Milwaukee Consumer Environmental Health Manager Lauren WOBORIL, who needed to re-inspect the premise for health violations. I was informed that the police were needed due to a prior visit where threats were made during the Health Department visit.

As the Health Department was conducting their inspection, I was able to speak to the clerk, ARABIYAT SEIF, Mohammad (w/m 10-06-96). As I was speaking to SEIF, I informed WOBORIL that I had a visit to the establishment where the business needed to make their licenses current and that people working the counter had their Class D license in order to sell alcohol at the store.

SEIF stated the store had current licenses and I asked him if he was selling alcohol and if he had a Class D license. SEIF stated the owner was coming back to the store and he removed a sign from the front door, with the time of the owner returning at 2 or 3 pm. I informed SEIF that he could not take money for alcohol until the owner returned to the store.

SEIF then informed me that the owner of the building was not going to renew their lease and that in 6 months the store will be closing. I informed him that he could not sell alcohol if he did not have the license to do so. He stated he opened the store at 9:00 a.m. and was just helping out until the owner returned.

During the inspection a leaky freezer was located with water on the floor near the freezer. The freezer did contain frozen items such as pizza and other various frozen food products. Temperature

measurements were taken and it was deemed that the frozen products in the freezer needed to be thrown away, that they could not be sold to customers due to de-thawing in the freezer. SEIF complied and removed the food items, disposing of the food items at the request of the Health Department.

The business did have their current licenses posted near the cash register, which expired on 05-20-25.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
