This office is in receipt of your claim in the amount of \$253.00, relating to damage sustained to your vehicle on June 24, 2003 when you allege you drove over an elevated manhole lid near North 76th Street and West Mill Road.

Our investigation reveals Underground Operation investigated a report of a loose manhole lid at the subject location on June 24, 2003. The intersection and area manhole lids were found to be secure and in proper condition. The department has no reported history of any problems at this location. Prior to this alleged incident the City had no notice of this loose manhole lid and because of this lack of notice, the City would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
