This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/27/2020 officers conducted a license premise check at Leon's Frozen Custard, 3131 S 27th St, to check for compliance with the Safer at Home order issued by the Governor. The business was in compliance with the order. The applicant was on scene and cooperative with the officers.
2. On 04/05/2020 officers conducted a license premise check at Leon's Frozen Custard, 3131 S 27th St, regarding complaints of Covid 19 violations. When the officer arrived they observed cones placed 6 feet apart for customers to stand by while waiting to order. The officers spoke with the manager, who stated they have the customers stand by the cones and only serve one customer at a time. If they observe groups standing by each other, an employee will go out and have them separate.
3. On 07/12/2020 officers conducted a license premise check at Leon's Frozen Custard, 3131 S 27th St, regarding complaints of Covid 19 violations. When the officers arrived they observed the business was following order issued by the Milwaukee Health Department. The manager was cooperative with officers.

4. On 06/06/2021 officers were dispatched to a Trouble with Subject at Leon's Custard, 3131 S 27th St. The officers spoke with a security officer on scene. He stated there was a group of

35 vehicles and four wheelers in the lot revving engines and smoking their tires. The security guard told the subjects to leave but they refused. The officers spoke with the applicant, who stated they have security hired to stop any issues that arise and he inquired on what else he could do to stop further issues. The applicant was advised to contact the Community Liaison Officer.

5. On 06/19/2021 an officer was dispatched to a Trouble with Subject at Leon's Custard, 3131 S 27th St. The officer spoke with security, who stated there were two subject loitering. He asked them to leave and they became verbally abusive to him. The subjects left prior to the arrival of the police.

The following pertains to Leon's Frozen Custard located at 3131 S. 27th Street.

6. On 03/02/25, at 6:30 p.m., An officer was dispatched to a Trouble with Subject complaint. The caller stated there was a homeless male harassing customer. Upon arrival the caller and male subject were no longer on scene.
7. On 03/07/25, at 9:09 p.m., An officer was dispatched to a Trouble with Subject complaint. The manager called regarding a concern with several subjects in cars gathering on the property. No business violations observed.

On Monday, May 5, 2025 at approximately 9:54 PM, I was dispatched to 3131 S 27th St (Leon's Frozen Custard) regarding a car meet of approximately 40 + vehicles.

Upon arrival, I observed the parking lot at 3131 S 27th St (Leon's Frozen Custard) along with their extended parking lot south of the location directly next to the location and the parking lot at 3129 S 27th St (Einstein's Bros. Bagels) to be completely filled with vehicles and patrons. I observed that the majority (approximately 80%) of the patrons were not customers of Leon's Frozen Custard. Myself along with responding officers conducted a walk through of the parking lot.

OBSERVATIONS:

Loud music extending more than 50 feet could be heard from numerous vehicles after 10:00 PM.

Extremely loud exhaust could be heard from numerous vehicles.

Numerous vehicles at the location were observed to have illegal front window tint.

I detected a strong odor of suspected burnt marijuana emanating through out the air from all three parking lots.

I observed numerous subjects walking with tobacco wrappers, splitting the wrappers, and then filling the wrappers with suspected fresh marijuana.

I observed open alcoholic beverages on top of vehicles parked in the parking lots.

I observed numerous subjects holding at their waistbands as I observed a bulge underneath their clothing near their hands. Based off my training and experience having conducted numerous firearm investigation, I know these subjects may be armed with a firearm which could be used to harm or kill myself or civilians in the parking lots.

I observed two clearly and visibly posted signs stating "CUSTOMER PARKING ONLY, NO! LOITERING CITY

I observed the location to have adequate lighting for hours of darkness.

I did observed surveillance cameras inside and outside of the location.

I did not observed any security personnel at the location.

At approximately 10:28 PM I conducted a business check at the premise 3131 S 27th St (Leon's Frozen Custard).

I spoke with the manager of the location who was later identified as Cristina DORANTES (F/H, DOB 10/03/1977). DORANTES stated she has worked at the location for approximately 30 years, works 5-6 days a week, either from 10:00 AM-5:30 PM or 5:30 PM-11:30 PM.

DORANTES directed me to the posted FOOD DEALER license inside of the location which was current and up to date. I did not observed a posted occupancy sign.

I observed the location as cluttered and messy.

DORANTES providing me with the employee work schedule. I observed the schedule to show nine (9) employees on the schedule until 11:00-11:30PM.

Upon investigation, DORANTES handed me her cellular device with the owner/agent of the premise who was identified as Ronald SCHNEIDER (M/W, DOB 01/11/1950).

SCHNEIDER stated that he would like police to assist the premise with removal of subjects who are not customers at the location. He stated he has surveillance cameras and posted no loitering signs on the premise. He was cooperative in this investigation. Please watch body camera footage for entire phone conversation.
