Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Officer Carlos Felix, assigned to the License Investigation Unit, Day Shift. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/12/23, at 11:13 PM., an officer was dispatched to 420 E. Capitol Dr., McDonald's, for a Trouble with Subject complaint. The on-shift manager informed a female employee working, she was not needed anymore for the shift. The female refused to leave, became boisterous, and threaten to fight the manager and a second employee. Upon the officer's arrival the female was no longer on there. The female was terminated by a manager. No license violations were observed.
2. On 06/10/24, at 4:03 PM., officers were dispatched to 420 E. Capitol Dr., McDonald's, for a Subject with Weapon complaint. An employee was told they had to go home. That employee stated they were not going anywhere and displayed a handgun concealed in their waistband. The employee was no longer on scene when officers arrived. Upon the investigating officer conducting follow-up at a later date, video was not available. No license violations were observed.
3. On 08/03/24, at 7:15 PM., officers were dispatched to 420 E. Capitol Dr., McDonald's, for a Fight. An employee became upset after being fired and poured bleach over the lobby floor. That person was no longer on scene, and officers were informed their services were no longer needed.

An employee working placed his book bag containing a handgun in a locker and later discovered it was stolen. No license violations were observed.

An irate customer in the drive-thru entered the business yelling threats and throwing items, which caused a disturbance. The customer left after employees escorted them out. Security camera footage was not available during the investigation. No violations observed.

She states that the customer became angry and pulled up to the window and began yelling at the workers and pounding on the window. She states that the subject then parked her car next to the window and began banging on all the windows. GAITER states that she locked the lobby doors to prevent the subject from coming inside. She states that they were still letting other customers into the store and that one of them opened the door and let the angry customer inside. She states that the subject continued yelling and then walked behind the counter and began knocking things over. She states that the subject eventually left after being escorted out by some of the workers.

MOHAMED stated they were all in line at McDonalds ordering food, when a male behind them were trying to talk to HOLLOWAY and MABRUKE. MOHAMED stated the male subject was complimenting HOLLOWAY and MABRUKE making them uncomfortable, when he chimed in telling him "okay can you just stop because they're not responding to you". MOHAMED stated the male subject then told him "I wasn't even talking to you, it could get like that", while he was "clutching" his gun.

I spoke with a McDonalds associate who was verbally identified as THOMAS, Criston R., (B/M, 08/09/80) who stated he didn't see the incident because he was busy working.

THOMAS was cooperative during the interview.
