We have received your claim for the amount of \$2,014.86 in relation to the property damage you sustained on March 19, 2015.

The Milwaukee Fire Department reports they received a call from your tenant requesting medical assistance. The tenant was not able to come to the door, so the fire department requested the Milwaukee Police Department force entry into the residence.

Our investigation reveals the Milwaukee Police Department exercised appropriate action in this forced entry and as such the City of Milwaukee would not be liable. Accordingly, we are denying your claim.
