Dear Ms. Vaughn:


We are in receipt of your claim for damages in the amount of \$3,563.67 that resulted from a snow plow striking your vehicle on December 30, 2020, in the vicinity of 3377 North 27th Street, Milwaukee, Wisconsin.


We have conducted and concluded our investigation of this matter. The vicinity in which your car was struck, 3300 block North 27th Street, is a main thoroughfare in the city with heavy traffic, involving various trucks, that travel in the area overnight.

Without concise information that directly ties our city unit as the party that struck your vehicle, we are unable to accept liability for the damages to your vehicle. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

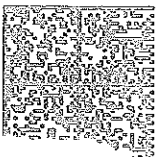
