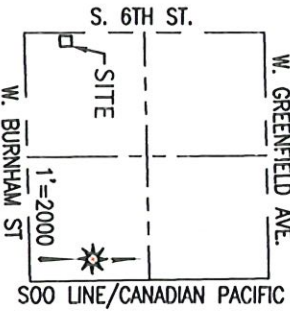

VICINITY MAP

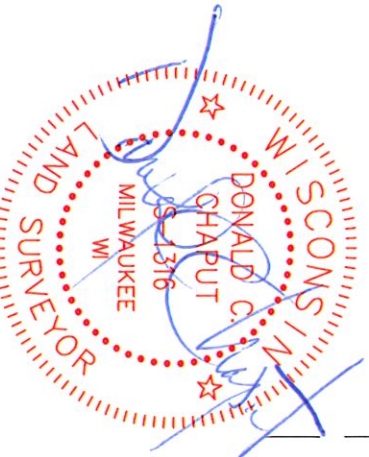

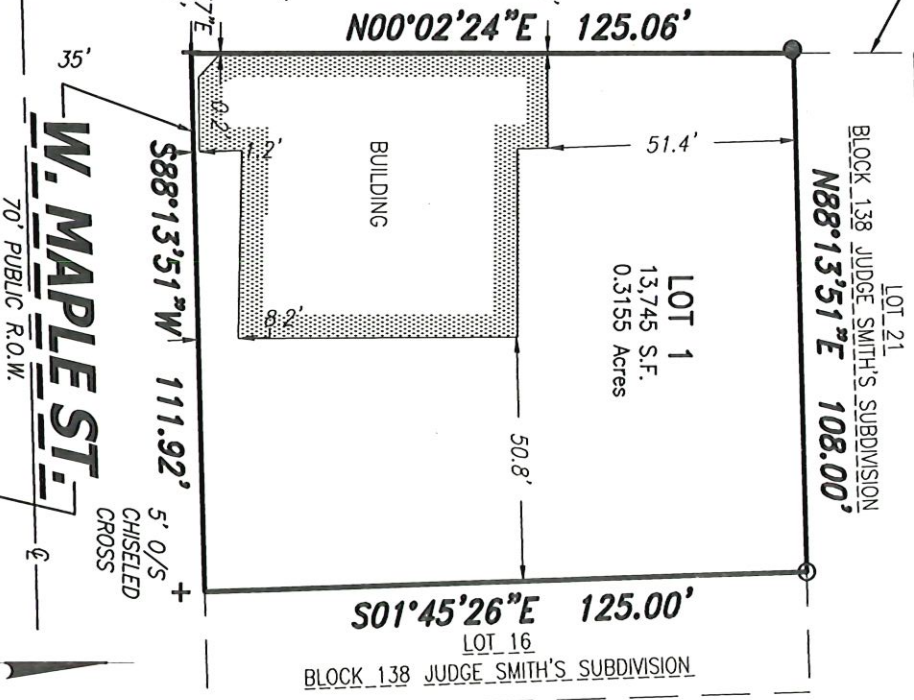

Said lands contains 13,745 square feet, or 0.3155 acres.

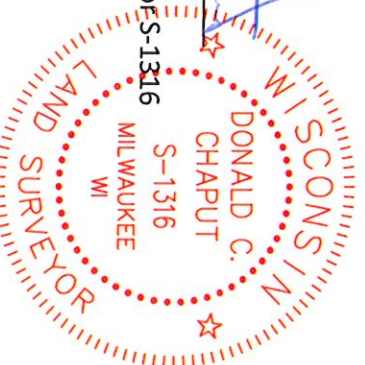

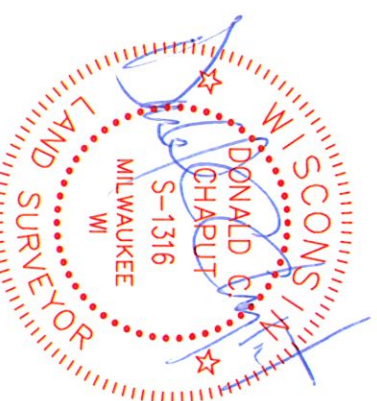
