This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/20/23 at 9:54a.m., Milwaukee Police were dispatched to a Threat at 225 E. Capitol Dr. On arrival officers could not locate the caller, nor the subject described in the CAD system. The business stated they did not call the police.
2. ON 05/030/23 at 10:56a.m., Milwaukee Police were dispatched to a Subject with Gun at 225 E. Capitol Dr. Investigation revealed a suspect was loading their backpack with items and when confronted by the store manager, they lifted their shirt and displayed a gun in their waistband and fled the store. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
3. On 05/18/23 at 12:17p.m., Milwaukee Police were dispatched to a Trouble with Subject at 225 E. Capitol Dr. Officers were advised a subject was panhandling outside and refusing to leave. The subject was gone on police arrival and the business was cooperative.
4. On 06/07/23 at 1:56p.m., Milwaukee Police were dispatched to a Theft at 225 E. Capitol Dr. Investigation revealed subjects took items without paying, then fled. The business was cooperative.

On Monday, April 28th, 2025, at approximately 1647 hours, my partner P.O. Kimberly KANEKEO and I, squad 5241, were dispatched to 225 E Capitol Dr, Aldi Supermarket, for a Battery complaint. The incident occurred in the city and county of Milwaukee.

INITIAL OBSERVATION;

Upon arrival, I was met by the caller, who was verbally identified as Brianna J. JONES (f/b 12-27-1995), who is employed through Securitas, at Aldi Supermarket. I was also met by the assistant manager, who was verbally identified as Reagan K. WOOLEN (f/w 02-10-2002). The victim in this case, who was verbally identified as Tahmina S. CADE (f/b 09-12-2003), was initially not on scene.

WOOLEN was able to assist officers with video footage observation.

VIDEO FOOTAGE;

I reviewed video footage, which revealed the following;

I observed CADE inside Aldi Supermarket placing groceries into her cart by the register. I observed at the approximate 1239 hours mark, the alleged suspect, who was described as a black female, heavy set, long black braids, wearing a white t-shirt and camouflage pants, approached CADE and attempted to speak with her. I observed CADE to have ignored the suspect and continued placing her grocery items into bags on the vestibule along the east wall of the business. I observed the suspect began walking towards the exit and turned around towards CADE at approximately 1241 hours. I observed the suspect re-approach CADE in an aggressive manner and began striking her multiple times with a closed fist while pulling her hair. I observed the suspect to have thrown CADE to the ground. I observed the suspect to have also kicked CADE once to the right shoulder area. I observed the suspect to have exited the business shortly after.

WOOLEN was unable to download video footage due to access restrictions, however, informed officers to be able to provide the footage at a later time.

End of footage.

CADE arrived on scene shortly after, and made the following statements;

INTERVIEW OF CADE;

I spoke to CADE, who stated she was inside the business when the suspect approached her. CADE identified the suspect as Eloradanun H. WALLACE (f/b 09-22-1989). CADE stated WALLACE asked her if

she was "Reatha's" daughter, to which she answered "Yes". CADE stated WALLACE asked if she wanted to fight. CADE stated she ignored the question and continued putting her groceries away. CADE stated WALLACE continued to antagonizing her, up until the physical altercation occurred. CADE stated WALLACE exited the business shortly after.

CADE stated the altercation stemmed from her mother, who was also on scene and was verbally identified as Dorothea SMITH (f/b 09-04-1963), being in an intimate relationship with WALLACE's father. SMITH was also able to confirm WALLACE's identity.

End of interview. '

CADE was later transported by Bell Ambulance #420, to St. Mary's Hospital for medical evaluation.

PROPERTY/EVIDENCE;

Due to the limited amount of CST's and high volume of calls for service, I was unable to obtain photos of CADE's injuries. P.O. KANEKEO however, sent CADE an Axon Community Request regarding photos she took on her cell phone.

End of evidence/property.

I later spoke to CADE to obtain an update on her injuries. CADE stated her injuries were simply swelling and stated she did not suffer any fractures or broken bones.

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
