2. On 11/12/2016 Milwaukee police were dispatched to a fight/subject with a gun complaint at 634 West North Avenue. Investigation revealed there had been a fight inside the bar and all the involved parties were pushed outside. A gunfight ensued, during which several rounds were fired into the air and two subjects chased each other while firing weapons. One round struck a vehicle. The armed security guard told officers that "shooting in the air and at people was not a danger towards anyone" so he didn't take action during the gun battle. Milwaukee police incident report # 163170011 filed.

- 3. On 09/29/2017 at 2:35am officers observed cars parked in the bus zone in front of 634 W. North Av. The officer began issuing parking citations and the owners began moving their cars. The officers attempted to speak with owner of the tavern at 634 W. North Av but as they approached they heard the door being locked. The officer looked in the window and observed several people hide behind the bar. On 10/05/2017 the officers spoke with Terence SMITH, the bar manager. He stated he was aware of the incident. He was advised they could not lock the bar in an attempt to keep officer out. The officers checked the posted licenses which stated their closing hours were 1:30am Monday through Saturday.
- 4. On 10/13/17 at 6:15pm officers responded to Levels on North Bar (634 W North Ave) regarding a complaint that the establishment was open even though their license was expired. Upon arrival officers observed the open sing on and people inside the establishment with drink in their hands. Officers spoke with a bouncer and advised him that the bar was no supposed to be open. The bouncer called the owner by phone and explained the situation. The owner stated he didn't know the license was expired and stated he would comply and close the business.
- 5. On 10/17/17 at midnight officers conducted follow up regarding Levels on North Bar being open for business when their license was expired. An officer drove past the business and found it to be closed. The officer received an email from Terence Smith, the manager, asking why they could not be open. The officer responded by email explaining the Class B Tavern license was expired and the application for a provisional license was denied. Smith responded to the email stating he would comply and that they would be doing some remodeling until the license was renewed.
- 6. On 03/17/18 at 3:15 am, Milwaukee Police were investigating a shooting at N. 6th Street and W. North Avenue when an officer observed blood and multiple bullet casings on the stairs outside 634 W. North Avenue (Level's on North). An officer entered the tavern and made contact with a subject, who identified himself as the manager, and asked him if he knew anything about the shooting. The manager stated that he did hear 2 gunshots, went outside, but did not observe anything. While the officer was interviewing the manager, the door of the woman's restroom opened and a male and female exited and was told to wait for detectives. The officer did observe blood inside the threshold of the door to the tavern which caused the officer to look around the establishment for more signs of blood. While doing this the manager became defensive and agitated, questioning the officer as to what he was doing. The manager told the officer who the owner of the business was and asked the officer to contact the owner because he was "just the manager". While waiting for detectives, the officer observed and heard the bar manager urinating in the sink behind the bar area. When detectives arrived, the bar manager became extremely uncooperative with them and kept repeating himself when asked questions. The agent was issued a citation.

7. On 03/20/18 at 10:30 pm, Milwaukee Police conducted follow-up regarding a shooting which occurred outside of 634 W. North Avenue (Level's on North) on 03/17/18. Employees of the tavern lied to officers about the events surrounding the incident and only told the truth when officers confronted them with the fact that police knew the shooting victim entered the establishment after being shot. One of the employees also said that he was the Manager of the tavern but when he was asked for his "Class B" manager's license, he changed his story and told officers that he just stocks and cleans the bar. While conducting these interviews, officers could smell fried food being made and found that there was an employee, in the kitchen, standing next to an oil fryer. There were four baskets of wings frying in the deep fryers and a five gallon bucket of chicken wings defrosting in the sink. The employee stated that they were selling food items and he was "in charge" of the food. Officers later check to see if the tavern had a food dealers license and found they did not. A citation was issued.

- 8. On 03/21/18 at 8:30 pm, Milwaukee Police performed follow up at 634 W. North Avenue (Level's on North) regarding earlier contacts with police at the tavern (Items #6 and #7). The agent stated that he wanted to work with police on any problems that may be the result of the establishment. He was informed that the employees were uncooperative with officers during a shooting investigation, the manager urinated in a sink, and employees were cooking and selling food. The agent informed officers that he was unaware of these problems and the person urinating in the sink was not the manager but just a "helper". He was informed that a meeting needs to take place per the request of the Captain of the Fifth District in order to work out any problems and about the citation's he will be issued for the earlier violation observed by officers.
- 9. On 07/22/18 at 12:40 am, Milwaukee Police conducted a tavern check at 634 W. North Avenue (Level's on North). In past contacts with police, occupants would lock the entrance to the establishment and open it after several knocks. When officers approached the tavern during this check, patrons attempted to shut the door on officers but they were able to gain entry before the door was fully closed. As police gained entry, multiple subjects blocked the entrance and officers observed multiple subjects flee into the back rooms of the location. Officers checked the two bartenders for Class D Operators license but neither one could verify their license status. The maximum occupancy of the establishment is 62, but officer's body cameras revealed that the tavern appeared to be above that occupancy. There was armed security inside the tavern and officers did have a conversation with the agent. No citations were issued.
- 10. On 08/14/18 at 10:29 pm, Milwaukee Police conducted a tavern check at 634 W. North Avenue (Level's on North). Officers were met outside by the agent and they proceeded to enter the rear of the business which is a kitchen area. Officers observed in the kitchen that the agent had four fryers on and a large bucket of chicken in the sink defrosting under water. The agent was informed that he is not allowed to serve food because he did not have a proper license and he stated that he was not selling the food, it was for a party. Officers informed him that making chicken for a party is still in violation and he could receive citations if he does it again. The agent understood and said he would stop making chicken. The agent informed officers that his license was up for renewal and he has a meeting with the alderperson regarding his license.

11. On 10/12/2018 officers conducted a licensed premise check at 634 W. North Av. The officer observed a customer with food in a Styrofoam container. The officers attempted to check the kitchen but found it locked. The officer advised that as a licensed premise he could check the entire property. Access was granted and the officer observed 5 fryers operating and chicken defrosting in the sink. The applicant arrived while the officers were on scene and could not explain the food being prepare. The applicant was cited for Food Establishment License Required.

12.On 11/30/2018 officers conducted a licensed premise check at 634 W. North Av. The officers spoke with a bartender about whether the business would be open on New Year's Eve and she stated she was not sure because the owner has not advised them yet.

- 13. On 03/19/2019 at 2:04am officers observed people inside Level's on North, 634 W. North Av. The officers shined their lights on the windows and 4 females left the building. At 2:10am officers conducted a licensed premise check and spoke with the applicant who was standing in the door way. There were several more people inside that left without incident. The officers checked the bar and found evidence of marijuana being smoked in a back room and a bag of rifle ammunition. The bartender stated it was her birthday and the patrons were her friends who were celebrating with her. The officers counter a total of 22 people inside the bar. The applicant stated he thought the time was 2:00am when the officers arrived and that he had time to have the patrons leave.
- 14. On 04/22/2019 officers received information that Level's on North was having a "Repass" party and there were subjects inside with guns and one of them was wanted. When the officers arrived it appeared the business was open with the open sign illuminated. As they approached the door it was locked by a subject inside. The officers observed people inside running to the back of the bar. After they were let inside they checked for subjects hiding in the basement and upstairs, but did not locate anyone. They did recover two guns in trash cans, one in the kitchen and the other in the men's bathroom. Officers located suspected heroin and cocaine in baggies on the floor of the bar. Officer located suspected marijuana in a back room of the establishment. Officers also located 10 baggies containing heroin in a stairwell leading to upstairs apartments. The kitchen was in full use with brats, ribs and other foods being cooked. The applicant arrived and stated this was a private party and the food being prepared was being provided for free.
- 15. On 08/16/2019 at 1:20am officers were dispatched to a fight at N. 6th St and W. North Av. The caller stated a large group of people were fighting in the road and female had a board. The investigation revealed the subjects involved came from Level's on North, 634 W. North Av. The security guard at Levels stated some patrons left the bar and began to fight on the corner of 6th and North. He and another security guard ran down to the fight and broke it up. Officers spoke to two victims who stated an argument occurred on the dance floor and left the tavern. One group followed the other to their car and broke the car's window with a board.

16. On 09/03/2019 at 1:40am officers observed people outside of Level's on North and auto double parked on North Av. The officers observed 6 people walk inside the tavern, which has a 1:30am closing time listed on their license. They also observed a Black female approach the bar and attempted to open the door which was locked. Officers observed and employee who is known to them, open the door and allow the female inside. The officers drove around the block and when they returned they observed 10 people on the sidewalk and a bartender telling them to leave the area. One subject had a small liquor bottle in his hand. At 1:49am officers entered the business and found 7 patrons still inside the bar. The applicant was issued a citation for allowing patrons after hours.

17. On 11/27/2019 the applicant was cited for Operating while Intoxicated and Intoxicant in Vehicle. On 06/18/2020 the applicant was convicted and his license was revoked for 6 months.

18. On 12/31/2019 at 10:50pm officers conducted a license premise check at Level's on North, 634 W. North Av. The officers spoke with the bartender, who stated she has a Class D Operator's license but did not have it on her person. A check revealed the subject was in fact not licensed. The applicant was called and arrived on scene. The officers also observed food being prepared and fryers warmed and ready to cook. The applicant stated he cooks the food but does not sell the food because her does not have a food license. The applicant was cited for Responsible Person on Premise and Food License Required. At 3:09am the officers returned and observed a subject enter the bar and heard the front door being locked after the patron entered. They observed another patron attempt to enter but the door was locked.

- 19. On 02/02/2020 at 2:11am officers were dispatched to a Shooting at Level's on North, 634 W. North Av. The investigation revealed no one was shot but a subject was observed firing shots in the air outside of the business. Security stated there was a fight inside and the subjects were being escorted out. One of the security guards observed a subject sitting in an auto firing shots in the air. The officers spoke with the applicant, who stated he called the police after hearing the shots in case someone was shot.
- 20. On 02/22/2020 at 12:42am officers were dispatched to a Shooting at N. 6th St and W. North Av. The responding officers observed numerous cars parked in the area. The only

businesses open were Wendy's and Level's on North. The officers spoke with security working at the door for Level's on North. He stated he did not hear any gunshots, or see anyone shot. The officer spoke to the applicant about what the head count of the tavern was. The applicant did not know. The officer then went inside and observed a large crowd. The officer observed numerous patrons coming from an area of the business that was labeled "employees only". When theofficer's checked that area they located a chest freezer in the hallway with a pistol inside. The officers recovered the pistol and inventoried it at the station.

- 21. On 02/25/2020 officers assisted the FBI and IRS serve a search warrant at 634 W. North Av. The officers recovered 2 air pistols, ammo in several different calibers, a digital scale and 9.4 grams of Heroin.
- 22. On 03/22/2020 officers conducted a license premise check at Level's on North, 634 W. North Av, to see if the business was complying with the Safer at Home order. The officers found the business was closed.
- 23. The applicant has 4 warrants with Milwaukee County Sheriff's Office for Failure to Support (warrant #'s: 2020006139, 2020006138, 2020006145, 2020006974).

On 12-31-19 at 8:00 p.m., Sq. 5468 and Sq. 5466 (PO MARITATO and PO PARKS) conducted a licensed premise check of Level's on North, a licensed premise in the city of Milwaukee, located at 634 W. North Ave. Upon arrival, we observed that the bar was dark, no interior lights or window neon signs were turned on. We believed that someone would be at the bar and setting up for New Year's Eve. We did not observe anyone inside or outside of the bar.

We returned to the bar at 10:50 p.m. and found the bar to be open for business. We entered the bar and conducted a tavern check. Upon entering the bar, there were 8 people at the bar, who were drinking alcohol, with the security guard Kendrick L. TIERRY (b/m 01-08-88), behind the bar with the bartender Lena K. JOHNSON (b/f 09-04-90). There was also another unidentified female behind the bar, sitting on a chair, next to a sound mixing device.

PO LETTEER walked to the north end of the bar and stood at the opening to walk behind the bar. TIERRY began walking towards PO LETTEER and asked what we wanted. I informed him that I needed to speak to the person in charge of the bar, which would be the licensed bartender. TIERRY again asked what we wanted and PO LETTEER informed him that he needed to speak to the bartender. TIERRY left from behind the bar and PO LETTEER spoke to JOHNSON. TIERRY was hired by HENDERSON and started work at 9:30 p.m.

PO LETTEER informed JOHNSON that officers were at the bar to check licenses and make sure that the bar was operating as it should be, so the bar could operate for New Year's. JOHNSON stated she did have a license and paid 80 dollars for it, but that she did not have it on her person. JOHNSON showed me on her phone a certificate for a server's course. I asked her if she had the city of Milwaukee license and she stated she had it. PO LETTEER was able to gather her information and check the online licensing system to validate her claim of having a Class D License. PO LETTEER checked the online licensing system for her name and date of birth, but could not locate any valid Class D License for JOHNSON. She was informed of this and asked to call the licensed agent, Jeffrey HENDERSON, to come to the bar so we could speak to him. We informed JOHNSON and the patrons in the bar that nothing was going to be served to anyone, until this could be sorted out. The unidentified female who was sitting behind the bar, stated she had her bartenders license, but stood up and left the bar.

PO LETTEER informed JOHNSON since she has completed the severs course, that all she needed was to go downtown and apply for the license and that she may have to appear in front of the committee as part of the application process. JOHNSON stated she was just hired in early December to work at the bar as a bartender and that she also works at another bar, but she never stated what other bar she works at JOHNSON was informed that once she does get her license, to leave a copy at all the bars in which she bartends at, so there would be no further confusion when asked for her license.

While waiting for HENDERSON, PO MACRAE conducted a check of the licensed areas of the bar, which includes the first floor. PO MACRAE was able to enter the back room, which is located on the north side of bar, that is connected to a kitchen. PO MACRAE upon entering the kitchen found a black male, identified as Omar A. HARRIS (b/m 05-22-73), who stated he was waiting for the "Boss" and that he was setting everything up, again waiting for the "Boss", to start cooking the food. PO MACRAE asked him what was meant by getting things ready and HARRIS stated he was cooking a lot, getting the fish

(darkened fish) and the grills (burgers) ready. PO MACRAE asked HARRIS if he was going to cook the fish and HARRIS informed PO MACRAE that "The bar does pretty good", in reference to cooking food. PO MACRAE asked HARRIS where they get the fish from and HARRIS stated the "Boss" gets it from a grocery depot that is located on the south side. PO MACRAE then asked HARRIS if the "Boss" was HENDERSON and he stated HENDERSON was the "Boss".

PO MACRAE, while in the kitchen located on the south wall of the kitchen an orange piece of paper, which appeared to be a menu of items that are cooked in the kitchen. The menu items were as follows:

Steak/Philly \$10, Blackened Fish w/Veg/Rice \$15, Grilled Chicken w/ Rice and Veg \$15, Catfish Dinner \$10, Catfish Sandwich \$10, Grilled or Fried Chicken Salad \$10, Grilled/Fried Sandwich \$10, 8PC Chicken \$10, 8 PC Wings \$10, 5PC Tenders \$10, Burger \$10, Buffalo Chicken Salad \$10. On the menu was also the disclaimer that "All prices go up after 12:30 a.m." It should be noted while on this call, there were also two more menus located behind the bar.

Along the south wall of the kitchen, on a prep table, just below the menu, were spices and dressings, along with stacked Styrofoam food containers. PO MACRAE while continuing his inspection, located five fryers, which were filled with oil and ready to cook, along with two electric skillets, which were operational and a bowl filled with fish fillets.

We called for a supervisor to come to the bar, in order to explain the situation and learn if the bar was going to be closed for the night. SGT. KITTS and SGT. SMITH arrived and we explained the situation. It was determined that if HENDERSON would arrive at the bar and stay there, the bar could be open and that we would document this incident, along with the appropriate citations. PO LETTEER also checked the online license system to make sure that HENDERSON had the proper licenses for the bar. The check revealed that Level's on North has a BTAVN License (207791), PEP License (6329) and a CIG License (1028827), all of which are set to expire on 11-07-20.

HENDERSON arrived at the bar and PO MACRAE explained why we were there and what we found while at the bar. HENDERSON was very agitated that we were there and once the food situation was explained, he stated the guy in the back was homeless and that he cooks food. He stated he was not selling the food because he did not have a food license. HENDERSON stated he believed the bartender to have a valid bartender's license, upon being hired. HENDERSON stated "This stuff always happens when I am not at the bar!" HENDERSON stated that he is a small black owned bar and that he cannot afford to have any further citations or reports issued to the bar. We informed HENDERSON that we would be filing this report, along with issuing citations as it related to this call.

We asked HENDERSON if he was going to stay at the bar and he stated he would be at the bar all night. We informed him that we would return later to make sure that he was at the bar, operating the bar.

At 3:09 a.m., Sq. 5468 and 5466 returned to the bar in order to see if HENDERSON was still at the bar, while the bar was in operation. Upon driving up to the front of the bar, we observed both sides of North Ave., the south and north side of the street in the 600 block were filled with vehicles. There were also vehicles parked on N. 6th St., just to the north and south of W. North Ave. The only business open at this time was the bar.

We drove around the area and counted about 60 vehicles parked near the bar. We pulled out marked squad in front of the bar and stopped. We observed a patron entering the bar and just before entering, the patron was patted down, by a black male in sunglasses and a fur type coat. While the person was being patted down, we could see inside of the bar and it appeared that people were standing shoulder to shoulder. The black male after patting the patron down, closed the door and locked the door. We could hear from our vehicle the lock on the front door being locked. Just after the door being locked, there was another person standing in front of the bar. The caller was identified as Jeff, who later was identified as the owner or agent of the bar, Jeff HENDERSON. The call was for that someone was shot. Then there was an update of nobody being shot and that someone was firing shots outside and nobody shot at the time of the call. Officers were able to learn that a Silver 2dr. Audi, with a black male with dreadlocks shot into the air.

Upon arrival, Sq. 5330 (PO SOSA and PO WHITLEY) and interviewed Anthony C. LASLIE (b/m 12-19-88), the security guard and he stated he was inside of the bar, when the shots were fired in front of the business. A second security guard, Terry KENDRICK (b/m 01-08-88) was inside of the bar, letting people out. He stated there was a verbal argument inside of the bar and they were escorted out of the bar. KENDRICK then stated he observed a b/m shoot a gun into the air and that he was a passenger of a silver vehicle.

As officers were at the call, inside of the bar, they could smell the strong odor of marijuana. It is unknown if officers located any marijuana or paraphernalia.

Later we (PO MACRAE and I) spoke to HENDERSON. We informed him that a tavern report would be written. HENDERSON stated he did not know what was going on and believed that someone was shot outside, even though it was found that no one was shot. HENDERSON stated he called the police, just in case there was someone shot.

On 02-22-20 at 12:42 a shooting was called in at N. 6th St. and W. North Ave. Upon arrival, we observed cars parked on N. 6th St. at W. North Ave., as well as in the 600 block on W. North Ave. We, along with other squads checked the area. The only two businesses that were open, were Wendy's and Level's On North Tayern.

PO MACRAE and I, along with Sq. 5430 (PO GRYCOWSKI and PO ROEMBKE) went to Level's On North to make sure that nothing happened at the bar. We spoke to the door man (security) who was standing at the main entrance checking ID's. PO MACRAE asked the door man, Kendrick L. TERRY (b/m 01-08-88), if he observed anything. TERRY stated he did not hear any gunshots, nor did he see anyone who may have been shot. While speaking to TERRY, the listed agent Jeffrey HENDERSON exited the main door and came out by us. PO MACRAE then asked TERRY how many people he had in the bar and TERRY could not answer with a number count. TERRY looked at HENDERSON, when asked once again how many people were inside of the bar, including staff.

PO MACRAE looked into the tavern and observed a large crowd of patrons inside. PO MACRAE informed HENDERSON that a "head count" of the patrons inside would be conducted. As PO MACRAE entered the tavern and began counting patrons and observed numerous subjects entering the tavern from the NE/rear "employees only" area. Upon sight of police they immediately made their way to the front door to leave.

PO MACRAE observed another group of subjects entering the tavern from the NW/rear "employees only" area which leads to a kitchen. As PO MCARAE walked towards the subjects and stopped one person still standing in the rear hallway later identified as Brad L. CHRISTIAN (B/M 05/14/63). CHRISTIAN was asked if he was an employee; he stated no. CHRISTIAN stated that he was using the bathroom. It should be noted that in the tavern area just outside where CHRISTIAN was observed are separate male/female bathrooms.

As the bathroom / hallway, where the subjects were observed, a white chest-freezer running in the hallway was observed as well. From past tavern checks, we did not recall ever seeing a chest-freezer in the hallway. The freezer was opened, where observed was frozen food, and a black handgun with an extended magazine lying inside. At that time, PO LETTEER came over near me. PO MACRAE informed PO LETTEER who stayed next to the weapon. The tavern was shut down with the authority of SGT Derek

KITTS (SQ#5412). The handgun located was a Taurus G2C 9mm semi-automatic pistol with an extended magazine, Serial #TMU23826, MPD Gun Tag # 88457.

PO Greg GREGORY (SQ#5330) took numerous photos of the scene and handgun. The weapon was recovered after photographs of the scene were taken.
