
Dear Mr. Bellamy:

This office is in receipt of your claim in the amount of \$374.00, relating to an incident that took place on or about March 3, 2003 at the Midtown Shopping Center.

Our investigation reveals that the Milwaukee Police Department has no records relative to this alleged incident.
