Dear Alderman Bauman:

The above files were introduced recently at the request of Alderman Michael D'Amato in connection with a large residential condominium project being developed in the 3<sup>rd</sup> Aldermanic District.

At the time that we made that request of Alderman D'Amato, it was not clear as to what type of soil stabilization facility would be used, but since that time, revised construction plans have been reviewed, and it has been generally concluded that since there will only be a temporary stabilization facility and that no structures will be constructed under the public right-of-way, the Department of Public Works will deal with this through a permit, eliminating the need for the subterranean space lease.

You may receive a communication from the Department of Public Works in the near future indicating that both files may be placed on file.

The purpose of this communication is to advise that we concur in that recommendation and apologize for any inconvenience I may have caused your committee staff.


