Dear Committee Members:

To implement the rates of pay contained in the 2015-2016 Memorandum of Understanding between the City of Milwaukee and the Milwaukee Police Supervisors' Organization, we request your approval of amendments to Part I, Section 4 of the Salary Ordinance.

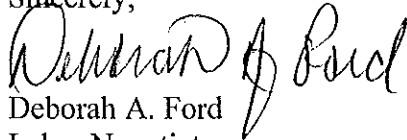
