This is to notify you that on Tuesday, April 29, 2025, the City's Licenses Committee voted to recommend to the City's Common Council to renew with a 10 (ten) day suspension your Filling Station, Food Dealer and Weights & Measures licenses and; not to renew your Extended Hours Establishments license based upon the preponderance of the evidence in the police report, applicant, and aldermanic testimony that demonstrates that the operation results in a threat to the health, safety, and welfare of the public and for failure to comply with the approved plan of operations, for the premises located at 406 W Center St. ("Center St BP").

On May 2, 2025, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the Extended Hours Establishments, Filling Station, Food Dealer and Weights & Measures licenses in which the Committee recommended renewal with a 10 (ten) day suspension of your Filling Station, Food Dealer and Weights & Measures licenses and nonrenewal of your Extended Hours Establishments license based upon the preponderance of the evidence in the police report, applicant, and aldermanic testimony that demonstrates that the operation results in a threat to the health, safety, and welfare of the public and for failure to comply with the approved plan of operations. You were further notified that the Milwaukee Common Council would consider the matter at its meeting on Tuesday, May 13, 2025 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did file written objections to the report of the Licenses Committee and you did appear in person.

Following consideration of the report of the Licenses Committee, the Common Council voted renewal with a 10 (ten) day suspension of your Filling Station, Food Dealer and Weights & Measures licenses and nonrenewal of your Extended Hours Establishments license based upon the preponderance of the evidence in the police report, applicant, and aldermanic testimony that demonstrates that the operation results in a threat to the health, safety, and welfare of the public and for failure to comply with the approved plan of operations. The suspension of the Filling Station, Food Dealer and Weights & Measures licenses is in effect between 12:01 a.m. on May 13, 2025 until 11:59 p.m. on May 22, 2025. The nonrenewal of the Extended Hours Establishments license is in effect on May 13, 2025.

This is to notify you that on Tuesday, April 29, 2025, the City's Licenses Committee voted to recommend to the City's Common Council not to renew your Class B Tavern, Public Entertainment Premises and Food Dealer licenses based upon the preponderance of the evidence in the residents' testimony, aldermanic testimony and the video included in notice of the hearing that demonstrates the operation results in a threat to health, safety or welfare of the public for the loud noise when the business is open, the excessive littering and other things mentioned at the hearing and; to deny the Change of Agent, Removing/Adding Stockholder transfer application, for the premises located at 340 W Reservoir Av. ("Lush Lounge").

Following consideration of the report of the Licenses Committee, the Common Council voted nonrenewal of the Class B Tavern, Public Entertainment Premises and Food Dealer licenses based upon the preponderance of the evidence in the residents' testimony, aldermanic testimony and the video included in notice of the hearing that demonstrates the operation results in a threat to health, safety or welfare of the public for the loud noise when the business is open, the excessive littering and other things mentioned at this hearing and denial of the Change of Agent, Removing/Adding Stockholder transfer application. Said nonrenewal is in effect on May 21, 2025.

This is to notify you that on Tuesday, April 29, 2025, the City's Licenses Committee voted to recommend to the City's Common Council to deny your Food Dealer and Food Peddler Licenses application for the premises located at 3135 S 92nd St., based upon the preponderance of the evidence in the Milwaukee Health Department testimony which demonstrates the operation results in a threat to health, safety or welfare of the public.

On Tuesday, May 13, 2025, the Common Council considered the Committee's recommendation regarding your application. On that date, the Common Council adopted the Committee's recommendation and denied your Food Dealer and Food Peddler Licenses application based upon the preponderance of the evidence on the Milwaukee Health Department testimony which demonstrates the operation results in a threat to health, safety or welfare of the public.

If you previously paid the license fees you may be eligible for a refund, except for a portion of the fee that may be retained, by bringing in the receipt or filing an application for a refund within one year to date of Common Council action with the License Division, Room 105, City Hall.
