

Nonrenewal, based upon the third nonappearance of the Secondhand Motor Vehicle Dealer's license for Mazin Mohamed for the premises located at 4319 N 76th St ("Amazing Auto Sales") in the 5th aldermanic district.

Nonrenewal, based upon the Health Department reports, operating without a license, and applicant testimony of the Food Dealer and Extended Hours Establishment licenses for Shadi Alkhawaldeh for the premises located at 2100 W Hopkins St ("Haji's Red Hot") in the 6th aldermanic district.

Renewal, with a fifteen (15) day suspension, based upon the police report, and aldermanic and applicant testimony of the Class B Tavern and Public Entertainment Premises licenses for Shanita Cotton for the premises located at 2911 W North Ave ("T Jay's Lounge") in the 15th aldermanic district.

Renewal, with a ten (10) day suspension based on the police report of the Class D Operator's License of Pablo Macias.



Re: Report of the Renewal Application of Mazin Mohamed, Agent for Amazing Auto Sales LLC, for a Secondhand Motor Vehicle Dealer's License located at 4319 North 76th Street in the City and County of Milwaukee, Wisconsin ("Amazing Auto Sales").

- 1. Mazin Mohamed (hereinafter the "Licensee") is the holder of a Secondhand Motor Vehicle Dealer's license for the premises located at 4319 North 76th Street in the City and County of Milwaukee, Wisconsin ("Amazing Auto Sales"). Said license expired at midnight on October 1, 2019.
- 2. An application to renew said license was filed with the Office of the City Clerk on July 25, 2019.
- 3. Pursuant to Chapter 85 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, this matter was referred to Milwaukee Police Department for investigation. On July 26, 2019, the Milwaukee Police Department responded with a report that could form the basis for nonrenewal of said license.
- 4. On October 30, 2019 the City Clerk provided timely notice to the Licensee pursuant to Chapters 85 and 275 of the Milwaukee Code of Ordinances of the neighborhood objections. The matter was scheduled for a hearing on the objections on November 12, 2019, commencing at approximately 9:30 a.m. in Room 301B of the third floor of City Hall. At said date and time, the Licensee did not appear.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - Alderwoman Dodd moved denial based on third nonappearance. (Prevailed 5-0) Α.



CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 85 and 275 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Mazin Mohamed who holds a Secondhand Motor Vehicle Dealer's License for the premises located 4319 North 76th Street in the City and County of Milwaukee, Wisconsin ("Amazing Auto Sales") has not met the criteria of Chapters 85 and 275 of the Milwaukee Code of Ordinances, to not renew the Secondhand Motor Vehicle Dealer's License. The Committee finds the police report and aldermanic testimony as stated above to be true as stated above.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Secondhand Motor Vehicle Dealer's License held by Mazin Mohamed for the premises located at 4319 North 76th Street in the City and County of Milwaukee, Wisconsin ("Amazing Auto The Committee based its recommendation on the Licensee's third nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Secondhand Motor Vehicle Dealer's license of Mazin Mohamed for the premises located 4319 North 76th Street ("Amazing Auto Sales") in the City and County of Milwaukee, Wisconsin not be renewed based on the Licensee's third non-appearance.



Re: Report of the Renewal Application of Shadi M. Alkhawaldeh, Agent for Haji LLC, for Extended Hours Establishments and Food Dealer License Renewal Applications with Change of Agent and Stockholder for the premises located at 2100 West Hopkins Street in the City and County of Milwaukee, Wisconsin ("Haji's Red Hot").

- 1. Shadi M. Alkhawaldeh (hereinafter the "Licensee") is the holder of Extended Hours Establishments and Food Dealer Licenses Renewal Applications with Change of Agent and Stockholder for the premises located at 2100 West Hopkins Street in the City and County of Milwaukee, Wisconsin ("Haji's Red Hot"). Said licenses expired at midnight, November 4, 2019.
- 2. An application to renew said licenses was filed with the Office of the City Clerk on October 18, 2019.
- 3. Pursuant to Chapters 68, 82, and 85 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Health Department for investigation.
- 4. On October 30, 2019, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68, 82, and 85 of the Milwaukee Code of Ordinances of the health department report and neighborhood objections and included copies and relevant Milwaukee Health Department reports regarding food safety. The matter was scheduled for a hearing on the health department report and neighborhood objections on November 12, 2019 at 10:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared and admitted receipt of the notice of hearing.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - Α. The Licensee stated the previous owner lives in Canada and he had a bad manager. He stated he applied in October to take over the business, but he was never told to meet with the alderwoman. He added that he paid for the license



and waited for it to come in the mail, but it never came. He stated he tried to meet with Alderwoman Coggs last Friday. He added that there are no more violations because he cleaned and fixed everything. He stated that all employees will go to the food manager certification program. He added that the previous owner had family issues and was not at the business. He stated that he will be at the premises all the time.

Appearing with the Licensee:

- B. Hazem Amro 2231 West College Avenue stated he is in the new manager and he started working November 3rd. He added that he has the safe food handler certification and the violations came because they're trying to improve the inside. He added that he's working to improve and change the premises and he used to work at Fryerz as a manager.
- C. Mel Shy, 2526 West Burleigh Street stated the people in the risk control program are not present today. There was a change in ownership at the end of July, beginning of August and they're trying to catch up with everything that was in place from the previous owners. She added she was just hired as a manager in September.

Individual also present:

- D. Claire Evers, Health Department stated there were 27 food safety violations on the routine inspection in October of 2018. She added there were 4 complaints, and a compliance conference was required to assist the premises with gaining and maintaining compliance. She added in August 2019 there were 7 more food safety violations, and last week there were an additional 14 food safety violations which required the premises to be closed. She stated the manager on site had no idea what the risk control plan was. She added the complaints were verified pest issues.
- E. She stated the November 7th inspection included the following violations:
- F. WHEN TO WASH: Employee observed not washing hands before putting on clean gloves.
- PACKAGED AND UNPACKAGED FOOD-COVERED CONTAINERS OR G. WRAPPING: Raw fish in the walk-in cooler and cooked chicken in the 2-door prep cooler were observed to be unwrapped or uncovered.
- FOOD CONTAMINATION PREVENTED FROM PREMISE OFF THE H. FLOOR: A box of bakery items being stored on the floor in the walk-in cooler.



- I. THAWING: Raw chicken wings are being improperly thawed by holding at room temperature in the wash and rinse compartments of the 3-compartment ware-wash sink.
- J. EQUIPMENT AND UTENSILS – GOOD REPAIR: The soft serve machine and the flat top grill are not maintained in good repair. The soft serve machine is not functional and has a foul odor inside. There is a gap between the flat grill surface and the back grill wall, which allows grease to leak onto the stainless steel table underneath. There is a grimy cloth on the stainless steel table to absorb grease.
- K. FOOD CONTACT SURFACES – SANITIZED BEFORE USE AND AFTER CLEANING: The cutting board and food prep table in the kitchen area are not being sanitized before use and after cleaning.
- UTENSILS, EQUIPMENT AND LINENS STORING PROHIBITIONS L. CLEAN DRY LOCATION: Single service containers are improperly stored on a shelving unit below an exposed area of ceiling where they are subject to dust, debris and insulation.
- PLUMBING SYSTEM MAINTAINED IN GOOD REPAIR: The plumbing is M. not maintained in good repair. The water to the prep sink and mop sink is not working. The air gap below the prep sink is being covered with a plastic bag due to its foul odor.
- N. HAND DRYING PROVISION: No single-use toweling or other hand drying device available at handwashing sink in food prep area or employee rest room for hand drying.
- O. CONTROLLING PESTS – INSPECTING PREMISE: Mouse droppings were observed in and on bag of flour in the kitchen.
- P. STORING MAINTENANCE TOOLS: Maintenance tools and a step ladder are improperly being stored on and next to two food storage shelves that have singleservice items on it.
- Q. TOXIC SUBSTANCES – IDENTIFYING INFORMATION, PROMINENCE – COMMON NAME - WORKING CONTAINER: Working containers of degreaser are not labeled with contents.
- R. TOXIC SUBSTANCES – STORAGE: Can of insulating foam sealant in food prep area is stored touching container of single-use gloves and above the freezer; and the premises did not have a valid food dealer license because it had expired 3 days prior.
- S. Alderwoman Coggs asked why the applicant did not apply for a change of ownership when he took over in July. She stated that the health reports are



horrible and they're putting people's lives and safety at risk because of the bad food management. She added that she has heard nothing from the applicant about a plan to change this and as recently as 4 days ago there were still violations. Ald. Coggs additionally observed that the violations referenced in Findings F –R above occurred while the business was unlawfully operating with no license. She stated that based on the volume and danger represented by the violations, she could not conscionably support a renewal.

- T. Alderman Kovac stated the premises were operating in a dangerous way, and they did not have a license and knew they did not have a license.
- U. Alderwoman Coggs moved denial based on Health Department reports, operating without a license, and applicant testimony. (Prevailed 5-0)

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 68, 82 and 85 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Shadi M. Alkhawaldeh who holds Extended Hours Establishments and Food Dealer licenses Renewal Applications with Change of Agent and Stockholder for the premise located at 2100 West Hopkins Street in the City and County of Milwaukee, Wisconsin ("Haji's Red Hot") has not met the criteria of Chapters 68, 82 and 85, of the Milwaukee Code of Ordinances to not renew the Extended Hours Establishments and Food Dealer licenses. The Committee finds the health department reports and aldermanic objections as stated above to be true. The Committee based its recommendation on the Health Department report, operating without a license and applicant testimony.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Extended Hours Establishments and Food Dealer licenses Renewal Applications with Change of Agent and Stockholder for the premises located at 2100 West Hopkins Street in the City and County of Milwaukee, Wisconsin ("Haji's Red Hot"). The Committee based its recommendation on the Health Department report, operating without a license and applicant testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) recommends that the Extended Hours Establishments and Food Dealer licenses Renewal Applications with Change of Agent and Stockholder held by Shadi M. Alkhawaldeh for the premises located at 2100 West Hopkins Street in the City and County of



Milwaukee, Wisconsin ("Haji's Red Hot") not be renewed based on the Health Department report, operating without a license and Licensee testimony.

- 1. Shanita M. Cotton (hereinafter "the Licensee") is the holder of Class "B" Tavern and Public Entertainment Premises (PEP) Licenses for the premises located at 2911 West North Avenue in the City and County of Milwaukee, Wisconsin ("T Jay's Lounge"). Said licenses expire at midnight on December 4, 2019.
- 2. An application to renew said licenses was filed with the Office of the City Clerk on September 25, 2019.
- 3. Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. October 29, 2019, the Milwaukee Police Department responded with a report that could form the basis for nonrenewal of said licenses.
- 4. On November 7, 2019, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the neighborhood objections. The matter was scheduled for a hearing on the objections on November 12, 2019, commencing at approximately 1:15 p.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - Α. On January 1, 2018 officers were dispatched to an Entry complaint at 2911 West North Avenue. The officer was met by a security company that had an open front door. The officer searched the building and found nothing out of the



ordinary. The investigation determined the employee had left the door unlocked when they left for the day.

- B. On May 28, 2018 officers were dispatched to a Shotspotter call at 2929 West North Avenue. The officers went to 2911 West North Avenue to check for witnesses. The spoke with the manger, Kevin Barnett, who stated he did not hear any shots and would be closing the bar for the night.
- C. The Licensee has the following past due fines owed to Milwaukee Municipal Court:

13034224 Building Code Violations \$950.00 due 11/10/2017

- D. On June 21, 2019 at 1:35 a.m. officers were dispatched to T-Jay's Lounge, 2911 West North Avenue, for a tavern violation. The caller stated his 15-year-old-sister was in the bar and there were subjects smoking marijuana. The officers checked the ID's of the patrons and did not find anyone underage. No violations observed.
- E. On June 28, 2019 officers were dispatched to T-Jay's Lounge, 2911 West North Avenue, for a property damage complaint. The officer interviewed the victim who stated she was inside T-Jay's from 1:30 a.m. to 1:50 a.m. When she came out her car door window was broken and items missing. The victim was found to be 20-years-old. The officer interviewed the manager and the door man who stated they did not let anyone underage in the bar. The applicant was issued a citation for Allow Underage on Premise.

- F. On July 1, 2019 at 1:09 a.m. officers were dispatched to a subject with gun in the area of T-Jay's, 2911 West North Avenue. The officer spoke with the caller by phone, who stated a security guard had brandished a firearm. The caller was uncooperative and hung up on the officer. The officer went to T-Jay's and spoke with the manager, Kevin Barnett. He stated nothing out of the ordinary happened that night. The staff was very cooperative with the officers.
- G. On August 25, 2019 at 2:20 a.m. officers were dispatched to North 29th Street and West North Avenue for a shotspotter call of over 30rounds fired. The officer interviewed the manager of T-Jay's, 2911 West North Avenue. He stated they had no problems that night and were closing at 2:15 a.m. when they heard shots fired from a vehicle on the street. He provided video which showed



- a vehicle exit the parking lot to the west of T-Jay's and pulled up to another vehicle on the street. One vehicle fired at another and both fled. One of the vehicles fleeing struck a parked car, flipping it on its side.
- H. On September 3, 2019 at 1:08 a.m. officers were dispatched to T-Jay's lounge for a wanted subject. The subject was located and arrested without incident.
- I. On September 8, 2019 at 1:17 a.m. officers conducted a licensed premise check at T-Jay's Lounge, 2911 West North Avenue. The officer observed more than 80 cars in the area and conducted a capacity check. The door man stated he thought capacity was 136 and they had about 120-130 patrons. The officer checked and found capacity was 80 people. The bar was closed and all subjects were counted as they exited and the officer counted 213 people, which included employees. The investigation also revealed the bar was charging a cover charge, which was not posted and was serving food without a food dealer license. The manager stated they did not need a food dealer license because they were giving the food away. The Licensee was cited for the violations.
- J. On September 22, 2019 at 1:18 a.m. officers were dispatched to T-Jay's Lounge for a tavern violation. The caller stated there were several underage people inside the bar. The door man stated he knew the officers would be coming because he had turned away female with no ID. The officers checked the bar and did not locate anyone underage.
- K. On October 4, 2019 a meeting was held at District 3 regarding T-Jay's Lounge. The Licensee stated she is not involved in the daily business, her husband Kevine Barnett, runs the business. She stated she was unaware of several of the incidents at the business. She was advised of the recent incident on September 8, 2019 and the possible citations. She was advised to use a counter, post signs and prices and monitor patrons at close. She stated she would advise Barnett of the information provided.
- L. The applicant stated she hired more security, installed more lights in the parking lot, has a counter to keep track of capacity, and they do not give out food anymore.

Individual also present

Dameon Ellzey 15th District Legislative Assistant stated he has witnessed M. unruly patrons outside the premises and the police report speaks to that with the shootouts. He added that there was video on Facebook of a fight outside the premises. He stated the Licensee is taking measures to fix issues, such as meeting with District 3, but they need some time to reevaluate their crowd and who they are advertising to. He added the applicant needs to be more involved in the business. He added Alderman Stamper recommends a suspension of 15 to



- 30 days to get back to reasonable operations because the last 6 months have been problematic for the location.
- N. Alderwoman Dodd stated the applicant needs to be more involved in the day-today and the police report is concerning. She added the applicant needs some time to come up with an action plan in writing that she can share with Alderman Stamper.
- Alderwoman Dodd moved approval with a 15 day suspension based on the O. police report and aldermanic and applicant testimony. (Prevailed 5-0)

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 85, 90, 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin State Statutes.
 - 2. Based upon the above facts found, the Committee concludes that the Licensee, Shanita M. Cotton who holds Class "B" Tavern and Entertainment Premises (PEP) licenses for the premise located at 2911 West North Avenue in the City and County of Milwaukee, Wisconsin ("T Jay's Lounge LLC") has not met the criteria of Chapters 85, 90, 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin State Statutes, to not renew the Class "B" Tavern and Public Entertainment Premises (PEP) licenses without undergoing a fifteen (15) day suspension. The Committee finds the police report and aldermanic objections as stated above to be true.
 - 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class "B" Tavern and Public Entertainment Premises (PEP) licenses without undergoing a fifteen (15) day suspension for the premises located at 2911 West North Avenue in the City and County of Milwaukee, Wisconsin ("T Jay's Lounge LLC"). The Committee based its recommendation the police report, applicant and aldermanic testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Shanita M. On October 30, 2019 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 85 and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on November 12, 2019 at 1:00 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee appeared and admitted receipt of the notice of hearing.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Pablo Macias, 642 South 9th Street, #1, Milwaukee, WI 53204 on October 30, 2019 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 642 South 9th Street, #1, Milwaukee, WI 53204 is the address given by the Licensee on his application. The envelope was not



returned to the License Division by the United States Postal Service. The Licensee appeared at the hearing on November 12, 2019 at 1:00 p.m.

On October 18, 2018, the Licensee was charged in Milwaukee County for В. Operating While Intoxicated (3rd) (Misdemeanor)

C. The applicant stated the first 2 offenses were over 6 years ago. He added he was celebrating his friend's birthday and he drove to see his girlfriend because it was easy, but apologizes for the mistake. He added that he needs money because he owes child support and money to the City. He stated that he currently works parttime at Chivas Bar.

License Division staff appeared with the Licensee as his interpreter.

- D. Alderman Kovac stated the first two offenses were a while ago, and the applicant made a mistake in July and has apologized for it.
- E. Alderman Kovac moved approval with a 10 day suspension based on the police report. (Prevailed 4-0-1)

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the Licensee, Pablo Macias has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapters 85 and 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license without undergoing a ten (10) day suspension.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Operator's license held by Pablo Macias without undergoing a ten (10) day suspension.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above the Committee recommends by a vote of four (4) ayes, zero (0) noes, and one (1) abstention that the Class "D"



Operator's License of Pablo Macias not be renewed without undergoing a ten (10) day suspension.

The suspension is in effect between 12:01 a.m. on January 1, 2020 until 11:59 p.m. on January 10, 2020.
