*Terry Beede, 3125 N. 79th St., is concerned about the potential involvement of the husband of the applicant since the applicant does not have a lot of experience with the business.*

*Barbara Marshall, 3142 N. 80th St., is afraid that the applicant does not have a business plan and is not responsible.*

*Kelly Ehlers, 8000 W. Auer Ave., is concerned about traffic and parking problems as well as who is going to be running the establishment.*

*Betty Heiden, a member of Capitol West Neighborhood Association, says that the association is not in favor of a jazz club or a sports bar at the location. She also says that she is against the liquor license, not a restaurant, because of crime in the area.*

*Nancy Runner, 3230 N. 82nd St., is opposed to the liquor license.*

*Richard Heil, 7718 W. Burleigh, manager of Mama Mia's, says that when they opened the establishment, the restaurant was required to buy a parking lot. He is concerned about traffic and parking.*

*Lucas Mackler, 3241 N. 80th, is concerned about parking and traffic. He is opposed to the liquor license.*

*Carrie Urban, 3222 N. 79th St., is opposed to the license.*

*John Stocks, 3139 N. 80th St., is opposed to the license.*

*Larry Danner, 3169 N. 80th St., is opposed to the license.*

*Carol Worthan, 3121 N. 80th St., is opposed to the license.*
