I feel the City's procedure was improper due to the following reasons and I have attached any supporting evidence, including city employee's names/dates which I spoke to regarding this issue and copies of any city orders received:

The waste was primarily weeds that were bagged up from a complaint filed by a neighbor that I was taking care of removing. I set the waste to the far section of my lawn while waiting for my brother to come help me take to the dump. It was not left at alley side or in city trash bins. The initial notice was sent to my tenant at 2021 who failed to forward to me at 2023. The second notice on 10/2/2025 was taped to my door. I took all waste to the city dump on 10/3/2025. I failed to call within 24 hours of notice, because I misread the notice. I thought reinspection would happen and see it was gone within 24 hours. I was told the bill was for the contractor however, the city never had to remove the waste, I did at my expense, and within 24 hours of getting the notice. Signature


