in such a way that discredit could be brought upon the department.

Core Value 5.00 – Respect, referencing Guiding Principle 5.01: Failure to  
be courteous and professional.

The charges having been substantiated, she is found guilty as charged  
and the penalty adjudged appropriate by the Chief of Police is as follows:

Failure to cooperate with

Ten (10) day suspension  
without pay.

Behaving in such a way that

the department.

Ten (10) day suspension  
without pay.

Failure to be courteous and  
professional.

Fifteen (15) day suspension  
without pay.

It is hereby ordered that POLICE OFFICER DARCIE J. TRUNKEL be suspended for a total of thirty-five (35) working days without pay. If not appealed, said suspension is to be served during the following periods: January 31, 2021 through February 13, 2021; March 1, 2021 through March 13, 2021; March 28, 2021 through April 3, 2021; and April 12, 2021 through April 24, 2021.
