Dear Attorney Cermele:

I write concerning the above listed matter, which I have been looking into diligently for a short time now. Unfortunately, I have not received responses to several letters I sent out and to date none of the complainants has identified any particular person as having committed the claimed offense(s). I write to inform you, thus, that I am not able to issue charges at this time.

It is possible that things could happen that would change this in the future, though. First, videotapes which I have been told exist could be produced. Second, there is a misdemeanor case against one of the complainants which I believe is scheduled for a status in December which I intend to monitor. It is possible, but unlikely, that testimony in that case could have an impact here. As of right now, though, I have determined that there is no evidence to proceed against any particular person.
