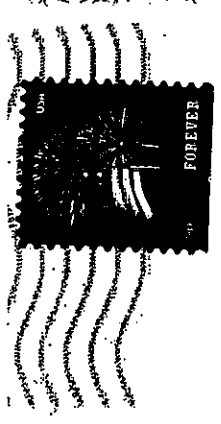

I am requesting to be reimbursed for the damages I accrued at my property on February 11, 2014 at 2464 N 34th St. Due to the city's pipe bursting in front of my property, water flowed into my basement filling it with two feet of water. Due to that I had to hire a company to soak up the water, dry out the basement, and tear down two feet of drywall and insulation. However, I also lost many of my personal items, such as a bed, refrigerator, dryer, furniture, clothing, books, supplies, and the list goes on. I also had to have the furnace and washer serviced; water heater replaced. On top of the losses, I had to hire contractors for repairs and removal of debris. I am asking for the city to reimburse me for the thousand dollar deductible I had to pay my insurance company to restore the basement and replace some of my items. 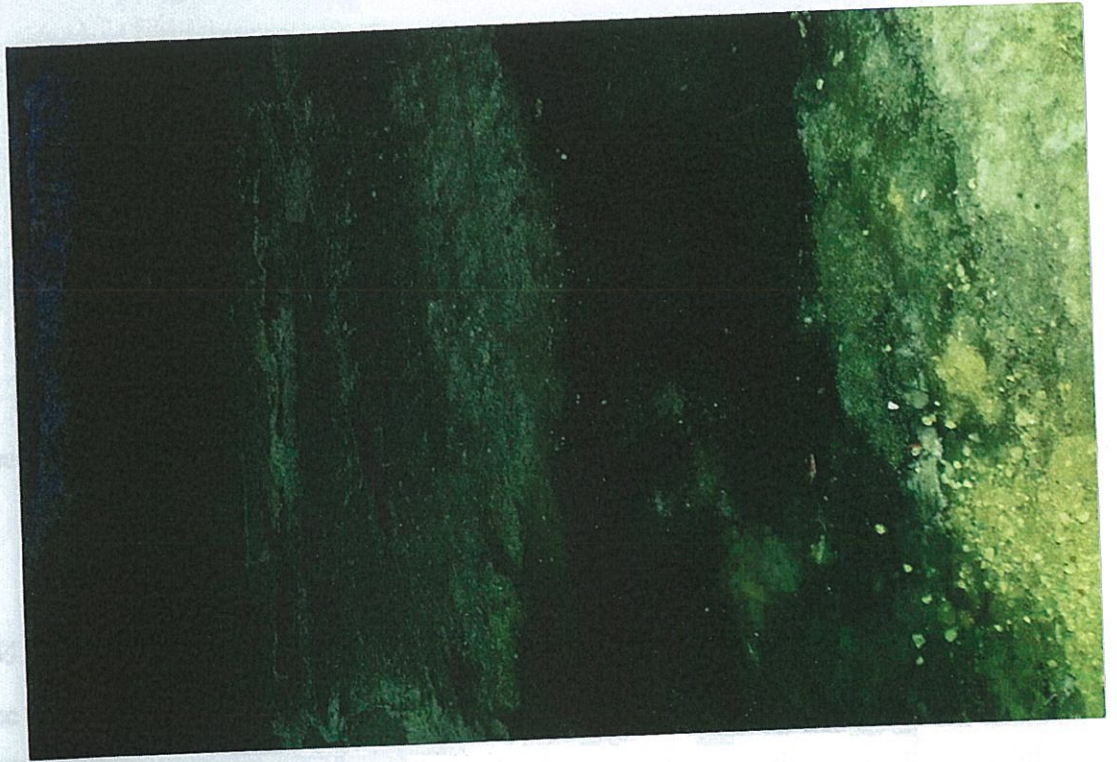

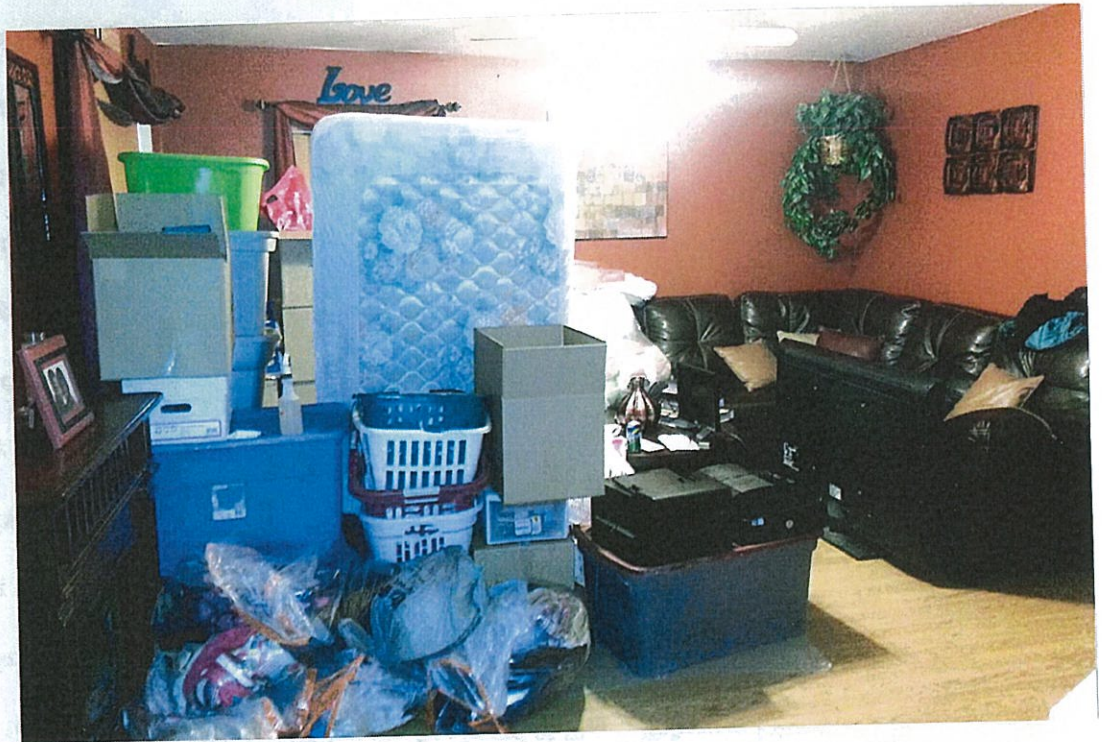

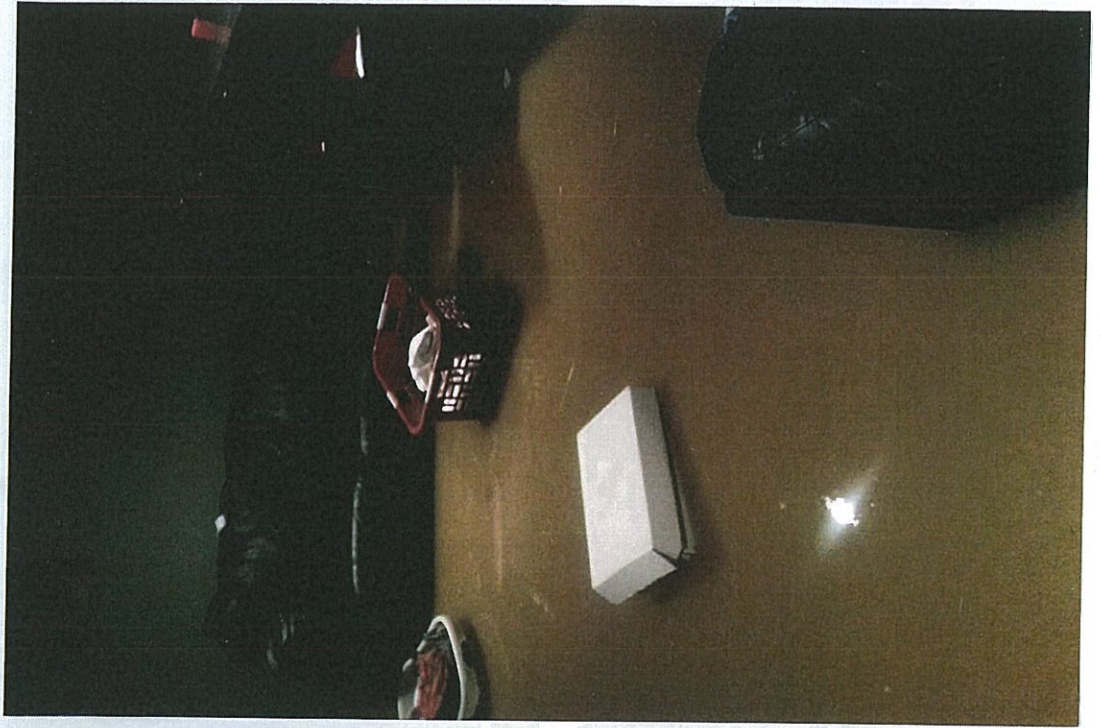
