HERZOG stated that he and BONEY were arguing in the alley of the location and that BONEY assaulted him. However upon speaking with BONEY and some hotel staff, they stated that it was not true and that BONEY was keeping HERZOG from approaching him. Both parties came to a positive conclusion without further incident. The battery was determined to be baseless. It should be noted that this incident occurred in the alley of the Days Inn & Suites and not on the premises.

I did not observe any violations on the hotel property and all the City of Milwaukee licenses were current at the time of this investigation.
