Dear Ms. Vara-Ramos:

We have received your claim in the amount of \$71.96, relating to damage sustained to your vehicle's tire rim on September 28, 2005 when it collided into a pothole, located at South Cesar E. Chavez Drive and West Lapham Boulevard.

Our investigation reveals that the Infrastructure Services Division records from September 28, 2004 to October 15, 2005 indicates that they conducted asphalt patching at the intersection of South Cesar Chavez Drive and West Lapham Boulevard on one occasion during this period. On September 30, 2005 a Street Maintenance crew patched with asphalt a pothole in the roadway at 1600 South Cesar Chavez Drive. Their records also indicate that between September 28, 2004 and October 15, 2005 they received one complaint for this area. On September 28, 2005 at 1:24 p.m. the Call Center received a call about a pothole in the roadway at 1600 South Cesar Chavez Drive. A Street Maintenance crew patched this location on September 30, 2005. When the division is notified of any hazard in the roadway, sidewalk or alley they will send a crew to investigate and/or patch the hazard. Prior to this, the City had no notice of this hazard in the roadway and because of this lack of notice; the City would not be liable. Therefore, we are denying your claim.
