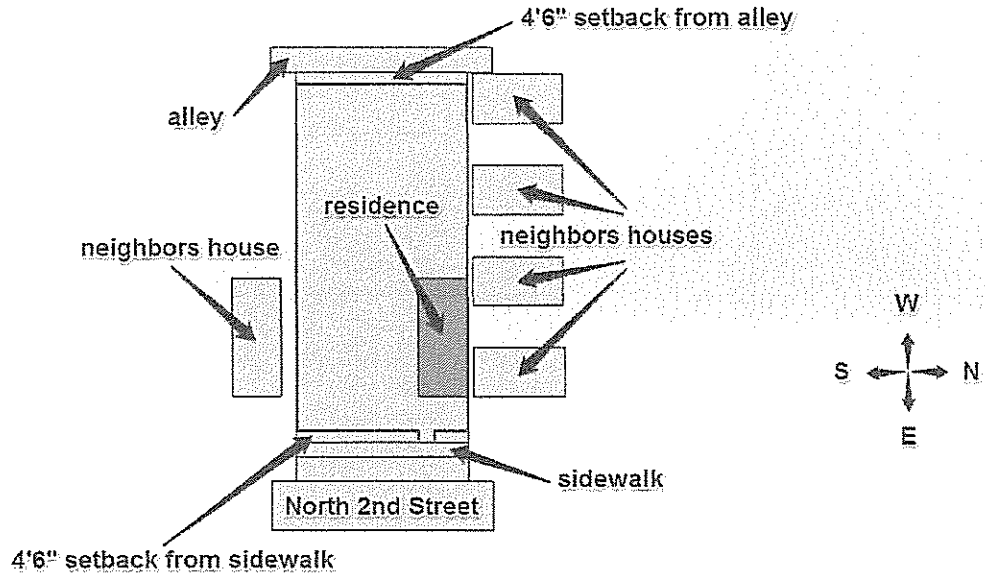

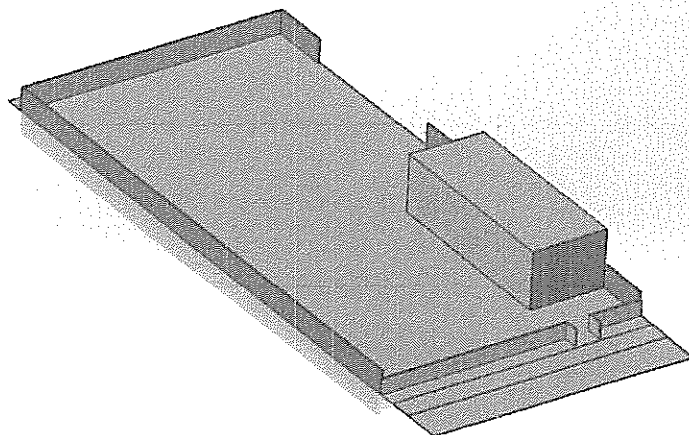

Rear Fence is in RED

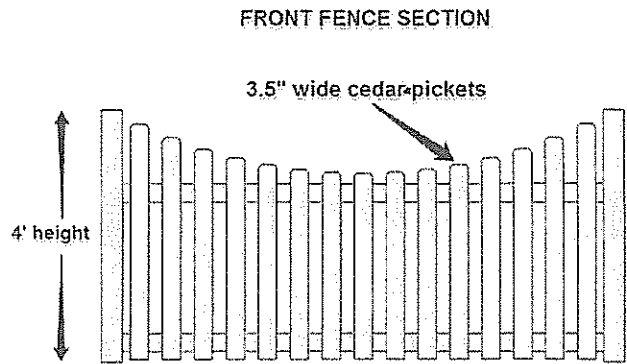
Side Fence is in BLUE

Front Fence is in Green

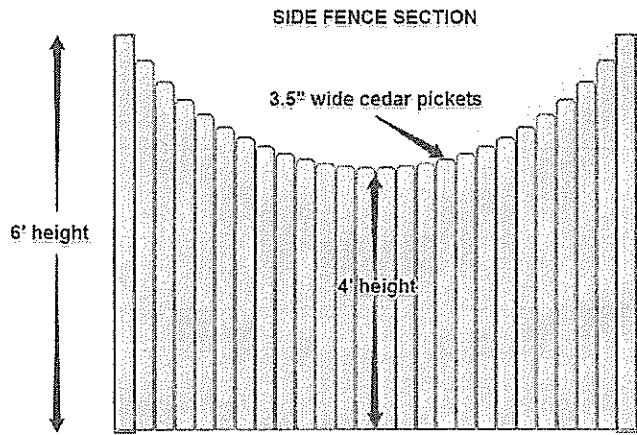

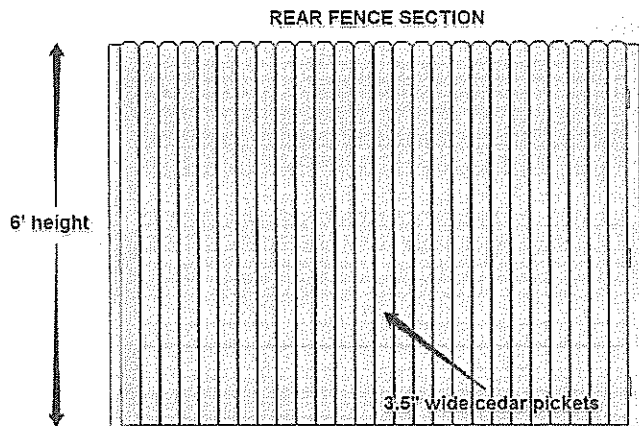
Fence Style for Historical Approval



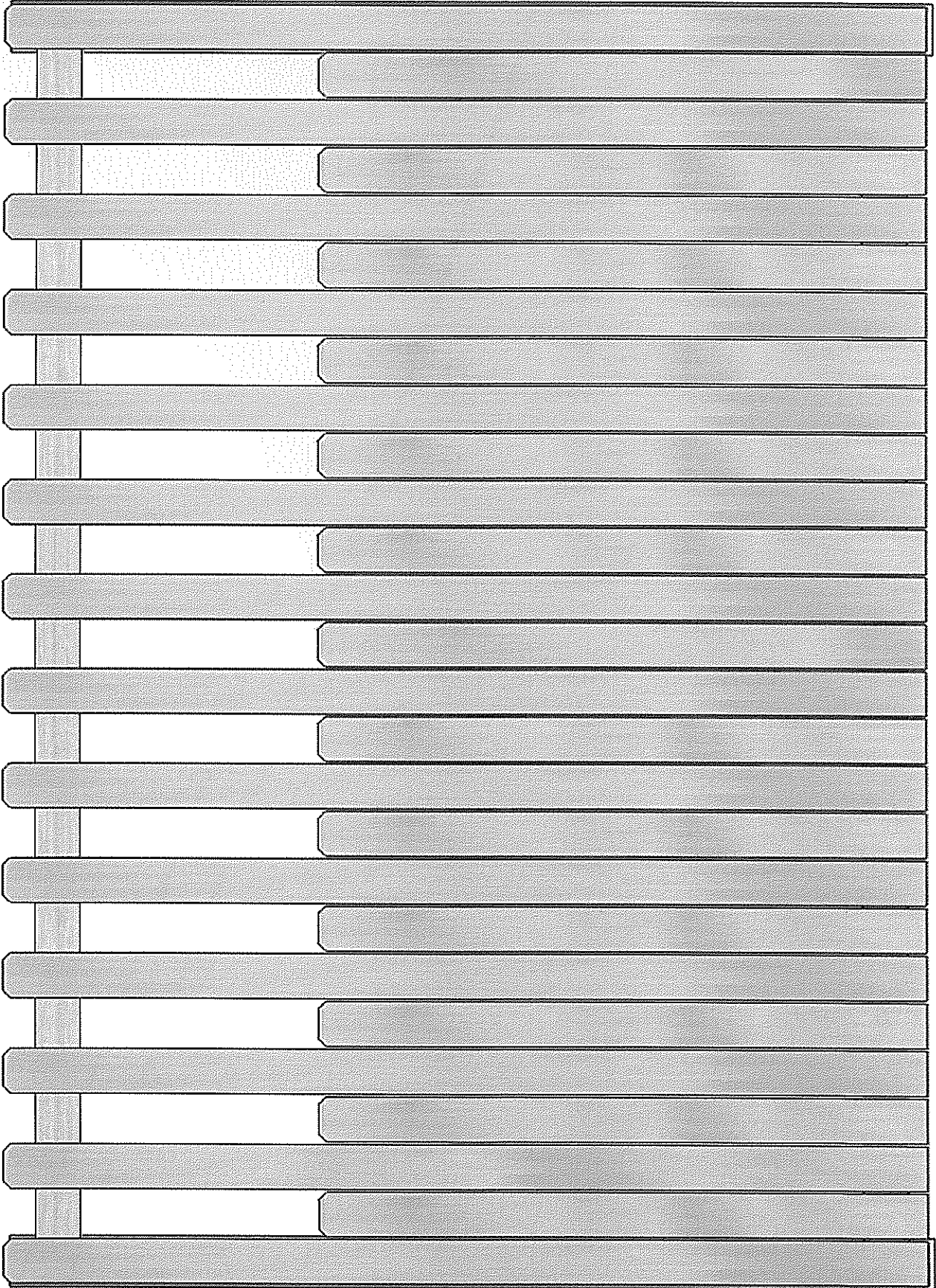
= See Green on Map
