Dear Mr. Leonhardt:

Please allow this letter of correspondence to serve as an objection to the revocation hearing on October 30, 2006 regarding All Star Spots Bar, located at 4001 W. Fond Du Lac Avenue and licensee, Kent L. Parker.

I trust that the motion to deny this revocation was solely based on the testimony of the victim and the police report taken on July 29, 2006. The police report reveals several inconsistencies as it relates to the victim's testimony. Yet, several other factors were present.

The victim did appear and did identify the assailant the night of the shooting. The victim informed all members of the committee who shot him 4 times, in addition, testified before the committee that the confusion in the police report was a result of his friends fear of be incarceration. Please note, the night of the shooting-the officers arrested the individuals that transported the victim to the hospital. The Milwaukee Police Department started off on the wrong foot; therefore, it is partially understood why the stories were an attempted collaboration of a car jacking.

Most disturbing, Alderman Willie Wade investigated this story himself. Mr. Willie Wade had a one-on-one conversation with Mr. Kent Parker and Mr. Kent Parker revealed that he was in fact, the shooter on July 29, 2006. Mr. Willie Wade encouraged Kent Parker to do the right thing. Needless to say, at the hearing and in the district attorney's office, Kent Parker failed to take responsibility of his actions.


This letter has four major purposes: 1) to serve as an objection to the licensing committee's denial to revoke Kent Parker's liquor license. 2) To allow an opportunity for Willie Wade to rethink his position of integrity, morals, and sound judgment relative to fully knowing Kent Parker enacted a recklessly endangering the safety of another **OR** take a polygraph to exclude himself as a direct witness. 3) To permit the full common council to hear this criminal and violent incident that took place in this city and no justice enacted upon the identified shooter. 4) To inform the public and Kent Parker that repercussions will be investigate thoroughly when you break the law; as opposed to your elected official will cover for you.
