Our traffic engineering staff has investigated this request and found east and west bound motorists on East Newport Avenue have a difficult time seeing traffic traveling north and south bound on North Oakland Avenue when vehicles park close to the corner. Therefore, in the interest of public safety, we recommend installing these restrictions to increase cross traffic visibility at the intersection.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
