Street. My family has been on the street for over 70 years. We still

and a large investor

in the neighborhood including a larger future development that I have been working on. I have never objected to a liquor license personally although the BID did not support the license for Tropics. I vehemently oppose this license for Pass me da Hookah, this is not wanted or needed on the street. We have many issues on Brady currently and for the past 3-4 years we have pleaded with MPD to provide us with more police. They say they cannot and we are suffering the consequences. On a nightly basis we are being pushed to the limit by unruly crowds, many who are not patrons but just people who come to the street to party. We are left picking up the pieces day after day. I have heard from many neighbors and tenants who want to move away. The issue is not getting better, in fact it's getting worse. More crime than I have time to mention. We have never considered moving out of the area but I can say with certainty if this keeps getting worse we will be. The Brady Street BID did not support the liquor license for Tropics whose business model was basically to-go cocktails and somehow that got approved. How can we have a business improvement district with nat want to improve the street and our recommendations are not being heard? What is the point then? This is not a time to approve liquor licenses anymore where there is really no skin in the game. Meaning someone leases a small space, does minimal improvements and pretends they will sell food. Please hear us on Brady. At this time, especially with the lack of police, we do not want or need this. Thank you.

The hearing before the Licenses Committee will take place on 11/7/2023 at 2:15 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.




