If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 10/05/23 at 12:45a.m., Milwaukee Police were dispatched to a Property Damage at 1955 W. Capitol Dr. Investigation revealed this was not a property damage. A subject was determined to be in mental health crisis and requested to be transported to MCMH.
- 2. On 11/02/23 at 9:52p.m., Milwaukee Police were dispatched to a Battery at 1955 W. Capitol Dr. Investigation revealed a customer was angry over a refund for food they already received and jumped over the counter and enter the cashier area. The employee and the customer got into a shoving match, before the customer was eventually escorted off the premise. The business was cooperative with the investigation and allowed officers to view video surveillance.

The listed items are Milwaukee Police Department calls for service to 1955 W. Capitol Dr., JJ Fish and Chicken.

3. On 07/05/24, at 10:59 p.m., Milwaukee Police were dispatched to a Robbery complaint. The victim stated an unknown subject took their property, threw the items in the parking lot and walked away. Security cameras were checked finding the robbery complaint to be baseless. While on scene and confirming the posted license information, officers found the business to be operating after the plan of operation time. The manager was advised.

- 4. On 10/04/24, at 8:30 p.m., Milwaukee Police were dispatched to a Property Damage complaint. A customer was belligerent to an employee, broke a glass off the hinge, and took food without paying. No business violations were observed.
- 5. On 10/20/24, at 8:42 p.m., Milwaukee Police were dispatched to a Threat complaint. Two subjects were in the business smoking, refusing to leave, and threaten to fight an employee. The subjects were gone upon officers' arrival. No additional action taken.
- 6. On 02/08/25, at 10:31 p.m., Milwaukee Police were dispatched for a Threat complaint. A subject ordered a 3-piece meal and requested additional items for free, which an employee refused to give them. The subject attempted to jump the counter and take items, while threating to beat-up the employee.
- 7. On 05/21/25, at 9:46 p.m., officers were dispatched to a Threat complaint. An unknown subject entered the business sat down and demanded food for free, which an employee refuses to give them. The subject removed a credit card reader from the counter top, cut the cord, and left with the card reader. Security footage was reviewed by officers. The damage was estimated around \$150.00 and the subject was not located.
- 8. On 06/15/25 at 12:10a.m., Milwaukee Police conducted a License Premise Check at 1955 W. Capitol. On arrival officers found the business to be open and operating, despite the business not having an Extended Hours License. The manager was notified of the violation via telephone. Further the officers observed the licenses were not posted or readily available.

This report is written by P.O. Chad Wilson assigned to Dist. Five Late Power Shift. On Friday 07-05-24 at 10:59 pm Sqd. 5490 P.O. Wilson was dispatched to a Robbery complaint at 1955 W. Capitol Dr.

Upon arrival I interviewed the victim, Antroine D. Grayson (b/m 07-27-71) who stated on 07-05-24 at 10:14 pm he was in the enclosed foyer of JJ fish restaurant at 1955 W. Capitol Dr.. Grayson stated at that time he was talking out loud to himself making rude comments, when an unknown black male unknown age unknown height overheard the comments. Grayson stated the unknown black male thought he was talking to him, so the unknown black male grabbed his belonging that was on the floor and threw it into the parking lot and walked away in an unknown direction.

I told Grayson that I would check the video cameras at JJ's Fish restaurant, Grayson then became uncooperative and refused to give any more information.

I spoke to the manager, Abdelmoghit Elhmaini (A/m 06-01-66) OF JJ's Fish restaurant, who arrived at 11:55 pm. Elhmaini let me look at the video in the store, but there was no video of the incident.

While on scene, at around 1:16 am I observed the licenses were posted on a pin board but there were posted notes on the license covering the operation days and times. I removed the posted notes which revealed the license was up to date, but the operation times were Sunday through Saturday 10:30 am to 12:00 am. I observed the employees taking customer's orders and serving them their food and beverages after the time they are licensed to be closed. I asked Elhmaini why they are still open and serving customers at 1 am and he showed me a flyer showing they are open until 2 am. I told Elhmaini he has to follow his licensed operation days and times and not stay open beyond those times. I did not issue any citations at this time.

Upon our arrival, I observed I observed a male exiting the restaurant and people looking from inside of the business outside. I also observed one worker at the register behind the counter.

I spoke to the caller, identified as Usman ANSARI (W/M, 07/07/1999), who was the employee. They stated a male entered the business and ordered a 3 piece chicken meal and wanted to add more items but did not have enough money. The male tried to get ANSARI to give him the items for free and got upset when ANSARI denied that request. ANSARI stated the male attempted to jump the counter and steal the food. ANSARI also stated the male threatened to beat him up, and that's when he called police.

The business was cooperative with the investigation.

The business had 0 security officers on scene.

This report is written by Police Officer Shelisa CARSON, assigned to District 5, Early Shift, Squad 5221.

On Wednesday May 21, 2025, my partner PO Brendan FAHEY and I were dispatched to a Threat complaint at 1955 W. Capitol Dr. located in the City and County of Milwaukee.

Upon arrival, I observed multiple people in the restaurant as well as a pile of envelopes on the ground in the restaurant. PO FAHEY and I spoke to the worker who stated there was an incident with a customer. The worker was identified as Hamza AIT YOUNS (U/M, 01/16/1996). AIT YOUNS stated a male subject came into the restaurant and asked about the food and then sat down. AIT YOUNS stated the male then asked if he could get a free carrot cake and AIT YOUNS told him no. AIT YOUNS stated the male then sat down again and demanded he give him a free carrot cake because he was the police and flashed what AIT YOUNS believed to be a badge. AIT YOUNS stated after telling the subject no, he believed the male was going to assault him so he closed the sliding window. AIT YOUNS stated the male then got upset and pulled the credit card reader and cut the cord. AIT YOUNS stated the male then sat down for a bit before leaving the establishment with the card reader.

Video Footage

PO FAHEY and I observed the video footage from this incident. The video showed a dark brown black male, wearing a black baseball cap with white writing, a red Chicago Bulls jacket, black pants and black shoes. This male entered the business at 21:48 and sat down at a table right away. The male appeared to

be opening up pieces of mail. The male then got up and was speaking with the worker. The male briefly left and came back in and was point at the case that held all of the desserts. The male was seen standing at the window in front of the worker and the worker closed the sliding window. At 21:53 the male was seen pulling on the credit card reader, causing the computer to behind the window to fall. The male was then seen cutting the cord and walked away to the table he was sitting at with the card reader. The male sat at the table messing with the papers until 21:59 when he left the business with his papers and the card reader.

End of footage.

PO Delia CARRILLO responded to our location and took digital photos of the scene and damages.

Manager Saeed BENHAJ (U/M, 04/10/1986) came to the location and allowed officers to view the video footage. BENHAJ estimated the cost of damages to be approximately \$150.

PO FAHEY and I searched the area for the subject but di not locate him.

No further information.
