scheduled to come to my property, I also want to add that I purchased a spray to revove the weeds and applied it within 3' days of receipt of the notice. The weed killer did not have great results. None of the weeds were at a height to impede traffic. In fact, I have parked My vehicle in the spot where they grow to put things in my garage. I do not drive a truck or large SUV and was easily able to park 2 wheels on this Small stretch of my property; the area is not big enough to fit a full vehicle. I pay someone to cut My grass in the summer, as well as clean my gutters and take care of other maintenance as My physical condition inhibits my ability to do so. Yes, weeds grow along the tenceline but they were not out of control or causing anyone (myself included) a problem. If you were to fine and punish every residence that has some burdocks and thistles along their alleyway, the city would have all the Money it could ever desire. I am astonished by the auount of this fine as whoever Mowed over the section in question did about a 10 inch wide strip along the approx 15 ft. fenceline. It probably took a city employee with a riding mower about 30 seconds. How that results in a \$303.57 fine is inconceivable. I lovingly Maintain My property and request this decision be overturned. I dispute that the weeds I) were impeding traffic and 2) were impeding lighting. There are NO trees, shrubs, or flowers in this part of my property. Just some weeds. Thank you for your consideration.
