I am not available for any hearings during the week. I teach for a living, and I would have to dismiss my class or call for a substitute, which my supervisor will not approve of. Surely, an appeal for \$499 can be reviewed without my presence. You have a thorough letter detailing what happened, and either you are going to pay, find the contractor responsible and notify them, or you will decline.

Just to substantiate my contention everyone simply wants to pass the blame; the initial denial letter by Mr. Carini relays possible fault or blame from Stark Construction. I did a interview with their insurance representative Jared Fleisch, who also reviewed my letter. Yesterday, I received a letter from Stark Construction's insurance company QBE, denying any liability. They state they did not cause the pothole, nor were they provided prior notice of a pothole. Additionally, they were not contracted for that area of Capital Drive; whereby, I incurred damages. Lastly, they relay possible liability with traffic redirection services by Q3 Contractors.

I have no concept of who or what is Q3 Contractors; however, I'm sure if we notify them, they will say they are not liable either; place the blame on you or someone else.
