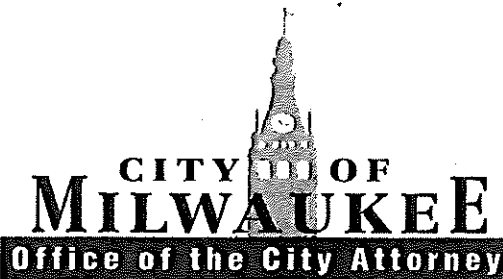

We have received your claim in request to dispute a citation and tow, regarding a 2024 Hyundai Elantra that was rented in your possession and towed on January 19, 2025, to the city tow lot.

Your claim indicates that the subject vehicle was towed on Sunday, January 19, 2025, as requested by a neighbor, who attempted to reach you without success.

Our investigation determined that the subject vehicle was issued a parking citation and subsequently towed due to obstruction of another vehicle. There is no evidence that the city is negligent and your claim is denied.

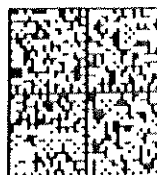
