FOURTH AMENDMENT TO CONTRACT FOR LEGAL SERVICES BETWEEN

CITY OF MILWAUKEE, WI

AND

AMUNDSEN DAVIS, LLC

THIS AMENDMENT to the contract between the City of Milwaukee (the "City") and the law firm of Amundsen Davis, LLC, the successor to Davis Kuelthau, S.C. (hereinafter "LAW FIRM"), is made and entered into by and between the City and the LAW FIRM.

WHEREAS, on March 3, 2020, the City and the LAW FIRM entered into a contract to provide legal services for City of Milwaukee Alderman Robert Bauman in the Wisconsin state court action entitled *Tri-Corp Housing, Inc. v Bauman*, Milwaukee County Circuit Court Case No. 07-CV-013965, and

WHEREAS, the City and the LAW FIRM entered into a first, second and third amendment of said contract, and

WHEREAS, the parties are desirous of a fourth amendment to said contract to increase the hourly rates as authorized in paragraph IV.B. and the amount of compensation as authorized in paragraph IV.D. of said contract;

NOW, THEREFORE, in consideration of the mutual covenants hereinafter stated, the parties do hereby agree to amend the contract as follows:

- 1. The parties agree that the hourly rates under sec. IV.B. of the contract shall be increased as follows: Lead Appeals Counsel: \$375 per hour; Assistant Appeals Counsel: \$325 per hour; Associates: \$275 per hour; Paralegals: \$200 per hour.
- 2. The parties agree that the not to exceed amount under sec. IV.D. of the contract shall be increased by an additional amount not to exceed \$27,000.00, so that the total payments under said contract shall not exceed \$352,000.00.
- 3. These changes constitute the entire fourth amendment to the contract between the parties. All other covenants, provisions, terms and conditions of said contract shall remain in force unless further amended by mutual agreement of the parties.
