7. On 07/29/2022 officers, along with Agents from the Wisconsin Department of Revenue, conducted a licensed premise check at Citgo, 3708 W North Av. The officers spoke with the manager about suspected drug dealers loitering in the parking lot for hours at a time and the need for employees to call police when they observe this activity. The officers observed several items behind the counter that are used in the sale of narcotics. The officer advised the manager the items are not illegal to sell but may contribute to these nuisance activities at the store. The DOR agent found tobacco that did not have invoices and confiscated it. The officer advised the manager to have employees call regarding subjects loitering. The manager was cooperative and stated he would be willing to have a meeting regarding the complaints.

8. On 01/26/23 at 12:39p.m., Milwaukee Police were dispatched to an Armed Robbery at 3708 W. North Av. Investigation revealed an employee opened the door to the secure cashier area to enter the store area, when a suspect rushed past the employee to the cash registers and points a firearm at an employee and demands money. The suspect then removes two cash register drawers and removes the money, fleeing on foot. The employees were cooperative and provided video surveillance of the incident.

- 9. On 04/22/23 at 2:40p.m., Milwaukee Police were dispatched to 3708 W. North Av., for an Armed Robbery that occurred on 04/21/23 at 9:40p.m. The employee stated a group of teens came into the store and took items without paying. The employee stated they did not call the police at that time, due to the items not being expensive. The employee further stated at approximately 9:40p.m., the same group came in and attempted to steal items again. The employee stated they remotely locked the door to prevent them from again stealing items. The employee stated one of the teenagers then pulled out a firearm and pointed it at him. The employee then unlocked the door and the subjects fled with stolen items. While on scene 3 of the suspects again entered the store and were positively identified by the victim. The suspects fled on foot, however, one suspect was taken into custody. The employee was cooperative and allowed officers to view video surveillance of the incident.

- 12. On 09/19/23 at 8:34p.m., Milwaukee Police were dispatched to a Reckless Use of a Weapon at 3708 W. North Av. On arrival officers several people standing outside of a vehicle in the parking lot. The employees were cooperative and allowed officers to view video surveillance of the incident. Video surveillance showed a vehicle parked, getting gas, when an occupant of that vehicle, began to walk toward the convenience store. A second vehicle pulls up to a pump and the occupant begins to fire shots at the subject walking. The subject then flees back to the vehicle and all subjects leave the gas station.
- 13. On 11/17/23 at 6:44a.m, Milwaukee Police were dispatched to a rollover crash that caused damage to the property at 3708 W. North Av. The employee was cooperative and allowed officers to view video surveillance of the incident.

On Thursday, January 26th, 2023, at approximately 12:39PM, Squad 3253, P.O. Daniel GONZALES and I were dispatched to 3708 W. North Ave for an armed robbery call for service.

Upon our arrival I observed two victims on scene and two witnesses to the armed robbery that occurred at 3708 W. North Ave. Since this was a major incident additional units arrived on scene to assist: Squad 3217, Sgt Gregory BYERS, Squad 3243, P.O. Luis MADRIGAL and P.O. Jason SPENCER, Squad 9147, Detective Timothy WALLICH, Squad 9142, Detective Mladen DUKIC, Squad 9140 Detective Raena VRTOCHNICK.

I spoke to the caller, Bernado CARDOSO (W/M, 07-14-1996), Phone # 414-539-3139. CARDOSO stated the suspect pointed a black handgun towards him to which he laid on the ground and stated to him "Take whatever you want". CARDOSO stated the suspect took both cash registers totaling at a value of roughly \$1,000 cash. CARDOSO stated the suspect's description is black male, 5'10", medium build, darker complexion, wearing a black ski mask, black long sleeve thermal, black short sleeve t-shirt over, gloves, gray sweatpants, and was holding a black metal rod in his left hand and a black firearm in his right hand. CARDOSO stated there was a second unknown black male holding the entrance door to the gas station so the gas station clerks would not be able to lock the doors. First unknown suspect was seen fleeing South bound across the street through the open field. CARDOSO was cooperative during the full investigation and provided me with security camera footage to help assist with the investigation.

Detective VRTOCHNICK spoke to witness, Roger B. Augustine (W/M, 05/23/74), cell phone number 608-289-7770, stated that he arrived at the Gas Station on 01/26/23, at approximately 12:05 pm, and was working on a water line repair at the coffee machine. Augustine stated that he was behind the open door of the cashier booth when he heard commotion and yelling. Augustine stated that the employee who

was working at the gas station who was wearing a turban (Sukhdev NMN Singh, W/M, 01/16/54) exited the cashier booth and stood by the open door of the cashier booth. Augustine stated that he realized at this time that the gas station was being robbed.

Augustine stated that the suspect in this offense exited the cashier booth holding cash register tills. Augustine stated that he only saw the suspect from behind and described him as an unknown race male with a "husky" build wearing black hooded sweatshirt and gray sweatpants. Augustine stated that this person stood at the front of the store at the front counter and removed money from the cash register tills he had removed from the cashier booth. Augustine stated that the suspect threw the cash register tills on the floor. Augustine stated that the suspect did not remove coins from the cash register tills before throwing them on the floor, and there was change on the floor after the suspect threw them.

Augustine stated that the suspect exited the gas station by means of the front entrance door located on the South side of the building and briskly walked Southwest across W. North Ave. Augustine stated that he did not see anyone hold the door for the suspect and did not see the suspect enter the gas station.

I reviewed video surveillance footage. The footage showed the suspect is a Black male, unknown age, 5'10, medium build, wearing all black clothing, gray sweatpants, with black ski mask and black gloves, armed with a black handgun and crowbar. Suspect is observed on surveillance footage at 12:21PM, approaching the gas station from the south on N. 38th St. on foot. Suspect enters the gas station at 12:22 PM and case's the storefront. At 12:25 PM victim, Sukhdev Singh W/M 1/16/1964 opens the door to the secure cashier area to enter the store front. At that time the suspect rushes past Sukhdev into the area behind the registers and produces a black handgun from his waistband with his right hand. Suspect points the gun at and demands money from victim, Bernado Cardoso W/M 7/14/1996. Suspect produces a crowbar in his left hand. Suspect lifts out the two cash drawer inserts and retreats back into the storefront area where he removes the money and places it into his pockets. Suspect discards the drawer inserts onto the floor and exits the gas station at 12:26 PM. Suspect runs back across the street to the same direction from which he came.

While on scene, I observed the licenses posted and they were up to date. During my investigation I did not observe any violations in the licensed premise.

This concludes my involvement with the business.

This report is written by P.O. Miles KOWALIK, assigned to District 3, Day Shift, Squad 3131.

On 04/22/2023, at approximately 2:40 p.m. P.O. Jose FLORES and I were dispatched, while in full duty uniform equipped with axon body cameras, and in a marked squad car to investigate a complaint of Armed Robbery that occurred the night prior, on 04/21/2023 at approximately 9:45 p.m. at the gas station at 3708 W North Ave, Milwaukee, WI 53208, which is located in the City and County of Milwaukee, and the State of Wisconsin.

SINGH stated that a group (unknown amount) of teenagers occasionally come into the gas station, grab an item, then leave without paying. SINGH also stated that he did not report this to police because the items were not expensive. SINGH stated that on the night of 04/22/2023, at approximately 9:40 p.m. this same group of teenagers came into the store and attempted to steal items. SINGH then remotely locked the door to prevent them from leaving with the items. At this time one of the subjects, (Unknown 1), pulled out a firearm and pointed it at the victim. The victim then unlocked the door and the subject fled with the items.

During the course of this investigation, while we were copying camera footage onto a flash drive, 3 individuals entered the gas station.

SINGH and CARDOSO positively identified them as the individuals who were in the store the night prior and stole the food items. P.O. KOWALIK, requested another squad, at which time, Squad 3245, (P.O. Ryan MILLER and P.O. Joshua HEDER), responded and upon their arrival the 3 subjects fled on foot. A subject later identified as Kevin SMITH (04/28/2007) was in this group, and then proceeded to flee the scene with the group when other squads arrived. He was taken into custody for Armed Robbery PTAC. This subject was taken into custody at 2329 N. 39th St., by Squad 3253, (P.O. Antonio OBREGON and P.O. Alexander LEITZKE).

The gas station has insurance coverage by Society Insurance. The items stolen include multiple snickers ice cream bars, multiple packets of candy, multiple juice bottles, and multiple bags of chips. The group grabbed handful amounts and the workers could not determine the exact quantity that was stolen; however they estimated the value to be \$50.00 dollars.

P.O. Jose FLORES reviewed video surveillance footage.

Camera footage shows Six suspects enter the Gas Station. The six subjects disperse among the store and begin grabbing food items. While they are still grabbing items, a bystander enters the store and purchases an item, then leaves. Unknown suspect 1 was wearing a black hoodie, light grey jeans, and a black beanie hat with a white symbol on the forehead of the hat, and white skull and crossbones on the sides, and white shoes. Once SINGH locked the door and told the group to put the items back, Unknown suspect 1 brandished a pistol pointing it SINGH and told SINGH to open the door. Unknown suspects 2 and 3 wore dark pants, dark hooded sweaters, and masks. Unknown suspects 4 and 5 wore dark clothing, and no masks.

Camera footage from 04/22/2023 at 3:31 p.m.

Camera footage shows a group of four black males enter the gas station at 3:31 p.m. SINGH immediately identified three out of four of these individuals as being involved in the robbery the night prior. SINGH stated that the individual who was directly in front of the window to pay was not involved. Unknown suspect 1 was standing at the front door entrance wearing a black beanie cap with a white symbol on the forehead and white skull and bones on the sides, a black sweater, light grey jeans, and white shoes. Unknown suspect 1 was identified by SINGH as the individual who brandished the gun the night prior. Unknown Suspects 2 and 3 were wearing dark pants, dark hooded sweaters, and masks. Once the group realized additional squads were on scene, they fled, and officers initiated a foot pursuit that resulted in the arrest of Kevin SMITH (04/28/2007).

While on scene, I observed the licenses posted and they were up to date on the inside of the counter area to the left of the door. During my investigation for *this armed robbery*, I did not observe any violations in the licensed premise.

Upon our arrival we observed a vehicle that was parked on the east side of the parking lot of the business. Officers noticed there were several people standing outside of the vehicle. The business was a gas station with several fuel pumps on the south side of the premise and the convenience store on the north end of the premise.

I spoke to licensed premise worker who allowed us to review the camera footage regarding the incident. The business was cooperative with the investigation. The business had zero security officers on scene.

I reviewed video surveillance footage. The footage showed a male subject arrive to the gas station and park his vehicle next to a pump. The male subject then turns around towards W North St and with his right hand takes out a handgun in which he then fires it towards a subject who is walking across the street. Simultaneously the caller arrived at the gas station and her son begins to walk towards the convenience store. Once the son hears the gun shot being fired, he then turns around and runs towards the mom who is by the vehicle attempting to pump gas. The son then gets in between his mom and the vehicle attempting to get into the vehicle. The video shows everyone leaving the gas station shortly after.

While on scene, I observed the licenses posted and they were up to date. During my investigation for Reckless use of weapon I did not observe any violations in the licensed premise.

This report is written by P.O Samuel WAGGONER assigned to District 3, Day Shift, Squad 3140.

On Friday, November 17, 2023, I was dispatched to 3708 W North Av for a rollover crash that damaged the property at 3708 W North Ave with P.O Thomas WRIGHT in full duty uniform and activated body worn cameras.

Upon arrival to the scene, I observed the gas station's sign and fencing were damaged by the Black 2017 Buick Encore.

Detective Tiffany SKONIECZNY spoke to the Up 31 Petro Mart employee Danny R. ALEXANDER Sr. (B/M 6/27/1973). It was determined that CIB would handle the investigation because the vehicle involved in the crash was related to an armed robbery that occurred on November 17, 2023.

The business was cooperative with the investigation and provided the above witness statement and security camera footage to the investigation. The business had 0 security officers on scene.

Detective SKONIECZNY reviewed video surveillance footage.

Friday, November 17, 2023, - video surveillance at the Citgo Gas Station,

Channel 1 (southbound of exterior, facing W. North Avenue – 6:42:16 AM - Two vehicle collision at the intersection and both vehicle's last resting position is at the most southeast corner of N. 37th Street and W. North Avenue.

Channel 1 6:42:35 AM-- One Black male (tall and thin, wearing all black with white strips on the his legs and arms) exits the black Dodge Charger and flees on foot. The male runs at a high rate of speed west on W. North Avenue approximately 30 feet and then north through the Citgo parking lot. The listed subject did not return to the scene.

Channel 1 6:43:00 AM-- One subject, later identified Ernisha L. JULIEN F/B dob 8/31/2002, exited the Buick with the assistance from the gas station clerk. JULIEN the walks toward and into the gas station.

Channel 7 6:44:20 AM – JULIEN entered the interior of the gas station. JULIEN is observed operating a cell phone in the right hand and then sits and lays on the floor of the gas station.

Channel 7 6:45:12 AM – JULIEN exits the interior of the gas station and flees eastbound around the gas
