This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/20/2021 officers were dispatched to a Hold up alarm at Wendy's, 914 N. 27th St. The manager stated no one intentionally pushed the button. He allowed the officers inside to check the business. The officers determined the call to be a false alarm.

2. On 08/09/22 at 1:18pm, Milwaukee Police were dispatched to 914 N. 27th Street for a trouble with subject complaint. The subjects left before police arrival.

- 3. On 08/12/22 at 1:26pm, Milwaukee Police were dispatched to 914 N. 27th Street for a trouble with subject complaint. The subjects left before police arrival.
- 4. On 09/30/22 at 11:00am, Milwaukee Police were dispatched to 914 N. 27th Street for a trouble with subject complaint. Upon arrival, officers observed several subjects at the location that were loitering and were asked to leave by police. They gathered their belongings and left.
- 5. On 10/05/22 at 1:26pm, Milwaukee Police were dispatched to 914 N. 27th for a battery cutting complaint. Investigation revealed that the deceased victim was arguing with another subject, on the sidewalk, between the locations of 930 N. 27th Street and 914 N. 27th Street. The deceased was located in front of 914 N. 27th Street.

- 6. On 01/14/23 at 10:39am, Milwaukee Police were dispatched to 914 N. 27th Street for a battery complaint. Investigation revealed that an employee had a verbal argument with her girlfriend inside their vehicle, on the parking lot of the location. The subject called because she was unable to exit the vehicle and no battery occurred.
- 7. On 03/19/23 at 1:25p.m., officers were flagged down at 914 N. 27th St., for a Trouble with Subject. The citizen stated after ordering their food they didn't receive the correct change, therefore became upset and an argument ensued. The citizen stated the manager threatened to shoot him and another employee spit in his face. Officers interviewed the employees who stated the citizen was arguing with them regarding change and began to cuss at them, therefore, they forced him out of the restaurant. The manager denied having a firearm, however, lied to the police about having a vehicle on the lot and would not allow the officers to check his car for his firearm. Due to the manager not cooperating, the officers contacted the manager's Probation Officer and he was subsequently arrested on a Probation Hold. The manager was advised in the future they should call the police and not try to settle matters like this themselves.

On Sunday, 03-19-23 at 1:26 P.M., I observed a trouble with subject at 914 N 27th St at Wendy's Fast Food. This is located in the City and County of Milwaukee, State of Wisconsin.

The victim who flagged me down was identified as Walter SCOTT (b/m, 03-13-63). SCOTT stated he was inside the Wendy's and got his food but wanted his change. He accused Wendy's employees of not giving him his change so he got upset. SCOTT stated he was assaulted and pushed out of the Wendy's and the manager Raykeem K BASS (b/m, 10-13-96) threatened him with a gun and said he was going to shoot him. SCOTT stated the other manager Tiquilla M ANDERSON (b/f, 07-22-84) had spit in his face. SCOTT stated BASS put his gun in his car in Wendy's parking lot when I made a U-turn to see what the commotion was about.

ANDERSON said that SCOTT was inside and wanted to exchange change for dollar bills, but told SCOTT that they had no singles and that upset him and SCOTT called the employees cuss words so they forced him out since he wouldn't leave.

ANDERSON stated nobody had a gun and she never spit on SCOTT.

I spoke to BASS who stated he never had a gun and he can't have one because of his probation status. BASS did lie and said he never had a car at the location and said he took the bus here. He admitted lying to me, yet still denied any gun possession at anytime.

SCOTT walked off and no longer wanted to be a victim.

BASS refused to let me check his car, but I called Probation/Parole and advised them about the allegations and they placed a hold for his arrest.

Some employees inside Wendy's were upset that we were arresting BASS and nearly interfered with us

taking him into custody.

BASS is a manager and I advised him to call police regarding bad patrons and not taking matters into their own hands. No one from Wendy's ever called police regarding this matter.

No surveillance from Wendy's since needed GM there. This was per manager ANDERSON. Video across street was blocked by traffic light. Shows some type of disturbance, but nothing more.



- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
