This report is written by Officer Carlos Felix, assigned to the License Investigation Unit, Day Shift. The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/17/2024 at 6:29 PM., officers responded to 2627 W. Capitol Dr., Clark Gas, for a Battery Complaint follow-up. Security footage showed, on 04/13/24, at 12:26 AM., an employee was attempting to physically escort a male out of the store. The male strikes the employee twice to the head and both subjects exchange punches. As both subjects are engaged in a physical altercation, a second employee strikes the male on the back with a wooden stick. The first employee pushes the male out to the parking lot where he sat for short time before panhandling in parking lot. An officer called and spoke to the owner who did not have any information regarding the employees, but stated he would get it to them and both employees involved were fired.
- 2. On 04/13/2024 at 3:09 PM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Robbery Complaint. The suspect a known shoplifter entered the business, took four cases of soda without paying, and exited the store into the alley. The suspect returned to the store and entered the rear storage room. An employee went into the storage room and observed the suspect with two cases of Red Bull. The employee told the suspect to stop, before getting pushed to the ground as the suspect fled. The employee sustained minor abrasion to their arm due to the fall. The items were valued at \$227.96. Video was available of the incident and no license violations observed.
- 3. On 04/25/2024 at 10:30 AM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Theft Complaint. An employee called regarding a known wanted suspect involved in the incident which occurred on 04/13/24. That suspect was taken into custody without incident. No license violations observed.
- 4. On 05/03/2024 at 10:23 PM, officers were dispatched to 2627 W Capitol Dr for a Shotspotter Complaint. While investigating officers were made aware that a victim had arrived at the hospital

with injuries sustained while shots were fired at the gas station. Officers were able to recover the surveillance footage that confirmed the driver of the suspect vehicle exited and shot at another vehicle that was parked at the gas station before fleeing. The business was cooperative with the investigation.

- 5. On 05/15/2024 at 6:21 PM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Subject with Weapon complaint. An employee called for police service and locked the door to prevent a known suspect from leaving with items they were attempting to steal. The suspect realized they could not leave and started damaging property. Officers placed the suspect into custody without incident. No license violations observed.
- 6. On 05/18/2024 at 12:28 AM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Theft complaint. Four Juvenile suspects entered the store and started removing several items off the shelves. The employee attempted to exit from behind the counter to confront the suspects. One suspect grabbed for a gun that was in their pocket, and threatened to shoot the employee if he came out. The suspects fled with items valued around \$70 -\$80.00. Video was available of the incident and no license violations observed.
- 7. On 05/23/2024 at 7:46 PM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Subject with Weapon complaint. Three juvenile suspects entered the store and one concealed items in their pocket. The employee attempted to confront the suspect and a second suspect made threats to shoot the employee if they exit from behind the counter as a gun was displayed. The suspects grabbed additional items and flee the store. Video was available of the incident and no license violations observed.
- 8. On 06/22/2024 at 10:00 PM., on 2627 W. Capitol Dr., Clark Gas, a theft occurred at 2627 W. Capitol Dr., Clark Gas. The victim was walking into the business with their phone in hand as the suspect walked past, grabbed the victim's phone and fled. This incident was reported at the district on 06/25/24 by the victim.
- 9. On 07/09/2024 at 5:22 PM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Property Damage complaint. A subject entered the business, became upset and knocked over a rack of merchandise. Video was available of the incident and no license violations observed.
- 10. On 10/15/2024 at 1:35 PM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Theft complaint. A known subject entered the business and took items without making payment.

 Officers cited the subject. Video was available of the incident and no license violations observed.
- 11. On 01/04/2025 at 10:47 AM., officers were dispatched to 2627 W. Capitol Dr., Clark Gas, for a Violation of Restraining Order complaint. A known suspect entered the business in violation of a court ordered, which was properly served. The suspect placed an item in the door preventing the magnetic locking system from being activated, and fled with items valued at \$53 dollars.
- 12. On 01/06/2025 at 1:03 AM., An officer conducted a License Premise check at 2627 W. Capitol Dr., Clark Gas. All licenses were posted and valid. Cameras were working and available for viewing at any time. The officer did find chips, candy and other items offered for sale past the expiration date. The employee removed most of the items and held some to be credited by the vendors.

On Wednesday, April 17th, 2024, at approximately 6:29 PM, P.O. MEYER and I were dispatched to a battery complaint at 2627 W Capitol Dr, which is located in the city and county of Milwaukee.

Upon our arrival, we spoke to two (2) workers who stated that they were just hired in the last few weeks. The attendants stated that they heard about a battery that occurred at the gas station and stated that they saw the video on FaceBook. The workers stated that they do not know who the workers are but stated that they are the night shift.

The workers then call their boss, identified verbally over the phone as Pritpal S GREWAL (M/A 04-26-1991), who stated that he owns the Clark Gas Station. GREWAL stated that he was made aware of a battery between a homeless subject and two (2) of his workers on the morning of Saturday, April 13th, 2024, by his manager. GREWAL stated that he then saw a citizen video on Facebook of his workers battering a customer in the front area of his gas station. GREWAL stated that this was unacceptable and stated that he has told his workers multiple times to never leave the bullet proof glass area, even if someone is stealing everything inside of the store. GREWAL stated that he has since fired both (2) workers but stated that he does not know their legal names as he did not have their applications in front of him at the moment but will follow up with their names. GREWAL stated that he had called MPD D5 front desk and spoke with Sgt. DEDERICH via phone who instructed him that officers were responding to investigate.

While on scene, I observed multiple monitors with surveillance footage of the interior and exterior of the business, which the workers on scene gave officers permission to view. While I watched surveillance footage, P.O. MEYER walked into the front area where customers buy their products and observed blood underneath the floor mats on the ground.

I later attempted to speak to the caller, Tony LEWIS (414) 739-7772. I called this phone number a total of three (3) times, which went to voicemail every time. This was documented on my body worn camera. I wanted to speak with LEWIS due to the call stating, "Caller requesting squad to above location, states that his 31 year old son was beaten by attendant with sticks and bats, per caller, he got video of incident. Is at location now but unknown where his son is" and "Caller is very worried, stated that he is now at gas station and sees blood all over the floor, would like to show officers his video."

Both workers on scene stated that they were not involved in the altercation and stated that the workers who were involved are the night shift.

The business was very cooperative with the investigation and officers on scene. The business had no security officers on scene at the time of the incident and at the time of the investigation.

I reviewed video surveillance footage. The footage showed a male subject in a gray zip-up jacket and blue jeans walk into the store at 12:21 AM. The subject is seen on camera twice (2) asking and receiving money from customers in line to buy their food/drinks. At 12:26 AM, I observed the male subject then grab something in the northwest corner of the store, put it to his mouth, then throw it on the ground. I then observed worker# 1 approach the subject and grab his left arm. It appeared that worker# 1 was attempting to ask and have the subject removed from the store, when the subject became irate and struck worker# 1 to the top of head twice (2). Worker# 1 then grabbed the subject and struck him to the face five (5) times. Worker# 1 then pushes worker# 1 onto the front counter, where the subjects then began to either punch or begin to pull worker# 1's

hair out multiple times. Worker# 1 then pulls the subject off the counter and strikes him with a closed fist to the back three (3) times. I then observed worker# 2 exit the employee area with a wooden stick at 12:27 AM, later identified as a wooden chair support and struck the subject to the back once (1). Worker# 1 then pushes the subject outside 12:27:18 AM. Worker# 1 then begins to clean up the blood on the ground with a paper towel.

I reviewed the exterior camera which shows the subject sit on the side of the building for approximately one (1) minute, then began to walk through the parking lot, panhandling in the parking lot before leaving the camera's view towards W Capitol Dr.

The video was recorded on body camera and was attempted to be recovered by our CSO but was unable to due to the size of the file. Follow up to occur to attempt to have a hard copy of the video. Workers on scene during the investigation showed officers where to place USB and also logged into the system for us.

While on scene, I observed the licenses posted on the south wall, and they were up to date. During my investigation for the battery, I did not observe any violations in the licensed premise.

This report was written by P.O. Damon WILCOX, assigned to District 5 Day shift.

On Saturday April 13, 2024, at approximately 3:09PM, Squad 5122 (P.O. WALISZEWSKI and I) was dispatched to 2627 W Capitol Dr for a robbery.

Upon arrival I spoke with the clerk/caller identified as Jai KATHPAL (W/M, 4-12-2001). He stated that a subject, who he identified as Deangelo K TURNER (B/M, 12-13-97), entered the store and began to take four cases of soda (12packs of Sprite, Coke, Pepsi, and A&W Root Beer from the shelf. He stated that TURNER than removed these items from the store and went into the rear alley. KATHPAL stated that TURNER steals from the store daily. KATHPAL stated that TURNER than came back into the store and went into the back storeroom of the location. He stated that he followed TURNER into the back room and observed him with two cases of Red Bull beverage in his hands. He told TURNER to "stop". TURNER then pushed KATHPAL to the ground, also causing him to bump into a stack of merchandise (causing it to fall over). TURNER than fled from the location out the storeroom door. KATHPAL sustained some abrasions to his right arm as a result of being pushed to the floor. The total value of the merchandise taken was \$227.96. KATHPAL stated that he observed TURNER flee on foot southbound in the rear alley of the location.

SCENE DESCIPTION

The above location is a Gas Station. It is located on the southeast corner of the intersection of N 27th St. and W Capitol Dr. The building is a single-story brick building. The front entrance faces N 27th St. to the West. To the West of the building is a parking lot area that had multiple gas pumps.

The front entrance of the building opens to the business. There is the front counter (that has a bullet resistant glass partition) containing the business's register on the North end of the business. To the South of the front counter is the customer merchandise area. I observed coolers (with various beverages) against the East and South wall.

In the northeast corner of the customer area is a door that leads to the back storeroom

area of the business. In the rear storeroom I observed stacks of merchandise that was back stock. I observed several stacks of soda cases had been knocked over in this room. There was an additional exit door in the northwest corner of the storeroom.

INTERVIEW OF KATHPAL

He stated that he had worked at the location for several months. He told me that he had begun work the morning of 4-13-2024. He stated that a subject he knows as Deangelo K TURNER (B/M, 12-13-97) had entered the business as soon as he arrived. He told me that TURNER was "in and out of the" business "all day". He stated that TURNER comes in "every day and steals". KATHPAL stated that TURNER is always stealing "cakes, soda and Red Bull"

KATHPAL told me that just before he called police, TURNER took four cases of soda off the shelf and took it outside of the business without paying for it. He told me that he believed he put the merchandise in the rear alley of the location. KATHPAL stated that he was receiving a delivery at the time of this theft. He told me that TURNER then came back into the location and walked into the rear storeroom of the business. KATHPAL stated that he believed that TURNER was going to steal more merchandise from the backroom. He stated that he armed himself with a wood handled hoe and walked into the back room of the location.

He stated that he observed TURNER with two cases of Red Bull in his hands as he walked into the rear storeroom. He told me that he yelled at TURNER to "stop. get out". He stated that TURNER saw him with the hoe, ran at him and pushed him into a stack of soda cases. KATHPAL stated that he slammed into the soda, knocking all the cases over, and fell to the floor. He then told me that TURNER then left the location with the two cases of Red Bull energy drinks. He stated that when he struck the floor this caused him pain to his arm.

KETHPAL stated that the four cases of soda were valued at \$8.99/ea and the two cases of Red Bull were valued at \$192.

KETHPAL gave the following description of TURNER - Black male, in his 20's, 6'0" tall, thin build, longer hair, beard, blue knit hat, blue jacket, black shirt with Nike swoosh logo on front, grey jeans, and white shoes.

He stated that he knew TURNER's name and birthdate because the police had stopped him inside the store several weeks prior and had provided him with the information. He stated that he requested the information for a restraining order.

VIDEO EVIDENCE

I did review the business's cameras. The cameras clearly depict TURNER remove the cases of soda from the business (out the front door). The cameras then depict TURNER re-enter the location and enter the rear storeroom area of the business. TURNER is observed to push KATHPAL into a stack of soda cases in this area. KATHPAL is observed to fall to the floor and TURNER is then observed to take two cases of Red Bull and flee out the storeroom with the stolen merchandise. The video had a time stamp on it. The time stamp when the incident occurred in the storeroom was 2:56PM.

DOCUMENTATION

KETHPAL was issued a PV-17, P.O. WALISZEWSKI did provide KETHPAL a link to Evidence.com and he stated that he would upload the video evidence. P.O. WALISZEWSKI did document the scene and KATHPAL by taking photos. THIS CASE WILL BE PRESENTED AT THE MILWAUKEE COUNTY DISTRICT ATTORNEY'S OFFICE ON MONDAY APRIL 15, 2024 AT 8:30AM.

While on scene, I observed the licenses posted and they were up to date. During my investigation for THIS ROBBERY, I did not observe any violations in the licensed premise. The employee, KATHPAL, was extremely cooperative in all aspects of my investigation. He also cooperated in uploading video of the incident into our Evidence.com database.

On April 25, 2024, at approximately 10:30AM, Squad 5122 (P.O. WALISZEWSKI and I) responded to a Theft at 2627 N 27th St.

While enroute to the location I contacted the caller, identified as Jai KATHPAL (W/M, 4-12-2001). He stated that he was an employee at the Clark Gas Station. KATHPAL stated that there was a known wanted person at the location. He further stated that the suspect had not committed any crime at the location that day. P.O. WALISZEWSKI and I had previous knowledge of the subject, Deangelo K TURNER (B/M, 12-13-97) and the previous incident (Robbery).

Upon arrival to the location, I observed TURNER in the parking lot of the gas station. He was placed in custody without incident. The following is a description of the original incident, which had occurred the week before.

On Saturday April 13, 2024, at approximately 3:09PM, Squad 5122 (P.O. WALISZEWSKI and I) was dispatched to 2627 W Capitol Dr for a robbery.

Upon arrival I spoke with the clerk/caller identified as Jai KATHPAL (W/M, 4-12-2001). He stated that a

subject, who he identified as Deangelo K TURNER (B/M, 12-13-97), entered the store and began to take four cases of soda (12packs of Sprite, Coke, Pepsi, and A&W Root Beer from the shelf. He stated that TURNER than removed these items from the store and went into the rear alley. KATHPAL stated that TURNER steals from the store daily. KATHPAL stated that TURNER than came back into the store and went into the back storeroom of the location. He stated that he followed TURNER into the back room and observed him with two cases of Red Bull beverage in his hands. He told TURNER to "stop". TURNER then pushed KATHPAL to the ground, also causing him to bump into a stack of merchandise (causing it to fall over). TURNER then fled from the location out the storeroom door. KATHPAL sustained some abrasions to his right arm as a result of being pushed to the floor. The total value of the merchandise taken was \$227.96. KATHPAL stated that he observed TURNER flee on foot southbound in the rear alley of the location.

SCENE DESCIPTION

The above location is a Gas Station. It is located on the southeast corner of the intersection of N 27th St. and W Capitol Dr. The building is a single-story brick building. The front entrance faces N 27th St. to the West. To the West of the building is a parking lot area that had multiple gas pumps.

The front entrance of the building opens to the business. There is the front counter (that has a bullet resistant glass partition) containing the business's register on the North end of the business. To the South of the front counter is the customer merchandise area. I observed coolers (with various beverages) against the East and South wall.

In the northeast corner of the customer area is a door that leads to the back storeroom area of the business. In the rear storeroom I observed stacks of merchandise that was back stock. I observed several stacks of soda cases had been knocked over in this room. There was an additional exit door in the northwest corner of the storeroom.

INTERVIEW OF KATHPAL

He stated that he had worked at the location for several months. He told me that he had begun work the morning of 4-13-2024. He stated that a subject he knows as Deangelo K TURNER (B/M, 12-13-97) had entered the business as soon as he arrived. He told me that TURNER was "in and out of the" business "all day". He stated that TURNER comes in "every day and steals". KATHPAL stated that TURNER is always stealing "cakes, soda and Red Bull"

KATHPAL told me that just before he called police, TURNER took four cases of soda off the shelf and took it outside of the business without paying for it. He told me that he believed he put the merchandise in the rear alley of the location. KATHPAL stated that he was receiving a delivery at the time of this theft. He told me that TURNER then came back into the location and walked into the rear storeroom of the business. KATHPAL stated that he believed that TURNER was going to steal more merchandise from the backroom. He stated that he armed himself with a wood handled hoe and walked into the back room of the location.

He stated that he observed TURNER with two cases of Red Bull in his hands as he walked into the rear storeroom. He told me that he yelled at TURNER to "stop. get out". He stated that TURNER saw him with

the hoe, ran at him and pushed him into a stack of soda cases. KATHPAL stated that he slammed into the soda, knocking all the cases over, and fell to the floor. He then told me that TURNER then left the location with the two cases of Red Bull energy drinks. He stated that when he struck the floor this caused him pain to his arm.

KETHPAL stated that the four cases of soda were valued at \$8.99/ea and the two cases of Red Bull were valued at \$192.

KETHPAL gave the following description of TURNER - Black male, in his 20's, 6'0" tall, thin build, longer hair, beard, blue knit hat, blue jacket, black shirt with Nike swoosh logo on front, grey jeans, and white shoes.

He stated that he knew TURNER's name and birthdate because the police had stopped him inside the store several weeks prior and had provided him with the information. He stated that he requested the information for a restraining order.

VIDEO EVIDENCE

I did review the business's cameras. The cameras clearly depict TURNER remove the cases of soda from the business (out the front door). The cameras then depict TURNER re-enter the location and enter the rear storeroom area of the business. TURNER is observed to push KATHPAL into a stack of soda cases in this area. KATHPAL is observed to fall to the floor and TURNER is then observed to take two cases of Red Bull and flee out the storeroom with the stolen merchandise. The video had a time stamp on it. The time stamp when the incident occurred in the storeroom was 2:56PM.

While on scene, I observed the licenses posted and they were up to date. During my investigation for THIS ROBBERY, I did not observe any violations in the licensed premise. The employee, KATHPAL, was extremely cooperative in all aspects of my investigation. He also cooperated in uploading video of the incident into our Evidence.com database.

I observed what appeared to be a black female wearing a green shirt and black pants exit the driver seat of the vehicle followed by a black male wearing a black and white flannel shirt exit the passenger side. I also observed a black male in the rear passenger side of the vehicle wearing unknown clothing.

Further reviewing the footage I observed a blue Toyota pull into the gas station a short time later and stop in front of the doors on the west side of the gas station. I observed two black males both wearing white t-shirts in the diver and passenger seats of the vehicle.
