

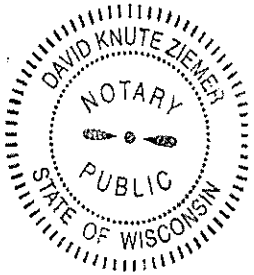

**070723...** A substitute ordinance relating to the dock and wharf lines of the Milwaukee and Menomonee rivers.

**081628...** Substitute ordinance relating to a change in zoning from Industrial-Heavy and Two-Family Residential to Industrial-Mixed, to accommodate existing and future land uses, on land located North of West Lisbon Avenue between North 30th Street and North 31st Street, in the 15th Aldermanic District.

**081690...** A substitute ordinance to create Section 113-32.0110 of the Milwaukee Code of Ordinances relating to the amendment of the Official Map of the City of Milwaukee.

**081691...** A substitute ordinance relating to parking controls in various Aldermanic Districts.

**081692...** A substitute ordinance relating to traffic controls in various Aldermanic Districts.

**081694...** A substitute ordinance to further amend the 2009 offices and positions in the City Service.

**081700...** A substitute ordinance to further amend the 2009 rates of pay of offices and positions in the City Service.

**081711...** Substitute ordinance relating to a change in zoning from Local Business to a General Planned Development by Heartland Housing, for a four-story building with community space and up to 45 apartment units, on land located North of West Tamarack Street and West of West Fond du Lac Avenue, in the 15th Aldermanic District.

**081718...** Substitute ordinance relating to a change in zoning from Two-Family Residential to Local Business, for a beer garden and horseshoe pit, on land located East of South 37th Street and South of West Burnham Street, in the 8th Aldermanic District.

**090003...** An ordinance relating to the late renewal application fee for a bed and breakfast establishment permit.

**090049...** A charter ordinance relating to eligibility, to make a selection of a protective survivorship retirement option.

**090080...** A substitute ordinance relating to disqualification for committee consideration of a new application for certain alcohol beverage licenses upon withdrawal of an initial application.

**090090...** A substitute ordinance relating to the composition and staffing of the capitol improvements committee.
