There is a possibility that your application may be denied for one or more of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings during normal business hours is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of Kilbourn Avenue and Water Street. You must present a copy of the meeting notice to the parking cashier.

Officers interviewed the manager who said he was aware of the theft from vehicle and that he does not have access to the surveillance cameras which would have captured the incident. Officers called the area manager, who is the only person with access to surveillance, and he told officers that he was on vacation and the video only retains 10 days of footage. When officers informed him the theft occurred within the 10 day time span, he said he would look for the footage and call back in an hour. The area manager never called back. This investigation has been delayed because officers have been unable to contact the area manager.

This report is written by P.O. Alexander LEITZKE, assigned to District 3, Early Shift, Squad 3220

On Wednesday, January 8th, 2025 at approximately 4:01PM, my partner P.O. Robin STOIBER and I, Squad 3220 were dispatched for follow up regarding a Felony Theft from a vehicle located at 5835 W. Lisbon Avenue.

Upon our arrival, I spoke with the manager Charles BLACK who stated he was aware why Police was here. BLACK asked if we were here regarding the theft from the Hummer. I asked regarding follow-up with video footage of the incident that occurred from 12/31/24 at approximately 2:00PM to 1/2/2025 at approximately 10:00AM. BLACK stated that the Area Manager Anton ALEXANDER is the only one with access to the video and there is no access on site to the cameras. BLACK stated the camera on the corner of the building should catch exactly where the vehicle was parked. BLACK stated the suspect had to have tools and been with the vehicle awhile due to the stereo system in the vehicle being bolted to the car frame. The suspect also was able to take larger items and would need to make multiple trips to the vehicle.

I spoke with ALEXANDER over the phone who stated he was on vacation and the video only retains for 10 days approximately and all the video of the incident is expired. I informed ALEXANDER the incident occurred within the last 10 days and still should be on there and re-informed him of the dates and times. ALEXANDER stated he was going to look for more footage and call back in a hour and never returned a phone call. BLACK stated ALEXANDER sometime stops on-site and would most likely be in tomorrow at some time just doesn't know when. I have been unsuccessful in able to look at the camera footage and requested BLACK to contact ALEXANDER later so I can look at camera footage of the incident. I will attempt to go back to the business on 1/9/2025 to obtain footage again. ALEXANDER has been delaying

the investigation, I will attempt to call him as well at a later date to make sure we can obtain footage of the incident prior to the 10 days of the expiration of the video.

While on scene, I observed the licenses posted and they were up to date with an expiration date of 11/11/2025.

Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)


- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
