Re: Report of the Renewal Application of Miloud Laasiri for a Public Passenger Vehicle Driver License.

FINDINGS OF FACT

1. Miloud Laasiri (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2019.
2. An application to renew said license was filed with the Office of the City Clerk.
3. On August 28, 2019, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, of a police report that could form the basis for suspension or non-renewal of the license and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on September 11, 2019 at approximately 9:30 a.m. in Room 301-B of City Hall. At said date, time and place, the licensee did not appear.
4. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice was sent to Miloud Laasiri at 2721 East Whittaker Avenue, St. Francis, Wisconsin 53235, along with a copy of the police report on August 28, 2019 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, Wisconsin 53202. The address of 2721 East Whittaker Avenue, St. Francis, Wisconsin 53235 was the address given by the applicant on his renewal application. The licensee did not appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.
 - B. Alderman Kovac moved denial based on Licensee's non-appearance.



CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Miloud Laasiri, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver License based upon his non-appearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver License held by Miloud Laasiri based upon his non-appearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends by a vote of **five (5) ayes** and **zero (0) noes** that the Public Passenger Vehicle Driver License of Miloud Laasiri be nonrenewed based upon his non-appearance.
