This is in response to a request our office received to install the above-captioned parking restrictions. Our traffic engineering staff has investigated this request and found east and west bound motorists on East Hamilton Avenue have a difficult time seeing traffic traveling north and south bound on North Humboldt Avenue when vehicles park close to the corners. Therefore, in the interest of public safety, we recommend installing these restrictions to increase visibility at the intersection.

Legislation will be prepared for consideration at the next Public Safety and Health Committee meeting to install the parking restrictions.
