

Dear Mr. Marc R. Fortney:

This is to notify you that on Tuesday, June 3, 2025, the City's Licenses Committee voted to recommend to the City's Common Council to renew with a 20 (twenty) day suspension your Class B Tavern, Public Entertainment Premises and Food Dealer licenses based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to the health, safety or welfare of the public for the assaults, battery and disturbance of the peace; for the premises located at 1209-13 N Water St. ("Brothers Bar & Grill").

On May 22, 2025, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the Class B Tavern, Public Entertainment Premises and Food Dealer licenses in which the Committee recommended renewal with a 20 (twenty) day suspension of your Class B Tavern, Public Entertainment Premises and Food Dealer licenses based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to the health, safety or welfare of the public for the assaults, battery and disturbance of the peace. You were further notified that the Milwaukee Common Council would consider the matter at its meeting on Tuesday, June 3, 2025 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did file written objections to the report of the Licenses Committee, you did appear in person, and you were represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted renewal with a 20 (twenty) day suspension of your Class B Tavern, Public Entertainment Premises and Food Dealer licenses based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to the health, safety or welfare of the public for the assaults, battery and disturbance of the peace. Said suspension is in effect between 12:01 a.m. on June 03, 2025 until 11:59 p.m. on June 22, 2025.
