3. On 07/02/08 at 3:33 am, Milwaukee police were dispatched to a Trouble With Subject complaint at 6325 N 76th Street. Investigation revealed an unknown female entered the store to purchase cigarettes and did not have enough money. The clerk refused to sell the cigarettes and the subject became argumentative and yelled several profanities and racial slurs. She also threatened to have the store robbed. The clerk, identified as Mukhter Mukhtar, feared for his safety and called police. The female subject was issued a citation for Disorderly Conduct.
4. On 01/09/09 at 2:05 am, Milwaukee police were dispatched 76th and Mill Road for a Battery complaint. Investigation revealed some patrons who just left the Citgo Gas station began fighting in the parking lot. Minor injuries were reported with medical attention being refused. Police spoke to the clerk, identified as Mukhtar Alikhan, who stated he observed several subjects arguing outside of the gas station but that all the subjects left in cars and that's why he didn't call police. Further investigation revealed it was a domestic violence battery and one subject was arrested and charged with same.

6. On 09/07/13 at 10:30 pm, Milwaukee police were dispatched to 76th and Winfield for a strong-arm robbery. Investigation revealed a patron exited the gas station and was attempting to leave the parking lot in his auto, when a jeep pulled up behind him and the driver accused the victim of striking his auto. Several other subjects exited the suspect's auto with one of the suspect's punching the victim in the face. The victim stated he fell, but got right back up and saw the suspect who hit him, jumped into the victim's auto, striking the jeep. The other suspects got into the jeep and all parties fled the area. Police attempted to view the incident on video surveillance, but was told by the cashier, Athar Ahmad, that there was no video of today's incident. A report was filed.

8. On 05/23/19 at 8:20pm, Milwaukee Police were dispatched to 6325 N. 76th Street for a threat complaint. Upon arrival, officers interviewed the caller/employee who stated that there was a mother in the establishment with kids who were knocking over items. Nothing was damaged and the mother was advised to not return to the filling station.

9. On 07/29/20 at 7:50pm, Milwaukee Police were dispatched to 6325 N. 76th Street for a trouble with subject complaint. Upon arrival, officers interviewed the caller/employee who stated that two subjects were outside panhandling and would like them removed. One subject walked away after police arrival and the other was conveyed to another location.

10. On 03/13/2021 at 9:44pm officers were dispatched to a Shooting at 6325 N. 76th St. The officers located a victim on the floor of the gas station with two gun shots to the abdomen. The officers recovered surveillance video from the business. The video showed the victim in the store and the suspect behind him in line. When the victim exited the store the suspect

followed and approached the victim. Another suspect exited an auto parked on the lot and the two suspects shot at the victim. The suspect fled in an auto and the victim appeared to shot at them as they fled.

11. On 08/28/2021 at 3:21am officers were dispatched to a Subject with Gun complaint at 6325 N. 76th St. The officers interviewed the clerk, who stated a subject came into the store and offered him drugs. The clerk told the subject to leave and the subject threw items on the ground and threatened him. The clerk stated the subject had a gun in his waistband but did not pull it out. The officers viewed video of the incident but was of poor quality.

12. On 01/24/23 at 12:04am, Milwaukee Police were dispatched to 6325 N. 76th St, for an armed robbery complaint. Officers spoke with the victim who stated that while at the gas station, an unknown armed suspect took his car with keys at gun point. Officers spoke with the employee regarding video of the incident, and it was revealed that the camera that was covering the exact area where the incident occurred was not operating. The camera footage obtained only showed the victim enter and leave the gas station store.
13. On 02/02/23 at 1:36am Milwaukee Police were dispatched to 6325 N. 76th St, for a trouble with subject complaint. The caller/employee stated that an unknown subject was at the location asking people for drugs, and refused to leave. Officers did not locate the subject near or around the business upon arrival. Officers spoke with employee, who stated that the subject frequents the business, usually pan handles, or ask customers for drugs. Officers obtained the subject description and checked his last known direction of travel.
14. On 02/27/23 at 9:53am Milwaukee Police were dispatched to 6325 N. 76th St, for a threat complaint. Officers spoke to the employee, who stated that he had trouble with a subject refusing to leave. The subject was arguing with the employee over a transaction, and then stated that I know where you live. The officers obtained the subject's description and was told the subject left after the police were called.
15. On 03/31/23 at 2:10pm, Milwaukee Police were dispatched to 6325 N. 76th St, for a reckless use complaint. Officers spoke with the caller who stated that his boyfriend shot out his car tire at the location. Officers reviewed video at the location and could not observed the shot being fired as described by the caller. Officers noted that prior to the incident time they did observed what appeared to be a hand to hand drug deal but the video did not show a shot being fired.
16. On 04/25/23 at 3:19am Milwaukee Police were dispatched to 6325 N. 76th St, for threat complaint. Officers spoke with the employee, who stated that a subject came into the business and made threats which made him fear for his safety. Officers reviewed video, obtained the subject's description and last known direction of travel. Officers canvassed the area but did not locate the subject.
17. On 05/01/23 at 12:37am, Milwaukee Police were dispatched to 6325 N. 76th St, for a threat complaint. The employee stated that a subject came to the location and made threats to shoot/stab him. The subject was told to leave multiple times. Eventually the subject left west bound from the location. Officers checked the area for the subject but did not locate him.
18. On 05/27/23 at 12:57am, Milwaukee Police were dispatched to 6325 N. 76th St for a theft complaint. The caller/employee stated that 3 subjects came to the location and took items without paying for them, and left in a white SUV. The employee stated that he did not want a

report just wanted the police aware of the incident and of the suspect vehicle. Officers checked the area for the suspect vehicle but did not locate it.

19. On 05/27/23 at 4:41am Milwaukee Police were dispatched to 6325 N. 76th St for a theft complaint. The employee/caller stated that several times throughout the early morning hour's suspects have been coming in and out taking items without paying for them. The employee stated that this time he noticed that one of the suspects may have been carry a gun in his waist band. The caller provided a full description of the suspects and the suspect vehicle with plate and last direction of travel. The employee gave officers a list of the items taken and the dollar amount. The employee stated that he could not work the video cameras but will provide officers with additional information. Officers left the employee their contact information, regarding the investigation.
20. On 05/30/23 at 10:53pm, Milwaukee Police were dispatched to 6325 N. 76th St for a threat complaint. Officers spoke with the caller/employee who stated that an unknown subject made threats to shoot him for refusing to give him service. The employee stated that the subjects arrived at the store in a white SUV, and the first subject attempted to buy items and he refused service to her. The second subject entered the store from the vehicle and he made the threats towards him. The employee stated that he refused service because they were the same suspects who stole from the gas station in the past.
21. On 06/05/23 at 11:24pm Milwaukee Police were dispatched to 6325 N. 76th St for a shots fired complaint. Officers spoke with the caller who was getting gas and observed a white SUV pull in. Subjects came towards the white SUV, talked then shots were fired. The caller stated that the subjects from the white SUV fired the gun shots first. Officers observed casings on the floor of the business parking lot and shattered glass. Officers spoke with the employee, who stated that he observed two subjects in the store prior to the shots being fired. The subjects were the same suspects firing at each other. The business was cooperative with the investigation.
22. On 06/18/23 at 1:37am, Milwaukee Police were dispatched to 6325 N. 76th St for a theft complaint. Officers spoke with the employee who stated that three subjects were attempting to steal items without paying for them. The employee had a brief confrontation regarding the items and called the police. The employee stated that he no longer needed police service because the subjects agreed to pay for the items.
23. On 07/02/23 at 5:19am, Milwaukee Police were dispatched to 6325 N. 76th St for a trouble with subject complaint. The caller/employee stated that an intoxicated subject was in the business and knocked down some items. The subject left prior to police arrival.
24. On 07/05/23 at 1:59am, Milwaukee Police were dispatched to 6325 N. 76th St for a property damage complaint. The caller/employee stated that an unknown suspect came to the location and threw beer bottles at the outside of the business. The same suspect returned a short time later in a white SUV, entered the store then threw a beer bottle at the glass partition, causing minor damage.
25. On 07/10/23 at 7:11pm, Milwaukee Police were dispatched to 6325 N. 76th St for a subject with gun complaint. Officers could not locate the caller, the vehicle or the subjects described by the Computer Aided Dispatch (CAD) related to the complaint. The officers spoke with the employee who stated that he was unaware of a subject with a gun at the location. The business was cooperative with the investigation.

26. On 07/13/23 at 3:11am, Milwaukee Police were dispatched to 6325 N. 76th St for a theft complaint. Officers spoke with the caller who stated that 8 subjects came to the business took items without paying for them and knocked over items. The subjects all left in a blue vehicle from the location. During the investigation officers mentioned that no security was at the location.
27. On 07/30/23 at 4:07am, Milwaukee Police were dispatched to 6325 N. 76th St for threat complaint. Officers spoke to the caller/employee who stated that the subject is now willing to pay for his items, and police service was no longer needed. The subject was observed at the ATM , pulling money from the machine. The officers mentioned that the business is now designated a nuisance premise. The business is in billing status or submitted an abatement plan which the business will close the store at the appropriate time or have security, to eliminate nuisance activity. No security was observed at the location.
28. On 08/08/23 at 3:58am, Milwaukee Police were dispatched to 6325 N. 76th St for a trouble with subject complaint. Officers spoke with caller/employee who stated that 3 subjects were standing on side of business smoking cigarettes, and wanted them removed from the property. The employee stated that he believe the subjects would scare customers away. The officers spoke with the subjects and they left without incident. Officers stated that the business did not have no security work at the location.
29. On 08/27/23 at 3:58am, Milwaukee Police were dispatched to 6325 N. 76th St for an armed robbery complaint. Officers spoke with the victim who stated that while he was pumping gas two suspects exited a red car, approached him with hand guns, and took his vehicle with keys. Officers spoke with employee who stated that he was unaware of the incident. The business was cooperative with the investigation and provided video of the incident. The video showed the incident, the suspect vehicle, suspect's description, last direction of travel of the suspect's vehicle and victim's vehicle. The business had no security officers at the location.

Officers spoke with caller/employee who stated that a subject refused to leave the business, demanding their quest card. This report is submitted by PO Andrew KELLER, assigned to District Four, Late Shift, Squad 4330.

On Tuesday, 01/24/2023, at approximately 12:04 am, my partner, PO Bronson MOORE, and I, were dispatched to the CITGO gas station (KD Power Mart 2), located at 6325 N. 76th St., for an Armed Robbery complaint (IR # 23 024 0002).

Officers located and spoke to the victim, Kevin R. CROSS (m/b, 08-16-60), in front of his residence, which is located at 8301 W. Mill Rd.

CROSS stated he was placing property in the trunk of his vehicle, after leaving the listed gas station with food and drinks. CROSS stated he parked his vehicle, facing westbound, on W. Winfield Ave., before entering the gas station. CROSS stated he was approached by an unknown black male, who, while armed with a black semi-automatic handgun, demanded the keys to CROSS's vehicle. CROSS stated he dropped his vehicle keys in the trunk and the unknown suspect grabbed his car keys from the trunk and entered the vehicle and fled westbound in the vehicle on W. Winfield Ave.

Officers conveyed CROSS to the scene and, during our investigation, learned that the exterior surveillance cameras, on the southwest side of the listed business, were not operational during this incident.

The employee on duty at the time of our investigation did provide officers with surveillance footage, which shows CROSS entering and exiting the store.

This supplemental report is submitted by PO Shane Bishop assigned to District Four, Late Power Shift, Squad 4431 with PO Ashley Pashkewitz.

On February 2nd, 2023, at 1:36am, Squad 4431 was dispatched to the gas station located at 6325 North 76th Street for a "Trouble with Subject". This call is related to CAD # 23-033-0083. The caller/employee Ather Ahmad w/m 02-15-1984, stated that a male was at the location asking people for drugs. The male was asked to leave and refused.

On arrival, the male was no longer on scene and officers spoke to the caller, Ahmad. Ahmad stated that the male frequents the gas station often and asks for drugs and panhandles. The male is observed leaving the location on foot going back west towards West Bender Avenue. The male was described as a black male wearing black pants and a gray/black jacket with hood.

Officers checked the area but were not able to locate this subject.

Two days later, on February 4th, 2023, at 8:17pm, Officers Pashkewitz and I received an e-mail from Late Shift Supervisor, Sgt. Paul Gracyzk, requesting us to file a license premise report regarding this incident. It is unknown what attracted the supervisor's attention to Squad 4431's dispatched assignment. The license premise report was completed when practical.

SMITH stated that she was getting gas and was parked at pump #1 in her vehicle when a white truck pulled up. SMITH stated that four people then came from behind the southeast corner of the building to talk to people in the white truck. SMITH stated that one of the four men then reached into the white truck. SMITH stated shortly after the man reached into the truck is when shots were fired. SMITH stated that people in the white truck were the ones who started firing weapons first. SMITH stated that she observed shots being fired through the windshield out towards others that were outside the vehicle.

I spoke to licensed premise employees who were identified as AHMAD, Athar (A/M, 02/15/1984) and his co-employee who was identified as ALIKHAN, Mohiuddin (A/M, 08/01/1954). AHMAD stated that he had just arrived to work and noticed that there were two black males in the lobby of the store who were looking at each other funny, he stated that one the males then stepped outside and then the two men started firing shots at each other. ALIKHAN when questioned stated that he was in the middle of stocking the shelves and then he heard gunshots. ALIKHAN stated that he did not see what happened he only heard the shots. The business was cooperative with the investigation. The business had zero security officers on scene.

On SUNDAY, AUGUST 27TH, 2023 AT APPROXIMATELY 3:58 AM, SQUAD 4330 (PO SAYAOVONG AND I) WERE DISPATCHED TO AN "ARMED ROBBERY" COMPLAINT AT THE LOCATION OF 6325 N 76TH ST. (WHICH IS LOCATED IN THE CITY AND COUNTY OF MILWAUKEE, WI).

Upon arrival, we were met by the caller/victim, who was identified as Michael M BRADLEY (B/M 05/11/1986) who stated that he was pumping gas on pump 3. BRADLEY stated that 2 subjects approached him with 2 handguns with extended magazines. BRADLEY stated he ran away from the location due to be in shock. BRADLEY stated he does not know who those subjects were. BRADLEY identified 2 subjects as Black Males, wearing all black clothing, black ski masks, and slim build. BRADLEY stated the 2 subjects took his vehicle and fled the scene with a black frame, clear lenses cartier prescription glasses. BRADLEY identified his vehicle as a 2020 Gray Hyundai 4 door bearing WI Plate AMT-6623. BRADLEY identified the suspects' vehicle as a Cherry Red Chevy Cruze.

I spoke to the business, Athar AHMAD (M/A 02/15/1984), who stated he was not aware of the incident but would allow officers to view surveillance footage.

The business was cooperative with the investigation. The business had zero security officers on scene.

I reviewed the surveillance footage and observed at 2:02 AM, the victim parked at pump 3 pumping his gas. The red chevy cruze pulled up to pump 6 and parked momentarily and waited until there were only 2 vehicles in the parking lot. The red chevy cruze proceeded to drive to pump one and two black males exited the vehicle from the passenger side. The two black male displayed firearms at victim. The victim ran northbound on N 76th St. Suspect 1 entered the victim's vehicle and suspect 2 retreated back to the red chevy cruze. Both vehicles fled the scene Westbound onto Winfield Ave.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the armed robbery, I did not observe any violations in the licensed premise.


