

Dear Council Members:

Enclosed please find a proposed substitute resolution recommending settlement of the above-referenced claims, which we ask be introduced and referred to the Committee on Judiciary and Legislation with the following recommendation.

On August 12, 2017, a police dog owned by the city of Milwaukee bit Isabella Marshall, the daughter of the claimants Chris and Christina Marshall, while they were all at home. This is the house of the officer, Christina Marshall, who was assigned as the handler of the dog and who was expected to keep the dog in the family residence. Isabella Marshall suffered wounds to her face and right arm. The claimants assert that there were serious physical and emotional injuries as a result of the dog bite and bills for medical care. They have agreed to settle their claims in the total amount of \$115,000.00.

Because settlement in this matter is deemed expeditious, we recommend payment of the proposed settlement amount, and have enclosed an appropriate resolution for your convenience.
