INSTRUCTIONS FOR FILING A CLAIM AGAINST THE CITY OF MILWAUKEE

To file a state-law claim against the City, a claimant must comply with Section 893.80(1), Wis. Stats., a copy of which is printed on the reverse side of the instruction sheet. Generally the statute requires the claimant to serve on the City Clerk a document stating the circumstances of the claim. The document must be signed by the claimant, or his/her agent or attorney, and should be served within 120 days of the event.

The claimant must also present to the City Clerk a document stating the address of the claimant and a statement of the relief sought. If money damages are sought, a specific sum must be stated. (The above information may be combined in a single document.)

Submitting the following additional information will allow the City to act on your claim more promptly:

1. Proof of the amount of the claim by means of either itemized receipts or two itemized estimates.
2. A phone number the claimant can be reached during business hours.
3. As detailed a description of the incident as possible, including the date, time and location.

ADDITIONAL INFORMATION

Before you can file a lawsuit against the City of Milwaukee for reimbursement, State law requires that you first follow the claim procedures established by the City Clerk.

Filing a claim against the City does not automatically guarantee reimbursement from the City. However, the City examines each claim on an individual basis to determine if reimbursement is legally required.

In order to obtain reimbursement for a claim against the City, you must prove that the City or its employees acted unlawfully or negligently.

Only the City Attorney or the Common Council and the Mayor can authorize payment of a claim against the City. Any other representations made by City employees are not legally binding on the City.



893.80 Claims against governmental bodies or officers, agents or employes; notice of injury; limitation of damages and suits. (1) Except as provided in subs. (1g), (1m), (1p) and (8), no action may be brought or maintained against any volunteer fire company organized under ch. 213, political corporation, governmental subdivision or agency there of nor against any officer, official, agent or employe of the corporation, subdivision or agency for acts done in their official capacity or in the course of their agency or employment upon a claim or cause of action unless:

(a) Within 120 days after the happening of the event giving rise to the claim, written notice of the circumstances of the claim signed by the party, agent or attorney is served on the volunteer fire company, political corporation, governmental subdivision or agency and on the officer, official, agent or employe under s. 801.11 Failure to give the requisite notice shall not bar action on the claim if the fire company, corporation, subdivision or agency had actual notice of the claim and the claimant shows to the satisfaction of the court that the delay or failure to give the requisite notice has not been prejudicial to the defendant fire company, corporation, subdivision or agency or the the defendant officer, official, agent or employe; and

(b) A claim containing the address of the claimant and an itemized statement of the relief sought is presented to the appropriate clerk or person who performs the duties of a clerk or secretary for the defendant fire company, corporation, subdivision or agency and the claim is disallowed.

Dear Captain Shephard and Sergeant Klein,

In confirmation of our discussions and our letter to you dated 12/28/04, we still await information as to the final disposition of your investigation reference our vehicle. As you are aware, our vehicle was removed from a location where it was found after being stolen, without your or our approval. Therefore, District 5 and your staff did not have the opportunity to review the location and the vehicle.

Our car was damaged by the tow and was taken south when we live north. We did not approve the tow. If I understand correctly, the property owner, Kimberly Abernathy, authorized the tow. There appears to be a number of irregularities and oversights in this investigation. I am submitting a claim to the City of Milwaukee for the loss of my vehicle and related expenses. I would appreciate a written reply from you outlining your findings to date.

Also, to assist you, I am attaching a statement from my All State Policy which advises that they will pay up to \$10,000 as a Vehicle Theft Award. I mentioned this to Sgt. Klein when I visited District 5 on Friday, September 3rd. I heard nothing further from you office regarding this. I had hoped perhaps that if your department would have discussed this reward in the 2431-29 N. 1st Street area it might have helped someone recollect how my car got there and who was the driver and later the "mechanic".

Dear Dave,

Thanks for the opportunity to speak with you on 1/13/05 and discuss my concerns regarding the loss of my vehicle and the improper and flawed communications and actions with which this matter was handled.

As you are aware, my vehicle was towed and damaged without my approval. The evening of the theft, we advised the investigating officer that we did not want the vehicle towed without our approval. In addition, the correspondence from the Department of Neighborhood Services apparently prompted the property owner to authorize the towing of my vehicle. It would appear that neither the property owner or the Department of Neighborhood Services advised the District 5 Police Office. Therefore, my vehicle was removed before the police investigation could be conducted and eliminated the opportunity for the police to obtain evidence from the scene or the vehicle.

I did call Lieutenant Johnson and asked him to contact you and discuss how to improve inter-departmental communications, with a goal of improving services.

As discussed, I am entering a claim for my losses with the Office of the City Clerk. Thanks again for your attention to this matter and recognizing the areas of the process which are a concern to me.

SUBJECT: The Theft of My Vehicle

Dear Chief Heggerty:

I am writing this letter to you to tell you my tale of woe. I'm certain you are exposed to many tales of woe and mine will be but a passing expression in the overwhelming daily difficulties to which you are exposed. I, however, as the victim, cannot let this situation pass without documenting and lamenting the event. As a citizen of a rural Wisconsin community, situations such as this are unacceptable.

Let me outline the event for you:

- 1) My car was stolen on 8/15/04 – your file report is 04-229-1002.
- 2) On Sunday evening, August 15, 2004, my son drove a friend of his back to his apartment in Milwaukee. He parked his vehicle in the 2300 block on Bremen Street between Wright and Hallstead.
- 3) The vehicle was locked, but when my son returned, the car was gone.
- 4) My son called the police department and after about an hour and a half, an investigating officer arrived. The two officers took the necessary information and left. Our car license plate was 871 DZT and it was a 1988 Olds Royale 88, 4-door, color bronze.
- 5) My son was now in Milwaukee without a vehicle and needed to have someone else bring him back to Kiel. The role of the victim has begun.
- 6) Making phone calls to us, having someone else drive 130 miles and a three hour round trip and now trying to determine what happens next. I called the District 5 office and asked for disposition and was told basically, if and when the car was found, we would be notified and that they have much more priority work then finding cars and car thieves. I continued to call 414-935-7252 or 53 and daily

asked for disposition. Obviously, based on some of the customer service responses, most victims don't inquire as much as I did.

- 7) I called again on Wednesday, September 1, 2004 and was told the car had not been found and don't call us, we will call you. To my surprise, less than 12 hours later on Thursday, September 2, 2004, I came home to find the attached letter in the mail. When I saw the Milwaukee address on the envelope, I anxiously opened it expecting good news. I was soon to be disappointed as I read and found that the letter was from the City of Milwaukee, Department of Neighborhood Services. You will note in the attached copy, the vehicle was found on August 30, 2004, the letter was sent on August 31, 2004 by regular mail and it read for further information I could call Officer Bates between 8 and 10 A.M. at 286-3601 (area code ??) which means I couldn't call until Friday, September 3, 2004. The paragraph regarding disposition states that the car will be towed at my expense. (Pardon me - I am the victim.)

- 8) Deciding after reading the attached that it would be best to act immediately, I, at 3:00 P.M. on 9/1/04, called the Dept. of Neighborhood Services at 414-286-5771 and spoke with Lori. She listened to my story and commented that it is unfortunate that the police department doesn't communicate and cooperate with their agency since many stranded and stolen cars are found by them. To make certain this message did not go unheard, I asked her to remain on the line and I hooked up a 3-way phone call with the District 5 Police Office. We jointly spoke with Officer Carla Bridges and reviewed all of the details including the poor inter-departmental communications. Officer Bridges was somewhat curt in her dialog but agreed that an officer would be dispatched and I would get a call with a disposition. Up here in farm country or in my work world of customer services, I believed I would have a call back in an hour, since the car was found probably less than two miles from the District 5 office. I waited and after five hours, at 8:00 P.M. my impatience had exceeded my patience. I called several times and received poor service until at 8:20 P.M., I spoke with Officer Coyer. He was very polite and advised that he would dispatch an officer to the location and investigate the status of my car and have the officer call me in 15 minutes. This time someone did call back. It was Officer Michael Branski calling from 414-745-5223. He was courteous and helpful. He was in the alley at 2431-39 N. 1st Street and my car was not there. Now what? Where did it go? Why would it have been towed? I didn't authorize it and 72 hours had theoretically not expired. So now what? Officer Branski provided excellent customer service and advised he would do further research and call me back, which he did. He told me that the car was at the city tow lot at 3811 Lincoln Avenue, 414-286-2700. He further advised that it would be practical for me to first call and visit the city attorney at 414-286-2676, 951 North James Lovell, 7th & State, Room 205, because if there were any red tape issues, I would be sent

back from Lincoln to the city hall to clear up miscellaneous charges and I could spend lots of time driving around Milwaukee. His suggestions and directions proved to be wise, prudent and correct. (Thank you, Officer Branski.)

- 9) Accordingly, not knowing what to expect, my wife, my son and I departed for Milwaukee on Friday, 9/3/04. Of course, again playing the role of the victim, we needed to lose our wages for the day, and buy a tank full of gas to go find our car which was legally parked and locked several weeks earlier. Of course, I was pleased to discover that I had to pay a parking fee to visit the offices of the city attorney, (more expense for the victim). We visited Room 205. The woman at the desk had no personality, was rude and must sleep on a bed of nails. She mumbled, gave us some paperwork and sent us to Room 304. This room had a better atmosphere and the counter men were polite, expedient and friendly. They verified information, gave us some paper and sent us back to Room 204.
- 10) Being back in Room 204 was a real treat. The lady at the desk was still eating sour pills and was obnoxious. She was, however, to our surprise, to be outdone by the man who we got to meet next. We were told to take a seat. There was a young Latino man who stepped up the counter before me. I was distraught to witness the lack of empathy for his situation, (the victim). I turned to my wife and said I hope I don't get this guy. I again had no luck - I believe his name was David Stanosz. If I have the wrong name I apologize, but whoever it was needs to learn to get up on the right side of the bed, be happier and recognize that the victim is the customer and probably works hard to pay taxes to pay Mr. Stanosz's salary. (The thief probably doesn't pay taxes.) After a discussion with this person in 205, I was given direction that I could proceed to Lincoln Avenue and view my vehicle.
- 11) I decided, however, since I had already invested in a parking permit, that I wanted to meet you, Nanette Heggerty, (about whom I have heard many positive comments on the radio) and share my thoughts and feelings with you. Unfortunately, you were unavailable, but I did have the pleasure of meeting and speaking with Sgt. Regina Howard (414-935-7830). Ms. Howard listened to my "tale of woe" and obliged my request and arranged for me to visit the District 5 Office and speak with Lt. Klein on my way home. (Thank you to Regina.)
- 12) We left the City Hall and traveled to 3811 West Lincoln Avenue to the City Tow Lot (see attached), another real enlightening opportunity for the victim and the resident of rural Wisconsin. Take a number, be a number and find out how the thieves have violated your rights. It is an awakening experience to find your car stripped, wrecked by thieves and damaged by unauthorized towing. And your choices are minimal - play on their turf or start paying. Your car is inoperable, the

wheels are gone, you would like to at least donate it and you are in the middle of an area with no one to offer assistance. (You are just the victim.) There were no choices or options, my only choice was to call a salvage yard and turn my car in for scrap. A great feeling - from being the owner of a perfectly fit vehicle to the owner of nothing, with threats of fees (costs) to be assessed against you. What a system! Of course, the thief has no problems because we are investigating more pressing issues.

13) We leave Lincoln Avenue, full of a variety of emotions and head north. North toward home, but first a visit to the location from which the car was stolen, where it was supposedly found and the District 5 Office. We met and visited with Lt. Klein (414-935-7251) at District 5. He patiently listened to my story and lament. I provided him with items found in the car which were not ours, including gum. I encouraged and asked about procedures to find the people who stole my car. The car was stolen and found very near the District 5 office. Somebody knows something - somebody saw something - somebody knows who put the car in the alley. As of early December, I had heard nothing. I called Lt. Klein in early December - he reviewed the case and returned a call to me to advise that up to this time, nothing had been determined.


14) Well, Chief Heggerty, we are coming to the end of my story (my tale of woe). I have given you the details and the facts. I would be pleased to speak with you by phone to elaborate on any questions you might have in more detail. Only several facts remain:

- a) I lost a vehicle which would have served me for at least another 5 years.
- b) I spent countless hours coordinating and communicating with the Milwaukee Police Department on this matter.
- c) I have had a loss of wages and spent an entire day traveling to Milwaukee to deal with this.
- d) I am the victim (I realize only one of many), but how do I get reimbursed?
- e) The criminal is probably stealing a car every day. He is not being caught because it is a petty crime (compared to all the big bad ones). He is making a good tax-free living selling stolen wheels, tires, radios, batteries, etc. If he is caught, my tax dollars will be spent to provide him with legal counsel and if he is convicted, I can get a part-time job so I can pay more taxes to put him in jail and provide him with exercise equipment.

Thank you for your interest in this matter. I await your written reply and I want to

know how and when the City of Milwaukee will reimburse me for the loss of my vehicle, my expenses in dealing with this and the tolerance I have had for some of the inadequate and rude customer service I received.

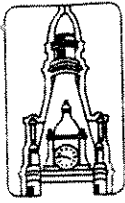

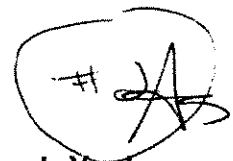

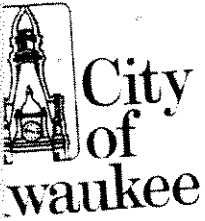
