
This office is in receipt of your in the amount of \$182.65, relating to damage sustained to your property due to sewage back-up at 3715 North 40th Street on December 12, 2000.

Our investigation reveals that the sewer in question was on a three year cleaning schedule. The last time the sewer was cleaned was on September 21, 2000. Because the sewer was on a regular cleaning schedule and the City of Milwaukee did not have any notice of any problems with the sewer, the City cannot be held liable.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Milwaukee, Wisconsin 53202, requesting a hearing.
