Good Evening Jeff,

I'm writing to you in regards to an email that I received via an open records request from you to Alderman Brostaff pertaining to me personally being a known agitator during the Kenosha Unrest. I am informing you politely owner to owner that there isn't a single factual element to that statement that holds merit and by that statement alone done so in documents that are of public record now, that you have engaged in defamation by

way of libel. This is my polite written warning and request for retraction that you have 48 hours to withdraw and correct that public statement. Should you refuse to do so after the 48 hour deadline I will seek a civil lawsuit against you, your businesses and any 3rd party that repeats the defamatory statement. Should you be inclined to repeat the defamatory statement at the licensing hearing it would then be a second infraction of defamation by way of slander at which time I will again seek legal action against you. Keep in mind that the severity of the defamation could also be charged criminally if the statement is so aggregious, which you indirectly allege that I was involved in riotous activity during the 2020 Kenosha Unrest. Please note that as an Investigative Journalist operating in my full capacity as a journalist and thousands of hours of time investigating the events surrounding Kenosha, that I have extensive knowledge and a vast amount of evidence to prove in a legal action that your statements are in fact defamatory. I look forward to your retraction of this statement and am confident this transgression can be resolved between the two of us to avoid a costly legal action at your expense.
