This is in response to a request we received from Badger Ham located at 3521 West Lincoln Avenue to install the above-captioned parking restriction on South 35th Street.

Our traffic engineering staff has investigated this request and found that trucks entering and exiting the loading docks on South 35th Street drive over the median island while trying to access the loading docks in question. The installation of this restriction will make it easier to access the loading docks and prevent future damage to the median island. Therefore, we recommend the installation of this restriction.

We will prepare the necessary legislation that will be heard at the next Public Safety and Health Committee meeting, so that you may support it to final passage.
