This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 12/03/20 at 7:58pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. The reason for the check was because officers knew the establishment did not have a license and on 12/02/20 they observed a number of vehicles parked out front and the lights and televisions were on. Police were not able to perform a premise check on that date because they were flagged down for an assignment. When officers entered the establishment, they observed six people inside, multiple televisions on throughout the tavern, music playing, and a multi-colored strobe light functioning. Officers interviewed the owner who stated that he was open for business and when he was told that he did not have a license yet, he became uncooperative and defensive. The owner said that he was emailed the license and called the alderman requesting that he email them again. When advised that he needed a paper copy of the license, the owner became defensive and asked why he was being told he needed a license and what requirements he needed to be met. Officers told him he would have to contact the city licensing division to find out what requirements had to be met and the owner said that he will have a license next time they meet.
- 2. On 02/19/21 at 9:47pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. Officers observed numerous vehicles, some illegally parked, and two lines outside the front door. Due to the large crowd, officers asked security outside, on two different occasions, if they could speak to the owner, but the owner did not come outside to speak with officers. Officers monitored the crowd and at tavern close, they roughly counted 519 people exiting the establishment using a hand-held counter (tavern capacity is 160). Due to a

shooting in the area, officers were unable to make contact with the owner. The applicant was cited

- 3. On 03/06/21 at 11:49pm, Milwaukee Police, along with the health department, conducted a license premise check at 2579 N. Teutonia Avenue. During the interaction, officers conducted a walkthrough and observed patrons not social distancing and not wearing masks. They interviewed security and ask how many patrons were inside and security told officers that they had counted 500 patrons (capacity of 160). After leaving the location, health department officials told officers that they would be issuing citations for standing, masks, social distancing, and over capacity totaling around \$12,000 (no citations could be found in the system).
- 4. On 03/15/21 at noon, a meeting was held at the Third District Police Station with the applicant of 2579 N. Teutonia Avenue. The meet was held because of the capacity issues and the owner of the business was not cooperating with police. The applicant said the manager of the establishment is named "Rob" (he does not know his real name and pays him through pay applications) and that the owner only owns the building, not the business inside, and should only be contacted when there is a maintence issue. The applicant was unsure of the security companies name but said that he has at least one security guard there at all times. When asked about the overcapacity, he said he was unaware of the issue but would make changes and would be at the location more often. The applicant was told he would be cited for the overcapacity on 02/20/21 (no citations could be found in the system).
- 5. On 03/18/21 at 9:48pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. Upon arrival officers made contact with the front door employee who advised them who the manager was and they asked both of them the identity of manager "Rob". They told officers that the dayshift manager was named "Ron" and that he works sometime in the morning. The manager was asked if he knew the capacity of the tavern and he told officers that it was 260. When told that it was 160, the manager became defensive stating that it was "updated" today.
- 6. On 03/19/21 at 1:09pm, Milwaukee Police conducted follow-up regarding the manager named "Rob". The business appeared to be closed but a maintence worker answered the door and said that the only manager he knows is "Doug".
- 7. On 03/20/21 at 12:52am, officers observed a large number of vehicles, several illegally, parked on the street surrounding 2579 N. Teutonia Avenue. There were also 20-25 vehicles circling the area, blocking traffic, trying to find a place to park and 20 people standing outside the front entrance waiting to enter the tavern. While parking enforcement was handling the illegally parked vehicles, one officer, with the squad and body camera activated, started counting the patrons leaving the establishment and afterwards went inside to finish the count. While inside, the manager of the tavern refused to allow them to walk to the rear of the tavern to count the patrons still inside. The police left the tavern and ended up with a final count of 169 patrons (capacity 160).
- 8. On 03/21/21 at 1:53am, Milwaukee Police were dispatched to Mt. Sinai for a shooting victim. Investigation revealed that the victim was waiting in line to enter the tavern, located at 2579 N.

Teutonia Avenue, when she got into a verbal argument with another subject. After finding out that the tavern was not letting anyone else inside, she walked back to her vehicle where she again was confronted by the suspect who shot her twice. Another squad was on scene and said the manager was cooperative with officers.

- 9. On 03/27/21 at 11:43pm, officers observed a large presence of vehicles parked, some illegally, outside the address of 2579 N. Teutonia Avenue. Parking enforcement was advised, security for the tavern was notified, and several patrons moved their vehicles. Several parking citations were issued.
- 10. On 04/25/21 at 12:30am, Officers observed approximately 200 vehicles parked surrounding 2579 N. Teutonia Avenue which is the only establishment open in the area. Officers also observed 10-15 people standing outside the tavern waiting to get in. Officers tried to enter the establishment but the front entrance was locked and security outside did not know why the door was locked. Someone eventually unlocked the door and when officers entered, there was a "smoky haze" inside which was later determined to be smoke emanating from cigarettes/cigars. While inside the tavern officers observed numerous 20oz empty bottles of Hennessy laying around, baggies of marijuana, cigarette buts, loose tobacco, and cigar wrappers on tables. The basement was checked and the breaker box for the building had wires exposed which could be a fire hazard and the only other exterior door to the tavern was locked and the courtyard it exited to, had a fence which was chained and padlocked. The applicant was contacted and told his establishment was 105 people over capacity.

- 11. On 05/01/21 at 1:41am, Milwaukee Police were dispatched to N. Teutonia Avenue and W. Clarke Street for a subject with gun complaint. Investigation revealed that the uncooperative caller said the incident happen inside the tavern located at 2579 N. Teutonia Avenue. Officers interviewed security who said that an altercation did happen inside the establishment and the female said the male had a firearm. Both subjects were escorted out, the male subject was searched, and no firearm was recovered. Security was cooperative.
- 12. On 05/13/21 at 4:20pm, Milwaukee Police, along with a Wisconsin Department of Revenue Agent and a DNS inspector, conducted a license premise check at 2579 N. Teutonia Avenue. Due to the tavern having two funeral events, the check was rescheduled but nine containers of shisha tobacco were confiscated because the tavern does not have a tobacco license.
- 13. On 05/14/21 at 2:00pm, a meeting was held at the Third District Police Station with the applicant of 2579 N. Teutonia Avenue. When asked what changes the applicant has made since last meeting, he replied that he has haired a new manager, has equipped security with a counter for capacity issues, and informed the building owner that he is not to be a part of day to day operations. The applicant was issued citations from item #10.

14. On 07/11/21 at 1:17am, Milwaukee Police were dispatched to 2579 N. Teutonia Avenue for a fight complaint. Investigation revealed that a large group of individual's left the tavern and engaged in a physical altercation outside which tavern security had to intervene.

15. On 11/14/21 at 1:13am, Milwaukee Police observed approximately 145-150 vehicles parked in the area of 2579 N. Teutonia Avenue which is the only open establishment at that time of night. Officers decided to perform a capacity check of the tavern using squad video placed at the exits, body camera footage, and a hand-held counter. After reviewing all video, it was determined that there were 238 patrons inside the tavern which is 78 persons over the capacity limit of 160. The manager was informed that a citation will be issued.

16. On 11/17/21 at 3:19pm, Milwaukee Police, along with a Wisconsin Department of Revenue Agent, conducted a license premise check at 2579 N. Teutonia Avenue. Investigation revealed that the applicant could not produce invoices for all of his alcohol nor did he have a tobacco license. All alcohol that did not have an invoice and 35 hookah tobacco vape pens were confiscated by the agent. Officers also found empty boxes of alcohol in the taverns dumpster which did not have the correct address on it, but the address of a liquor store. The applicant stated that he only buys his liquor from a distributor but the distributor told the agent

17. On 04/10/22 at 11:48pm, Milwaukee Police were dispatched to 2579 N. Teutonia Avenue for a tavern violation (underage persons inside the establishment). Officer did a walk through of the tavern and found no underage patrons. All employees and staff were helpful and

that the applicant has not purchased alcohol in months. Officers found a "Quest" card behind the bar and the applicant told officers that he uses the card to buy food for the establishment.

18. On 05/09/22 at 1:31am, Milwaukee Police were dispatched to 2579 N. Teutonia Avenue for a battery complaint. Upon arrival, officers interviewed security who stated that there was no battery and police could not make contact with a victim.

19. On 06/17/22 at 12:47am, Milwaukee Police conducted a license premise check at 2579 N.

Teutonia Avenue. No violations were found and the staff was cooperative.

20. On 06/19/22 at 2:04am, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. During the check, Officers observed a subject arguing with security outside and the subject had a firearm in his pants pocket. Officers took the subject into custody and

recovered two firearms from his person.

21. On 07/02/22 at 1:13am, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. No violations were found.

- 22. On 12/23/22 at 10:30p.m., Milwaukee Police were dispatched to a Battery Cutting at a local hospital. Officers met with the 20-year-old victim, who sustained a large cut to their lower back, as well as multiple injuries to the victim's face. The victim stated they were at 25/9 N. Teutonia Av consuming alcohol, when they observed two employees they did not get along with. The victim stated a fight took place but did not recall being cut. She was not sure who did it, but believed it was done by the employees. The victim further stated they were not sure if the incident took place inside or outside the club. The victim did not want to pursue any criminal charges as they were going to sue the business.
- 23. On 03/05/23 at 1:04a.m., Milwaukee Police conducted a License Premise Check at 2579 N. Teutonia Av. No violations were found and the employees were cooperative.
- 24. On 03/17/23 at 11:59p.m., Milwaukee Police were dispatched to a Shooting at 2579 N. Teutonia. Dispatch provided updates such as 100 shots fired, people shooting at each other, caller hiding under the bar/in the bathroom, people are fighting and people are shot. Officers were further advised of two walk-in gunshot victims to local hospitals. Officers observed numerous vehicles obstructing the roadway and people running from the tavern, multiple spent casings in front of the location and a partially loaded magazine in the roadway. Once inside the establishment officers observed at least 75 people still in the bar. Officers recovered 48 casings both inside and outside the establishment. An officer observed 2 firearms in a partially open file cabinet drawer behind the bar area.

A security guard who was posted at the front door they heard gunfire outside and glass shards struck them in the face. The security guard stated they saw at least one person holding a firearm and provided a description of the subject. The security guard further stated they did not know who was shooting and did not hear any gunfire inside.

A bartender stated it was their birthday and people were there to celebrate, when they heard a few dozen shots fired and ducked behind the bar. They further stated they did not have access to video surveillance, has never seen anyone operate it, and didn't know who officers could contact to obtain access.

Multiple employees were interviewed which everyone denied seeing anyone with a gun or gunfire, from inside the premise. After all interviews were completed a supervisor on scene requested a Forensic Investigator to take photographs of all employees, however, numerous employees refused to cooperate.

Investigation revealed a flyer was posted on Facebook promoting a "Birthday Bash", with multiple performers from both Chicago and locally.

At the conclusion of the shooting investigation officer conducted a licensed premise check and observed numerous bottles in a cage and liquor boxes with the labels removed. Officers requested the receipts for the liquor and they were not provided because they stated the manager had them.

On October 13th, 2023, members of CPU reviewed this incident for updates. A search warrant was obtained to recover surveillance video and it showed that head security guard speaking with someone in a vehicle in front of the lounge, when the vehicle departs the security guard is seen entering the lounge with a firearm in his hand. This security guard previously stated that he did not hear gunfire from inside but was observed on video returning fire with one gun and eventually placed two guns in the file cabinet. The security guard is a felon and should not have been in possession of a firearm.

On Saturday, December 24, 2022, on Squad 3188, I was dispatched to investigate a Battery Cutting at Mt. Sinai Hospital. I spoke to the victim, Armani M ELLIS (b/f 5-28-02), who stated that sometime on Friday,

December 23, 2022 at approximately 10:30PM to Saturday, December 24, 2022 at approximately 5AM at the location of 2579 N Teutonai Av, which is in the City and County of Milwaukee, an unknown subject used a sharp cutting weapon to cut her in her lower right side of her back, causing her to have stitches.

Interview with ELLIS:

ELLIS stated that she did not want police to be involved and wanted nothing to be done. ELLIS was cooperating with police during interview, but was not willing to give full detail of the subjects involved. ELLIS stated she did not want police involved because she wanted to handle this issue herself and sue the bar Vibe Lounge, 2579 N Teutonia Av) because she was attacked by two of their employees.

ELLIS stated she does not usually usually go have fun at Vibe Lounge. ELLIS stated she and a few friends decided to go there on Friday, December 23, 2022 and arrived there at approximately 10:30 PM. ELLIS stated she had an approximately 5-7 shots of liquor and half a bottle of wine while she was there. ELLIS stated while she was there she observed two females who used to go to school with her at Madison High School. ELLIS stated she never got along with the two females. ELLIS stated the two females were employees at Vibe Lounge and was working at the time she was a costumer there. ELLIS stated she does not remember much of the incident. ELLIS stated she remember getting into a fight with the two females. ELLIS stated she then left the location on Saturday, December 24, 2022 at approximately 4-5 AM. ELLIS stated the next morning her cousin began screaming because she saw that she had a large cut on her lower back.

ELLIS stated she usually drink a lot more then she did during the day of the incident. ELLIS stated she is currently still drunk during the interview with police.

ELLIS stated she does not remember much of the incident. It is unknown if she lost consciousness or was too heavy under the influence of alcohol during the incident. It is also unknown if the two female who attacked her were the same subject(s) who cut her. ELLIS stated she know it was the two female, but will still be under investigation to determined if the two females were involved in her server injury. ELLIS stated she does not remember if the incident happened inside or outside of the club.

Scene Description:

While on scene I observed ELLIS to be calmed and informed me she was not in any pain. I observed a large cut, approximately 1.5 inches long and 3/4 inches wide on ELLIS lower back on the right side. I observed multiple injuries on ELLIS' face, indicating that she had gotten into a fight.

I informed ELLIS that I will still be typing a report regarding to her incident, but if she want a criminal report to please contact me regarding. I advised ELLIS to not retaliate and go after the two females who were involved or she might face criminal charges.

I issued ELLIS a PV-17 and a Contact Card regarding.

I took 9 photos depicting ELLIS' injuries.

On Sunday March 5, 2023 at approximately 1:04am, my partner (P.O. Adam GONZALEZ) and I conducted a Tavern check at 2579 N Teutonia Av (Vibe Lounge).

As I arrived on scene there were numerous vehicles leaving the scene in all directions as well as numerous at least 75+ individuals inside the bar. Several individuals, I observed to be looking for there personal belongings, which they left inside of Vibe Lounge as the shooting was occurring.

Due to the amount of people inside the bar, officers on scene asked everyone but the employees to leave Vibe Lounge. Once the crowd was disperse from both inside and outside the bar numerous casings from both inside of Vibe as well as in the street on N. Teutonia Ave. and W. Clarke St were recovered. The total amount of casings recovered on scene were 48, which included 9mm casings, 40 caliber casings, and rifle casings.

Based on the report by Sgt. Brian LaROQUE, he observed the following while arriving on scene. He arrived on scene coming from the south on N Teutonia Av and observed approximately 25-30 vehicles still obstructing the roadway and people still running from the tavern. While approaching the tavern on foot he observed several spent casings on the west side of the street in front of 2579 N Teutonia Ave. He also observed a partially loaded magazine for a firearm laying in the roadway. He instructed officers to begin securing the scene with tape and assigned two officers to protect the evidence in the roadway.

During the investigation he began to walk behind the bar and observed the tavern had their license posted as well as two bartender licenses posted. As he continued checking the area behind the bar for casings or other items of evidentiary value on the floor behind the bar he observed a file cabinet near the southeast corner of the bar. he observed that one of the drawers was not closed completely. As he

moved his flashlight over the opening of the file cabinet drawer he observed a black object. Upon further inspection (through the opening of the drawer) he was able to make out a firearm and the Glock label on the base of the magazine. He was later advised when the firearm was retrieved from the drawer a second firearm was located in the same drawer.

All of the employees were interviewed on scene. The following is what they said about the incident.

During the investigation, I was tasked with interviewing the employee **Quintus T. GORE (b/m 11-4-1990)**, who identified himself as a security guard for Vibe Lounge. On the night of Friday, March 17, 2023, he arrived at work at 10:10 pm. He stated that he was assigned to be the inside security guard and was working just inside the front entrance door along the north wall.

He was wearing a black vest with white inner lining, black hooded sweatshirt underneath the vest, black jeans, black Nike shoes with the green swoosh logo, and a gray beanie.

GORE stated due to the crowd, he was only allowing three people in the bar at once to go through the search portion. He stated as he was working he heard gunshots coming from outside and simultaneously glass from the window striking him in the face. He said he initially was trying to hold people outside but eventually started letting people into the bar who were outside at the time of the gunfire.

GORE stated he saw at least 1 person holding a handgun, which he described as a dark color green. He stated it was a black male and believes he was wearing a white shirt and blue jeans but was not really sure and stated he could have been confusing people. While inside the bar, GORE stated that he heard customers stating they're shooting in the back. He does not know who was shooting and did not hear any gunfire inside.

Based on the report by Det. Ryan CASEY, he interviewed **Tia R. HUNTER (b/f 3-18-1993)**, who identified herself as a bartender.

Hunter stated that she thought an individual who was still on scene, Wesley T. Walker (B/M, 01/03/1981), was the manager of Club Vibe. Hunter only knew Walker's first and last name, she then provided the clothing description of what Walker was wearing and where he was located at the time of our interview.

Hunter stated that it's her 30th birthday and people were at the bar to celebrate. Hunter stated that she arrived at 2579 N Teutonia Av around 9PM on March 17, 2023. Hunter stated that when she arrived security was already at the bar helping open. Hunter stated that around midnight she was behind the first bar as you walk in, working. Hunter stated that she heard a volley of gunshots and ducked behind the bar. Hunter stated that the shooting paused and she thought it was safe but as she began to get up another volley of more gunshots occured. Hunter stated that couldn't recall an exact number of gunshots but stated it was a few dozen.

Hunter stated that she does not have access to the video surveillance in the bar and has never seen anyone operate it in the past. Hunter stated that she did not know who I would need to speak with to get the password to the system.

Hunter stated that she did not see anyone with a firearm or anyone shooting. Hunter stated that she has no knowledge of any firearms being behind the bar. Hunter stated that she arrived at 2579 N Teutonia Av by herself and drove her silver 2001 Buick Century to the bar.

Det. CASEY then heard a summary of the interview of **Wesley T. WALKER (b/m 1-3-1981)** who identified himself to P.O. Miladin STOJANOVIC as the security manager. The interview of WALKER was conducted by Det. Letitia HOLLOWAY. Det. CASEY heard the name "Haulin" as someone who showed up to the bar just prior to the shooting with about 20 or so people trying to enter then the shooting occured. This name "Haulin" was provided by Walker to Det Holloway. Det. CASEY is familiar with an individual named Romaine M. Hawthorne (B/M, 05/09/1997) to go by the aliases "Haulin", "Real Haulin", and "Big Haulin". I showed Walker an MPD booking photo of Hawthorne taken September 23, 2022 (Booking #112209028). Walker stated that very well could be "Haulin" but he wasn't sure because everyone wears masks nowadays.

Walker also stated that "600 Breezy" was supposed to be at the bar as well to perform. Walker stated that "600 Breezy" was a rapper from Chicago, IL. A search of google.com was conducted of "600 Breezy," which revealed an article on the website "everipedia.org/wiki/lang_en/600breezy" covering background information including personal life on "600 breezy". This website provided that 600 Breezy's real name was Antonio Valentino King (B/M, 04/16/1991). The website stated that he grew up in Chicago, IL. P.O. CASEY was unable to locate an MPD booking photo to show Walker of King. A query of eTime revealed IL records for King giving an address of 7941 S Coles Av, Chicago, IL as well as an address of 7924 S Evans Av, Chicago, IL.

P.O. CASEY located an instagram.com profile of "600breezy" which showed King. On King's instagram story was a repost from "marijuanaxo_414" of a flyer promoting a "Birthday Bash" at 2579 N Teutonia Av. The flyer stated "HOSTED BY 'DAGANG' ROYAL MONIE, POOK MULA, MINNIE, SINATRA, ZOEY, LON'DON, PAKBOY FENDI".

The flyer also stated "SPECIAL GUEST PERFORMANCES BY: Joe Pablo, Big Haulin, Trap Baby, Funny \$Money, Dai Ballin, Mula Mar, Sme Taxfree". I know "MulaMar" to be a Milwaukee rapper named Marlon M. Rhodes (B/M, 12/11/1996). In King's IG story uploaded by King he posted "Only place to be tonight" as well as the flyer. P.O. CASEY spoke to the witnesses who stayed on scene and no one was able to confirm if Rhodes or King were actually inside of the club.

Based on the report by P.O. Frank WILLIAMS, he interviewed **Eddie D. JONES (b/m 4-27-1974)**, who identified himself as a security guard.

JONES stated that he arrived at Vibe Lounge at approximately 21:30 for work as a security guard/maintenance type man. JONES describe his maintenance duties as that of someone who walks around and makes sure people put their liquor bottles in the trash.

JONES stated that while doing this, he heard shots being fired that sounded pretty close to him. JONES stated that he ducked onto the floor and crawled toward the back. JONES stated that while doing this, he

could hear the glass breaking from the windows.

JONES stated that once the shots stopped being fired, he ran upstairs just like everyone else.

JONES stated he did not observe any shots being fired.

Based on the report by P.O. Jason SPENCER, he interviewed **Deantre J. TYARS (b/m 6-30-1985)**, who identified himself as a security guard.

TYARS stated that at the time of the shooting he was located in the back bar area, which is located in the southeast corner of the business. TYARS stated that he observed patrons staring to scatter throughout the bar running towards the exit of the bar, which is located at northeast corner of the bar. TYARS stated that he saw patrons start to get down on the floor, so he did as well. TYARS stated that he wasn't sure why the patrons were doing this, TYARS stated that he thought maybe there was a fight. TYARS stated that toward the end of the patrons scattering he heard multiple gun shots that TYARS stated sounded like they were coming from outside. TYARS stated that while he was tacking cover near the pool table, he heard patrons stating "they coming back here". TYARS stated that he did not see any one with guns and did not see any gunshots.

Based on the report by P.O. Deja SLOAN, she interviewed **Douglas L. GRAY (b/m 11-19-1970)**, who identified himself as a security guard to P.O. Miladin STOJANOVIC when initially identified.

GRAY stated at approximately 11:50 P.M. he heard 10 shots or more outside the front of the building. GRAY stated he was standing to the far right of the bar when he heard the shots. GRAY stated he then ran to the back of the location to the right near the door that leads to upper (the door is next to a "VIP" sign located to the left). GRAY stated he saw no one with firearms nor did he see anyone shooting. GRAY stated there were no physical fights or altercations before the shooting occurred. GRAY stated he does not work at the location. Once GRAY was advised that he could leave the location, GRAY stated he was not going anywhere because he was the owner of the building.

I, P.O. GONZALEZ later checked the City of Milwaukee Property Data website, which revealed that the owner of the building was Kanisha KING and not GRAY.

Based on the report by P.O. Kurt KEMNITZ, he interviewed Eddie J. PARR (b/m 3-11-1984), who identified himself as a security guard to P.O. Miladin STOJANOVIC when initially identified.

PARR told P.O. KEMNITZ he is the head promotor/ host for the establishment. PARR initially stated that he was located on the stage at the rear of the establishment by the DJ station when he heard shots being fired from outside the location. He questioned PARR on how he could hear the Shots being fired when the music was so loud and he then recanted his initial story. PARR then stated that he was by the DJ booth when he observed the entire group of customers run from the front of the establishment to the rear screaming. When PARR realized what was going on he stayed on the stage however he went to the further back wall. PARR stated he never seen any gun or anybody shooting.

Sinatra Q. ADAMS (b/m 9-18-1991), identified himself to P.O. Miladin STOJANOVIC as the Host. It should

be noted that P.O. STOJANOVIC was unable to identify ADAMS as a real person and a check with MPD records revealed that his real name is **Treshawn Q. ADAMS (b/m 9-18-1991).** During the investigation he was placed in the rear of 3390 squad vehicle until spoke to by the detectives on scene.

After all the interviews of the employees, Squad 9314 (Sgt. PRIEWE) wanted the Forensic Investigator to take photographs of all the employees. Numerous employees refused to cooperate with this part of the investigation and refused to take the photographs.

While I was checking the licenses of Vibe Lounge. The following license were posted on the wall behind the bar of Vibe.

Class B Tavern valid between 12/14/22-12/13/23

Food Dealer valid between 12/14/22-12/13/23

Cigarette & Tobacco valid between 12/12/22-12/13/23.

The Operating license of the bartender Tia R. HUNTER (b/f 3-18-1993) was also posted, which was valid between 1/1/23-12/31/23.

In plain view, I observed numerous bottles of alcohol, which were located in a cage, which consisted of

- 15 bottles of Hennessy
- 2 bottles of Casamigos Tequila Anejo
- 4 bottles of Casamigos Tequila Blanco
- 3 bottles of Patron Silver
- 2 bottles of Remy Martin
- 17 bottles of Wild Irish Rose
- 1 bottle of Gionelli Blue Curacao Liqueur
- 1 bottle of Dekuyper Sour Apple
- 2 unknown bottles of liquor.

I also observed 2 boxes of Remy Martin, which contained the 24 200mL bottles inside. As I was inspecting the box, I observed the labels to be cut off on both boxes. I asked WALKER if he knows where they get there alcohol from and he stated he doesn't know but it is on 17th and State St. Badger Distributing of Milwaukee is located at 1812 W. State St. When asked if he knows where the receipts are he stated that

Dominique probably has them and that she keeps them with her. I know from previous experience WALKER is talking about Dominique JONES (b/f 6-25-1985) who has previously identified herself as the manager. JONES was not on scene during the investigation, but WALKER believes that she left with the crowd when we were telling people they had to leave the bar and that we would not let her back in. It also should be noted I observed a black counter behind the security desk which read "0000."

I attempted to make contact with the agent on 3/19/23 at 6:16 am but received no answer. A voicemail was left.

On October 13th, 2023, at approximately 1:26 pm, I was tasked with reviewing reports relating to the

shooting that occurred on March 17th, 2023. The investigation that was conducted by the detectives revealed the following.

While reading the reports, Police Officers were dispatched to the location of 2579 N Teutonia Avenue (Vibe Lounge), which is in the City and County of Milwaukee, Wisconsin.

It was revealed that a victim of the shooting stated he was waiting in line of Vibe Lounge when he observed multiple people standing in the doorway. The victim stated while in the back of the line, he heard approximately 10 shots and felt that he was stuck by gunfire. The victim stated people outside of the club rushed to get in and just as many people inside were rushing to get out of the club.

The victim stated as he was on the ground inside the club, he observed 2-3 individuals from inside the club firing shots outside of the club. The victim believed the person shooting was an employee of Vibe lounge and heard shots from inside and outside the club.

Additionally, during the course of the investigation, Detective were informed that there were 2 firearms located behind the counter register area and were taken as evidence.

Furthermore, it was revealed that a security guard of Vibe Lounge observed approximately 100 unknown black males walking through a field towards Vibe Lounge and informed someone from that group that all of those individuals wouldn't be let into Vibe Lounge. During the course of a mirandized interview, the person shooting stated he was, in fact, shooting from inside the club and admitted to being a felon in possession of a firearm. The subject stated he retrieved the guns from a subject that's a regular and he took them because the regular patron didn't want to walk back to his vehicle.

It should be noted, a search warrant was obtained for the surveillance camera and revealed the following below:

The head of security is seen exiting the front entrance of the club and speaking with someone in a vehicle. Once that vehicle leaves, the head of security is seen entering the club with a firearm in his hand.

While on surveillance it shows a security guard checking people and a short time later, a crowd of people began pushing through the front entrance. It's at that time, a security guard is seen with two handguns and begins firing one of the handguns. Furthermore, surveillance revealed that the same security guard was walking around with a silver over black handgun in his right hand. It is then shown that the security guard is seen removing items from his hooded sweatshirt and placing them in a filing cabinet behind the main bar.

During the course of the investigation, the shooter inside the club is identified as the bar head of security.


